Police vacancies

New Delhi, Jan 25: The Supreme Court has directed Home Secretaries of all states to file affidavits giving details of vacancies in police services at all levels. A bench headed by Chief Justice J S Khehar today observed that vacancy in police services was an important issue and asked all the states to file the affidavits within four weeks. The Apex court said that if any of the states do not file the affidavit, it will ensure the presence of Home Secretaries along with necessary records to assist the court in disposal of the matter. It was hearing a petition which claimed that law and order situation in the country is deteriorating due to a large number of vacancies in police services at all levels across all states.

Imphal, Jan 25: The political battlefield of 11th Manipur Legislative Assembly Election is now set ready for Congress and BJP with both parties nearing completion of horse trading game. The much talk about political mileage alleged to have been bolster by Congress party in the aftermath of 7 new administrative districts including Sarder Hills seems to have been exaggerated speculations as a congress MLA of Kangpokpi Assembly constituency, Nemcha Kipgen who had tender resignation yesterday and former Congress MLA from Thanlon Assembly Constituency, Vungzagin Valte, along with former MP Kim Gangte, who was also a leader of AITC today joined the BJP.

A grand reception function of the three high profile



politicians was organized today at BJP Manipur Pradesh Office, Nityapat Chuthek.

Source close to the BJP office said that even as some congress ministers, MLAs and Speaker had bull shifted the propaganda of joining to the BJP, there are still some Congress MLAs who will be joining the party in the next two three days. However, the source decline to name the Congress MLAs whom they are counting to welcome in

their party.

Center dispatch 35 tone petroleum product

Imphal, Jan 25: The Centre has dispatched 35 tonne of petroleum products to Manipur to tackle the crisis arising out of the blockade on national highway which has crippled normal life in the state. According to reports, 70 tonne more petroleum products will be sent soon. The move comes two days after an inter-ministerial meeting, chaired by Union Home Minister Rajnath

Singh, reviewed the stock of food grains and petroleum products in Manipur and how to replenish the supply. The Central government has informed the Election Commission about the move as assembly election is due in Manipur on 4th and 8th of March. Since 1st of November last year, the United Naga Council has imposed the economic blockade on the highway.

New Delhi, Jan 25: Union Information and Broadcasting Ministry has informed that Community Radio stations, CRS will not be allowed to broadcast any programmes related to news and current affairs or political in nature. However, they can use All India Radio content, which will be provided without any charges. I&B Ministry has added new clauses in the guidelines for Community Radio.

NE Students' Body Urges Centre to Intervene in Solving Manipur Crisis

Ghy, Jan 25: Expressing serious concern at the deteriorating condition in Manipur and the economic blockade since November 2016, the North East Students Organisation (NESO) has demanded that the Central Government intervene to solve the crisis.

At a meeting in Guwahati, the NESO demanded that the Centre bring all those

involved to the negotiating table to amicably resolve the issue.

"The organisation would meet Union Home Minister Rajnath Singh to request him to resolve the issue at the earliest," said NESO Chairman Samuel B Jyrwa and general secretary S Prakash Singh.

The meeting also opposed the Citizenship (Amendment) Bill, 2016, which aims at recognising

all Hindu Bangladeshis as Indian citizens.

NESO advisor Dr Samujjal Bhattacharya stated, "The government of India should realise the Northeast is not a dumping ground of illegal migrants, whoever they may be — Hindus or Muslims. The Northeast region will not take burden of any illegal foreigner who came after 1971 as per the Assam Accord."

Rijiju lays foundation stone of Integrated Check Post in Meghalaya

Meghalaya, Jan. 25: Minister of State for Home Affairs Kiren Rijiju has laid the foundation stone of the Integrated Check Post (ICP) at Dawki, West Jaintia Hills District, Meghalaya in the presence of Member of Parliament, Lok Sabha, Vincent H. Pala, Meghalaya Home Minister H. D. R. Lyngdoh and other dignitaries.

The ICP is being developed by the Land Ports Authority of India and would be spread over an area of 22 acres.

The ICP will provide world

class facilities for bilateral trade as well as for movement of passengers across the border and will generate employment opportunities and provide a major fillip to the economy of the State and the region.

The work is scheduled to be completed by August, 2018. Addressing the gathering, Rijiju stressed on the need for opening up of the borders for trade and commerce in order to bring in prosperity and economic development in the region.

"Although the North-Eastern region is geographically

isolated from the rest of India, it shares more than 95 percent of its borders with other neighbouring countries and we should leverage this position to our advantage by maintaining a cordial relationship with our neighbours and fostering bilateral economic ties with them, he added.

Others who spoke on the occasion were Vincent H. Pala, High Commissioner of India in Bangladesh, H. V. Shringla, H. D. R. Lyngdoh and senior officials from the Land Ports Authority of India.

'Quota a Government policy, courts can't embark on it' - SC on disability plea

New Delhi, Jan. 25: Reservation and relaxation for Physically Handicapped category candidates in civil services examination is a matter of government policy and courts cannot embark on it, the Supreme Court said yesterday. A bench headed by Ranjan Gogoi set aside the judgement of the Madras High Court and the view taken by Delhi High Court that "increasing the number of attempts for Physically Handicapped candidates belonging to General Category from 4 to 7 with effect from the 2007 Examination and not proportionally increasing the number of attempts for Physically Handicapped candidates belonging to OBC Category from 7 to 10, is discriminatory and arbitrary". The apex court bench said "the horizontal reservation and relaxation for Physically Handicapped Category candidates for Civil Services Examination, is a matter of Governmental policy and the Government after considering the relevant materials have extended relaxation and concessions to the Physically Handicapped candidates belonging to the Reserved Category

as well as General Category.

"It is not in the domain of the courts to embark upon an inquiry as to whether a particular public policy is wise and acceptable or whether better policy could be evolved."

The bench, also comprising Justice Ashok Bhushan, said "the Court can only interfere if the policy framed is absolutely capricious and non-informed by reasons, or totally arbitrary, offending the basic requirement of the Article 14 of the Constitution."

The verdict came on appeal filed by the Centre challenging two judgements of the high courts which allowed Physically Handicapped students of OBC to avail 10 attempts instead of 7 attempts in the Civil Services Examination.

Both the High Court's had held that since the attempts for Physically Handicapped candidates belonging to General Category have been increased from 4 to 7 with effect from 2007 Civil Services Examination, there should be proportionate increase in attempts to be taken by Physically Handicapped

Candidates belonging to the OBC Category.

The apex court said when the attempts for exams of Physically Handicapped candidates of OBC Category as well as those of in General Category are made equal, there is no question of discrimination as the candidate belonging to OBC Category has already been given ten years relaxation in age which give them a relaxation of three more years.

It said it was not a case of treating "unequals as equal" but a case of extending concessions and relaxations to the Physically Handicapped candidates belonging to General Category as well as Physically Handicapped belonging to OBC Category.

"Physically Handicapped Category is a Category in itself. A person who is physically handicapped, be it Physically Handicapped of a General Category or OBC Category, suffering from similar disability has to be treated alike in extending the relaxation and concessions. Both being provided 7 attempts to appear in Civil Services Examination, no discrimination or arbitrariness can be found in the above scenario", the bench said.
