Kohima, July 16: 43 NPF MLAs led by NPF Legislature Party Leader TR Zeliang along with Lok Sabha MP Neiphiu Rio yesterday met Governor PB Acharya and apprised him of the present crisis in the Government

MLA & NPF Spokesperson Tokheho Yepthomi in a release said the 43 elected MLAs are mandated by the people to run the affairs of the State and under no circumstances can these MLAs be termed as trouble

makers or imposters.

He insisted that the incumbent Chief Minister Dr. Shürhozelie Liezietsu, who is not elected, has been running the affairs of the r the last 8-9 days with just 11 MLAs, which is totally unimaginable and has never happened in the history of India. Defending Acharya directive for floor test, Tokheho said that the Governor is doing so as per the Constitutional

provisions and requirements. În a separate release, Press Secretary to NPF Legislature Party Leader Azeu Namcyn Hau said that the 43 legislators pointed out the abnormal functioning style of the incumbent Chief Minister was totally unacceptable. According to the release, Acharya maintained that whoever proved majority must run the government. The Governor said BJP-NPF alliance must not be broken for stability and

development.

Zeliang also said that the minority Government head ed by Dr. Shürhozelie should be asked to step down honorably instead of heading to the legal battlefield to cling on to power. ## JAC Anti Tribal Bills lobbying central leadership for separate administration of Outer Manipur

Imphal, July 16: A joint delegation of the Joint Action Committee Against Anti-Tribal Bills (JAC) and representatives Mizoram's apex civil society organizations and political parties are in New Delhi since July 11 this year to appraise the Union Government of the situation pertaining to some of the terms of the

Memorandum of Understanding (MoU) signed between the JAC and Manipur Government by emphasizing the need for a separate administrative setup for the tribal people of Outer Manipur including the Zo (Chin-Kuki-Zomi/Mizo) descendants of Southern Manipur.

A statement by the JAC said that the joint delegation met various Union Government officials and leaders from the North East Region including Pu R.N. Ravi, the Interlocutor

for the ongoing Indo-Naga Peace Talks. With the Indo-Naga Framework Agreement expected to conclude soon, the joint delegation from Manipur and Mizoram appraised the Interlocutor of the mounting apprehensions and concerns of the Zo people in present Manipur; the undying aspiration of the Zo people for integration of their ancestral lands was also discussed at length.

The representatives from Mizoram also submitted a memorandum to the Prime Minister's Office as well as the Ministry of Home Affairs, and presented a copy of the same to Pu R.N. Ravi which describes the historically distinct identity of the Zo people of Manipur and stressed on the need for them to be able to determine their own future. It also dwelled on

the marginalization of the Zo people in Manipur and called for the fulfilment of their enduring desire for integration of Zo ancestral lands under the same administrative unit. The memorandum was signed by various civil society organizations and political parties of Mizoram including the Central Young Mizo Association (CYMA), Mizoram Upa Pawl (MUP), Mizo Hmeichhe Insuihkhawm Pawl (MHIP), Mizo Zirlai Pawl (MZP), Mizo Students' Union (MSU), Zo Re-unification Organization (ZoRO), Bharatiya Janata Party (BJP) Mizoram State, Indian National Congress – Mizoram Pradesh Congress Committee (MPCC), Mizo National Front (MNF), Zoram Nationalist Party (ZNP) and Mizoram People's Conference (MPC). It may be noted here that two months have passed since the signing of the MoU between the JAC and Manipur Government in the presence of a witness from the Ministry of Home Affairs, but some of the points of understanding are yet to see the light of the day. With the Government stating its readiness in the MoU to provide all financial assistance for the construction of Tribal Martyrs Park and Tribal Martyrs Hall, ground work for the Park at Mata Dam, Lamka was initiated by the JAC with borrowed funds and contributions from wellwishers with the hope that the same may be ready for inauguration on Tribal Unity Day (August 31, 2017); however, the State Government is yet to release any amount towards the construction of both Tribal Martyrs Park at Lamka as well as Tribal Martyrs Hall at Singngat.

#### Bangladesh: 4 islamic militants surrendered in Dhaka

Dhaka, July 16: Four suspected Islamic extremists surrendered to law enforcers Sunday following a massive raid being conducted at a suspected militant hideout in Chaurabari area of Nayarhat village in Savar since Saturday

Mufti Mahmud Khan, director of legal and media wing of Rapid Action Battalion (RAB) confirmed the news to the Morning Star.

Earlier, the law enforces called

Mufti Mahmud Khan said,

Tipped-off that the house was being resided by extremists, the battalion personnel cordoned-off the house around 1:00am.

Other residences of the nearby houses were evacuated, he said. The extremists opened fire on the law enforcers around 3:00am, Mufti Mahmud

They also opened fire targeting the battalion members some time before 7:00am when RAB also retaliated, he said.

He said they assume presence of more than one extremist inside the house but it is not possible to say their numbers

right now.

Meanwhile, the owner of the house was taken into RAB's custody and interrogated, the battalion official said. He, however, did not disclose

the name of the house owner immediately.
'It is not possible to say which

extremist organisation they belong to but it is certain that they are islamic extremists', he

added.

#### Those opposing Framework Agreement are anti-peace, anti-Naga: NSCN(IM)

By: Samudra Gupta Kashyap Guwahati, July 16: The NSCN(IM) on Saturday reaffirmed its faith in the Framework Agreement that its leaders had signed with the government of India in August 2015, described it as one that would protect "the right, the identity, the land and the future of the Nagas", and at the same time said those opposed to the agreement were "anti-Naga National Issue and anti-peace process."

A crucial joint council meeting of the NSCN(IM)'s steering committee and the Council of Kilonsers (members of its own government) held on July12 in a resolution also said that NSCN(IM) government of India had signed the Framework Agreement as "two entities" and that it was signed "in consideration of the sovereign right of the Nagas and the security interest of The historic Agreement,

which was made in consideration of the sovereign right of the Nagas and the security interest of India, will protect the right, the identity, the land and the future of the Nagas," a press release issued by the NSCN(IM)'s media wing, said. The press release, quoting another resolution of the meeting said that individuals or organizations that were opposed to the Framework Agreement would be termed "anti-Naga National Issue and anti-peace process." The NSCN(IM) and its Government of the People's Republic of Nagalim also asked the Naga people not to be misled by certain sections of people, who have been raising slogans opposing the Framework Agreement "in order to safeguard their vested interest and ambition."
While the NSCN(IM)

refrained from naming the groups, the fact remains that four other Naga groups – GPRN/NSCN (KK); Naga National Council (NNC, Non Accordist), NNC and NNC FGN - had alleged that the agreement was "a stage managed activity under the with gross carpet with gross inconsistencies by the signatories which is

destroying the very purpose of the accord." (Courtesy: Indian Express)

### NEFIS welcomes Supreme Court order directing CBI to conduct investigation into cases of extra-judicial killings!

Imphal, July 16: North-Eas Forum for International Solidarity (NEFIS) said it welcomes the order of Supreme Court directing Central Bureau of Investigation (CBI) to conduct inquiry into the cases of extrajudiacial killings in Manipur by the Army, the Assam Rifles and Manipur Police.

In a statement the NEFIS said that the present ruling also pointed out the compromised nature of the investigation which would result if one depended on the State Police

to probe such cases. It should be known that Manipur Police has not registered any FIRs at the behest of the kin of those killed in encounters. This decision is a step ahead in repealment of Armed Forces Special Powers Act (AFSPA) which gives soldiers sweeping powers to arrest or interrogate people in "disturbed areas" or states dealing with separatists or insurgents. This law has been used by the army to use draconian measures against Indian people.

By denying the right to rule of law, the Indian state has kept North-East people relegated to the status of second class citizenry in the country that claims itself to be the world's largest democracy, the statement said. "While NEFIS welcomes this

move as a vindication of democratic movement against AFSPA, one has to see what more can be achieved on the ground. It awaits the repeal of AFSPA, only which could restore civil liberties in the North-East" the NEFIS North-East" statement said.
