Visually Impaired Teacher Discriminated by Directorate of Education(S)'

Imphal, July 20: Recent transfer and posting order issued by the Directorate of Education (s) has caused a serious inconvenience and felt discriminated to visually impaired upper primary

In a statement by Relief Centre for the Welfare of Differently Able Persons, Manipur the Directorate of Education(s) overlooked the transfer and policy guideline of Person with disability order by the

government. The Relief Centre for Welfare of Differently Able Persons appeals the government to stay the transfer and posting order No.AO/59/TT(RMSA/ SSA)/2011(4)-DF(S) dated 14th July 2017 in favour of the visually impaired teacher and allow him to continue his service at Sagolband Popular Upper Primary School, Imphal. RCWDAP further alleged that the said order by the Directorate of Education(s) is an infringement on the Rights

of Persons with Disabilities Act 2016. According to Rights of Persons with Disability Act 2016, Chapter-II Rights and Entitlements, under section-3 Equality and non-discrimination clause (3) (3) No person with disability shall be discriminated on the ground of disability, unless it is shown that the impugned act or omission is a proportionate means of

achieving a legitimate aim.

The report further stated that, according to No.36035/3/209-Estt.(Res) Government of India Ministry of Personnel, Public Grievances and Pensions Department of Personnel and Training North Block, New Delhi. Dated the 315J; March, 2014 H. Preference in transfer/ posting as far as possible, the persons with disabilities may be exempted from the rotational transfer policy/transfer and be allowed to continue in the same job, where they would have achieved the desired performance. Further, performance. Further, preference in place of posting

at the time of transfer/ promotion may be given to the persons with disability subject to the administrative constraints. The practice of considering choice of place of posting in case of persons with disabilities may be continued. To the extent feasible, they may be retained in the same job, where their services could be optimally utilized.

The Relief Centre for the Welfare of Differently Able Persons, Manipur, suggested that persons with disabilities should preferably be posted nearest to their homes till they wish to be remain posted .and wish to be remain posted, and no government transfer policy should hinder them in performing their duty effectively. Further the Relief Centre

appeals the State Government kindly to set up a separate Department for Disability Affairs in the interest of persons with disabilities so that their grievance could be addressed effectively.

CM tactful in dealing oppositions charges Governor's address passed

Imphal, July 20: 2nd Session of the 11th Manipur Legislative Assembly which begins today turn out to be another tachtful show of Chief Minister N. Biren Singh as he left oppositions MLAs speechless on giving clarification on why certain issues are not included in the Governor's speech to the house adressed on March 21, 2017, when two opposition MLAs moved for amendment of the Governors address.

While discussing the motion of thanks to the Governor's Address moved by Works Minister Th. Bishwaiit and seconded by Awangbou Newmai both the legislators appreciated the governor for expressing the need for peace and communal harmony in the state for an inclusive development in the state. Legislator Th.Bishwajit, who is also theworks minister of the state government while moving themotion of thanks to the governor's speech said that the speech reflected the Narendramodi who had said that without the development of the north east region India will not be called developed

Legislator Awangbou Newmai while appreciating the Governor address has highlighted the policy and programme of the government for creating a conducive and

peaceful state.

Opposition legislators Khumukcham Joykishan and Govindas Konthoujam moved motion for amendment of the Governor's adress on the ground that it lackscertain burning issues like that of the NSCN_IM framework with the government of India, Legislations for protection of indigenous people of the state, failure to implement Lok Ayukta Act in the state. Other issuesforimpowerment of local bodieshave also been missed out in thegovernor's address so urged the house for amendment of the speech.
Clarifying to the opposition Singh who is also the leader of the house said that his government will not left out matters of public interest which was taken up by the previous government. He said that issues for introduction of legislations for prtection of indiginous people of the state is the need of the hour but such a sensitive issue need to be consulted with all the stake holders of the that state. A hasty move may sabotage the peaceful atmostphere of the state, Biren added. Onthe NSCN-IM and GOI Framework agreement, Chief Minister said that his government is firm on the commitment for protection of the territorialintegrity of the state. However, as Manipur isnot a party to the talk it is not appropriate to mention on the governor's speech even though the government is ready to face any consequences that might effect the state. On the matter for the implementation of Lok Ayukta and protection of the paddy

field as well as dealing with the flood Chief Minister N Birer Singh said that his government is committed and has already been working out for that in the short 3 month period. The Governor speech was passed later without further objection.

Case filed, Roommate detained in Manipuri student's murder in Bangladesh

Sheikh has been arrested sneth has been arressed for his suspected involvement with last week's murder in Chittagong, port city of Bangladesh.

Mohammad Kamal, OC of

Monammad Kamal, OC of Akbar Shah Police Station said to the Imphal Times, 'Niraj Guru, who is also from India and lived in the same flat with Ateef, was

taken into custody on Wednesday afternoon.'
A Chittagong court later in the day sent him to jail after Niraj was produced before it. Earlier, a case was filed on Tuesday night for the murder. Victim Md Ateef Sheikh's father Md Abdul Khalek filed the case with Akbar shah police station accusing eight people – Ateef's three roommates and five others who went to the apartment for a party — of killing Ateef. Ateef's father filed the case against Winson Maisnam Singh, Nirash Grum and Jyotsna Devi Tumrong and five other students of University of Science and Technology Chittagong. OC Alamgir said that they were investigating the murder

No plea for his remand was filed on Wednesday, Chittagong Metropolitan Police's Additional Deputy Commissioner Nirmalendu Bikash Chakrabarty told. He said the remand plea

would be submitted after proper procedures needed to interrogate Nirai as he is a foreigner.

In the wee hours of Jul 15, according to Niraj, Ateef was found in a bloodied state on the floor of his room that he shared with another Indian student of USTC named Wilson Singh. Wilson was found hanging from the ceiling fan.

The police later confirmed that Ateef was murdered with a sharp weapon.
