The DDU-GKY is the skills action-arm of the National Rural Livelihoods Mission, tasked with skilling rural youth, moving them from poverty to productivity. It owns and manages the entire lifecycle of the process, from investing into Skilling Projects (at no cost to the trainees or employers) to identifying internships and

placement opportunities and to track career progression over a period of 3 years from graduation.

According to the MSRLM, the number of rural youths to be trained till March 2019 is 10518 candidates

DDU-GKY follows a 3-tier implementation model. The primary tier is the National Unit that functions as the policy-making, technical support, facilitation and investing agency. The next tier is the DDU-GKY State Skill Missions under the State Government/ State Rural Livelihood Missions, who coinvest as well as directly supervise and/or engage with publicly or privately held organisations from specific sector industries, education and training or NGOs who have a reputation in delivering training development programs.

# CM presides meeting on GST,

Directs officials to sensitize people on the new tax regime

Imphal, July 05: Chief Minister Shri N. Biren Singh presided a high level meeting on Goods and Services Tax (GST) in the Conference Hall of Old Secretariat today.

Speaking at the meeting, the Chief Minister directed all the concerned to have thorough knowledge about the new tax regime. He also asked them to impart proper awareness to the common people, who are at the grassroots level, to make revenue/tax collection easier. directed the officials, DCs and SDOs to take The Chief Minister also SDOs to take the responsibility of revenue collection seriously and work hard at the ground level.

He said that the meeting was convened to discuss the pros and cons of GST, and also to find ways to effectively enforce it in the State.

As GST is a new concept, the Chief Minister observed, all the Government machineries need to work in better co-ordination and understanding for its effective implementation. Deputy Chief Minister Shri

Secretaries, Commissioners, SDOs and other high ranking officers were present in the meeting.

Speaking to reporters after the inspection, the Chief Minister said that all the SDOs had been appointed as Nodal Officers of GST at the Sub-Division level. As such, they would give proper awareness on the new tax regime to the people at the grass-root level, he added.
Stating that around 17

different taxes were imposed on goods and services at Centre and State levels earlier,

that all these taxes had now been clubbed together into a single tax known as GST.

No matter Prime Minister Shri Narendra Modi had revived the 90:10 Central - State share for North East States, all the developmental projects depend upon the financial condition of the State.

As such, the Government needs to strengthen and revitalise the tax/revenue collection system in order to add extra pace to development, the Chief Minister stated.

Responding to a query on the Central Government's assistance regarding flash floods faced by the State, Shri

Biren said that after the Government declared the present situation as a State calamity, he had not only written a letter to the Prime Minister but also personally talked to Union Home Minister Shri Rajnath Singh over the phone on the issue. as soon as possible.

# Encounter killings: SC asks states to reply to NHRC plea

New Delhi, July 5: The Supreme Court today directed various states to file their replies on a plea of the National Human Rights Commission (NHRC) seeking direction for mandatorily giving information about any encounter killings in their respective jurisdiction for

purposes of enquiry.

A bench of Justices A M Sapre and R Banumathi directed the states should file their replies within eight

Advocate Shobha appearing for NHRC said some states

have filed their replies but many

of them were yet to do so. She urged the bench to give states the last opportunity to file their replies saying that the notices to state governments on the petition were issued in 2014. The NHRC in its plea has sought direction that the state governments and police authorities should continue to provide the information asked for by it in accordance

with the guidelines and provisions of the Protection of Human Rights Act, 1993,

for probing the cases of encounter killings.

It has also sought direction that the state governments should not refuse to comply with the recommendations made by Commission.
The Commission said that

due to apex court verdict of 2014 by which certain guidelines were framed, its role in such enquiries has virtually been nullified.

"The said guidelines which are made in sub-silentio, having not considered various mandatory provisions of the Protection of Human Rights Act, 1993, circumscribe and completely abrogate the power conferred

on NHRC by the Act, to enquire suo motu or on a petition presented to it by a victim or any person on his behalf into any complaint of violation of human rights by a public servant," the plea said.

It said that Section 12(a) of the Act makes a mandatory obligation upon the NHRC to inquire suo motu or on a petition presented to it by a victim, into the complaints of violation of human rights by

a public servant. It said the Commission has issued guidelines from time to time regarding the procedure to be adopted in cases of encounter killings.
"The latest guidelines were

issued by the Commission in May 2010 which provided that an information of encounter killing should be given to NHRC within 48 hours after the incident and a second report along with the Magisterial Enquiry Report and forensic report should be submitted to the Commission within three months," it said. It said such provisions cannot be rendered redundant by the guidelines framed in the PUCL case.

#### Why no law made for appointment of CEC, EC: SC asks Centre

New Delhi, July 5: The Supreme Court today asked the Centre as to why no enabling law as mandated under the Constitution has been made for the appointment of the chief election commissioner and election commissioners in the poll panel.

A bench comprising Chief Justice JS Khehar and Justice DY Chandrachud said that Article 324 of the Constitution

appointments of the CEC and the ECs be made as per the enabling law, but the law has not been enacted so far.

court, however, acknowledged that till now good persons have been appointed in the poll panel. The bench was hearing a Public Interest Litigation seeking various reliefs including that there should be a fair and transparent procedure for appointment of CEC and ECs.
