Manlun was commissioned as officer in 2010 and his first unit was Naga Regiment. Three militants were killed in the gun battle and a civilian was caught in the crossfire,

Army source said. Three jawans were also hurt in the encounter.
The body of the slain officer

was brought home to the Assam Regimental Centre in Happy Valley, Shillong on Wednesday and was received with full military honour

## EPFO extends deadline for submitting Aadhaar to June 30

New Delhi, June 8: Retirement fund body EPFO has extended the deadline for submitting Aadhaar number to June 30 for its over four crore members. However, the deadline for submission of Aadhaar number would be September 30, 2017 in case of north-east

"All field offices are directed to ensure that Aadhaar Number is furnished by the employer in respect of all new members who join the

Employees Pension Scheme, 1995 with effect from July 1, 2017 except north east states where it would be applicable from October 1, 2017.

The Employees' Provident Fund Organisation (EPFO) had set April 30, 2017 as the deadline for submitting Aadhaar number earlier.

The EPFO in January made it mandatory for its pensioners and subscribers to submit Aadhaar numbers

Later the deadline by revised time and again in view of slow

progress over Aadhaar number submission by members. The central government contributes 1.16 per cent of the basic wages as subsidy to every member Employees Pension Scheme Account in addition to 8.33 per cent deposited by their employers every month.

Since the government provides subsidy to an EPFO member, it has invoked Section of the Aadhaar (Targetted Delivery of Financial and other Subsidies, Benefits and Services) Act 2016, for the purpose.
The Section 7 of the Act provides that where government provides subsidy, benefit or service from Consolidated Fund of India, an individual can be asked to undergo authentication, or furnish proof of possession of

Aadhaar number. It also provides that where an individual to whom no Aadhaar number has been assigned, such individual can apply for enrolment.

## *Mob menace : A threat to justice delivery*

Imphal, June 8: Hunt the owner if the dog bites. So is the saying in Manipur? And what is happening in the last couple of days here in Imphal is no difference. A psychopathic killer murdered a mother and her daughter and a suspect was apprehended. Without waiting for the investigation on whether the suspect is the real accused or not an angry people search for his owner, dismantle the house of the alleged murderer and ostracised all the members of the family from the locality for the heinous crime committed by a Psycho killer. The trend is not new; these kinds of incident are common in Manipur society in the last couple of decades. There were incidences where minor children were punished by leaving them as orphan after their parents were lynched to death for the crime they had committed. Nobody care and notice the fate of the children who knows nothing about the kind of crime

committed by their parents.

Many mothers, fathers, brothers, wife and children had suffered and had to spend a painful life for the crime committed by their son, father or husband. And critics blamed on law enforcers and the justice delivery system of the country for the kind of the fall out. There were time when people had completely lose faith in law enforcers and that was one reason for mob to throng into action instead of waiting for the law enforcers to act. At a time when mob justice was at its peak, the state government taking with due seriousness had tried many means to prevent the mob menace. Community policing, public interaction and many other had been organised.
Years have gone; the law enforcers now left few rooms
for criticism. Many officers now spent sleepless night to solve cases of heinous homicide crimes. The last two three months saw at least seven cases of homicide. And officers in the police department have done enough by

speeding up the investigation. The result - the person responsible for the killing of Lunglairung Rongmei on May 5 this year have been arrested and are now in iudicial custody.

paarcia custody Similarly, within a very short span a suspect of the murder case of a mother and her daughter at Uripok Bachaspati Leikai here in Imphal on May 30 was also

arrested.
What is surprising is that, even after knowing that the law enforcers are doing their work well, the mental dementia still continues. It was the most heart shocking murdered, and the
