No wrongdoing in regularization process: COHSE employees

IT News Imphal, May 11:A group of the newly regularized employees of Council of Higher Secondary Education has today condemned the accusation of wrongdoings in their recruitment process leveled by a students' group terming it as saddening and unfortunate and a potentially lethal attack on their careers. Addressing media persons, a representative of the newly regularized employees pledged that there was not a single instant of jumping the rules during the recruitment and and no undeserving individual was regularized by flouting the rules. The antagonistic views directed at them were a product of shallow investigation and imperfect discussion, he said. Since the council is an

autonomous body all of its administrative decisions are adopted at meetings of the members that are held as per the requirement. Due to a situation resulting from the office being understaffed the council passed orders for recruitment on two occasions in 2013 and 2014 after which the vacant posts were filled on a casual basis. The recruitment was not singlehandedly carried out by the chairperson and secretary who were at the helm of the council at that time. the regularized employees claimed in a statement distributed at the press meet. Many hindrances were put along the path of the regularization of these employees time and time again though they were eligible according to the rules people and many

mischievously spread wild rumors of their employment being executed beyond the rules. Consequently, the employees approached the high court which passed orders on two separate occasions in 2015 and 2016 for their regularisation after

SC begins hearing on Triple Talaq;

Muslims. The bench also comprising Justices Kurian Joseph, R F Nariman, U U Lalit and Abdul Nazeer, however, said the issue of polygamy among Muslims may not be deliberated upon by it, as this aspect is unrelated to triple

talaq. The bench is hearing seven petitions, including five separate writs filed by Muslim women challenging the practice of triple talaq prevalent in the community. The petitions claim that triple talaq is unconstitutional.

The pleas have also challenged the constitutional validity of other practices like 'nikah halala' and polygamy among Muslims. The bench is taking up the main matter on its own as a petition titled 'Muslim Women's quest for

equality'. The apex court gave each side two days each for canvassing

their arguments on the questions formulated by the bench and one day will be given for the rebuttal. The apex court also made it clear that it would stop any counsel who will repeat the arguments. The apex court had on its own taken cognizance of the question whether Muslim women faced gender discrimination in the event of divorce or due to other marriages of their husbands. The hearing assumes significance as the apex court has decided to hear the case during the summer vacation and is likely to sit on Saturdays and Sundays to expeditiously decide the contentious and sensitive issues arising in the matter.

It holds importance as the Allahabad High Court in its verdict pronounced in the last week of April, had held the practice of triple talaq as nilateral and bad in law.

Muslim organisations like the All India Muslim Personal Law Board, AIMPLB, have opposed court's adjudication of these matters, maintaining these practices stemmed from the Holy Quran and were not justiciable.
