2 State legislators pledge to give up cigarette on World No Tobacco Day

Imphal, May 31: Two legislators of the state - Health and Family Welfare Minister L Jyentakumar Singh and Parliamentary Secretary (Health and Family Welfare) S. Subashchandra Singh today pledged to give up cigarette in the presence of Union Minister of State for Health and Family Welfare, Smt. Anu

'Will not implement beef ban'

Kohima: The Centre is examining representations given by states and some other organizations on the recent ban on sale and purchase of cattle at animal markets for slaughter. Union Minister Venkajah Naidu talking to media in New Delhi yesterday said, the rules were notified in the backdrop of some observations made by the Supreme Court on preventing cruelty to animals and breaking nexus in animal markets including smuggling. He said, some issues were raised by a few state governments and other trade organizations and these are being examined by the government.

The new rules prohibit slaughter of cattle and establishment of animal market and slaughter houses. Meanwhile, Nagaland is not going to implement the Centreimposed-ban on the sale of cattle for slaughter, Minister of Forest and Environment of Nagaland Imkong L. Imchen, informed media persons. The minister was of the view that the new rules affect the traditional food habit in Nagaland, where beef is a staple food. The Nagaland Pradesh Congress Committee has also slammed the Centre for imposing the nation wide ban on sale of cattle for slaughter under the shelter of Prevention of Cruelty to Animals Act, 1960.

Flash flood leaves many parts of Imphal valley submerged

Imphal/Thoubal May 31: Heavy rainfall in the past three days in Manipur spread panic among residents after water bodies including rivers and lakes were swollen, causing flash flooding in many parts of Imphal valley.

It has been reported that several houses were damaged in different parts of the state due to continuous rainfall. Official sources said that Imphal river had crossed danger level and that other major rivers were swollen due

hajor rivers were swonen due to heavy showers. Many places in Khurai and Wangkhei of Imphal East have remained inundated with flood waters. Localities like Khurai Puthiba, Khurai Chingabam, Khurai Tellipati and Lainingthou Luwangba Laishang (temple) and a community hall have been submerged under several feet of flood waters. Water loggings in several parts of the capital were also reported.

Meanwhile, the front portion

of Sekmai Dam over Sekmai river under Lamshang constituency was breached after heavy rainfall. Water level in Sekmai river was flowing above danger level, sources said.

Local MLA Salam Rajen accompanied by an official team that included Chief Engineer of Minor Irrigation took stock of the Sekmai Dam.

Officials said, "The damage portion of Sekmai Dam does not pose any threat to the dam The cyclonic storm Mora

reached Northeast on Tuesday. The storm reached neighbouring Mizoram on Tuesday after it hit Bangladesh's Chittagong. Due to the cyclonic storm, many parts of Manipur, Nagaland, Tripura, Mizoram, Meghalaya and Arunachal Pradesh received heavy to very heavy rainfall on

Tuesday.
At least 80 houses were damaged in Mizoram's Saihah district after heavy rains accompanied by strong winds lashed the state vesterday. Incessant rains during the last couple of days have caused flooding in many areas of Thoubal and Kakching districts has left people there in a state of extreme worry as

buildings, fish farms and agricultural fields were overed with water The biggest threat to life and properties in Kakching district was received from the swellin Sekmai river which runs across Kakching, Keirak and Wabagai and its continuous overflowing has submerged vast spans of land, including residential areas and cultivated fields. The water level of the rivers ascended suddenly this morning and breached the banks at Wabagai Thingel Leikai creating a massive opening 70 metres long. The stream of flood water submerged around 50 houses, 60 paris of agricultural land, homesteads

and fish ponds.
On the other hand, in Thoubal district, the Wangjing river burst at the banks in two places namely Wanjing Sorokhaibam Leikai and Khundrakpam Leikai at around 6.30 pm in the evening inundating around 300 houses in the localities. received about loss human lives due to the

AR personnel involved in Shanti murder: HRA, EEVFAM

Imphal, May 31: Human Rights Alert (HRA) and Extrajudicial Execution Victim Families Association Manipur (EEVFAM) have expressed suspicion that personnel of Assam Rifles have a role in the killing of Arabam Shanti in Moreh and asked the investigating agencies to probe this angle thoroughly.

In a joint press statement released today, the two organizations reportedly conducted a public meeting in connection with the killing of Shanti at Premnagar Mandop, Moreh. The meeting was attended by the family members of the deceased, meira paibis. community elders and youths

The family members including Shanti's husband, her son and her sister described the fateful day in which half a dozen bullets were pumped into her body by two masked men coming in a bike on May 22, 2017 at around 4.00 PM. Her son who drives an auto-rickshaw took her to the hospital only to watch her succumb to her injuries.
The Moreh Police station has

drawn up a suo motto having FIR no. 25(5)2017 MRH-PS under section 302/34 IPC and 25(1-C) Armed Act dated 22 May 2017.

According to the statement, the killing took place in close proximity to the Assam Rifles (AR) camp and according to eyewitness who does not want to be named, an Assam Rifles Gypsy was seen parked at a very short distance from spot of the killing. It is also pointed out that soon after the incident. some AR personnel came and picked up the empty cartridges lving at the crime scene.

"EEVFAM and HRA would like point out that if this act, if true, amounts to disturbing the crime scene and tempering valuable evidence, which raises serious questions about the motive of the AR in connection with the killing', the statement said.

This suspicion, it said, is also further corroborated by a report that when police apprehended two men moving in suspicious circumstances in a bike at midnight (intervening night of May 23 and 24) with small unregistered pistols, the Commanding Officer of the 11 Assam Rifles stationed at Moreh resisted the police taking the duo to Imphal for interrogation. It is not clear how these two suspects were laid off without even recording their statements under section 161 of CrPC or registering FIR against them, it questioned.

Under these circumstances EEVFAM and HRA share the deeply held suspicion of the community that the role of AR in the killing of Shanti cannot be ruled out. The present investigation should thoroughly probe this angle. It is therefore recommended that the investigation should be handed over to the CB-CID and handled by a police officer or no lower rank than a DIG.

"EEVFAM and HRA are also shocked by the atmosphere of insecurity prevailing in the community and the fragile ethnic balance due to divide and rule policy. Even though, the truth is known to the community , no one dares to speak out openly or publicly protest against the killing. It is therefore recommend that the Government should immediately take such action so that the citizens of Moreh are secured and to fully enjoy the right to life, the right to freedom of expression, the right to freedom of association and assembly as guaranteed by the Constitution of India and international human rights instruments" the release stated...
