Locals throng to hunter's residence

IT News Imphal, Nov 27: Awareness level among the locals Keibul Lamjao area about the protection of endangered Brow Antlered Deer - Sangai seems to be growing. A day after a Hog Deer (Kharsha), a similar animal like Sangai, which

was declared as endangered was found killed, large number of people from Khordak Village in Bishnupur district stormed to the residence of an alleged hunter at around 7.30 pm yesterday. The angry locals tried to angry locals the residence of dismantled the residence of the alleged hunter identified as Heisnam Kengba Singh (64 yrs) at Khordak Mayai Leikai.

Local club volunteers of Khordak however intervened the angry locals from taking the law in their hands. Later, a public meeting held on that evening resolved to drive out any persons who hunt endangered animals from Keibul Lampjao National Park.

The endangered Sangai the brow antlered deer and the hog deer has been declared as endangered species and has been protected under the scheduled 1 of the Wild Life Act. On the other hand hunting and paoching has been ban in and around the keibul Lamjao National Park by une government authority.

Centre refuses to abolish GST on items supplied to religious places

He further said that the Preamble of the Constitution states the nature of Indian State and the objectives are committed to secure justice, liberty and equality for the people and promoting fraternity, dignity of the individual and unity and

integrity of the Nation. It declares India to be a Sovereign Socialist Secular Democratic Republic, he

added. The Chief Minister contended that the Constitution defines the framework of the country, fundamental political fundamental political principles, establishes the structures, procedures, powers and duties of Government institutions, and sets out the fundamental rights and duties of the citizens. It imparts for the constitutional supremacy not the parliamentary democracy, he

Constituent Assembly adopted the Constitution of India after the country gained independence. A Drafting Committee was earlier formed under the Chairmanship of Dr. B.R. Ambedkar. In the early part of 1948, Dr. B.R. Ambedkar completed the draft of the Constitution and presented in the Constituent Assembly.
