# ATSUM threatens state-wide general strike from Sept. 28

Imphal, Sept 22: All Tribal Students' Union Manipur (ATSUM) today threatened to call state wide general strike on September 28 over state government failure to response to the charter of demands submitted to the Chief Minister.

Vareiyo Shatsang, president ATSUM, while talking to media persons at the sideline of a sit-in-protest staged today at Chingmeirong stated that a charter of demand has been submitted to the Chief Minister of Manipur addressing the grievances of the tribal students on August

17, 2017. He said the Chief Minister had appealed the people of the state to express their grievances before calling any bandh or blockade but the grievances of the ATSUM has not been responded till today. He said that if the state government do not give any response to the sit-in-protest staged today the ATSUM will call state wide general strike on September 28.

The charter of demand includes appointment of non-teaching and teaching faculties and to develop infrastructures at the educational institutions in Hill

district, to do away with the culture of utilisation of teachers, establishment of residential schools in the hills to develop infrastructure for the ZEOs offices, to rationalise teachers, to regularise adhoc teachers and to establish PHC centers in the entire hill districts. Other demands included are to facilitate examination centers in the Hill districts and also to comply with the 31% reservation policy for the ST students at Manipur University and also to initiate reservation for ST candidates while recruitment of any government post.

#### Transport dept. verified 1852 licenses affordable and well-

Imphal, Sept. 22: Keeping in view the seriousness of fatal accidents in many cases, the Transport Department, Government of Manipur initiated a drive of checking fake / duplicate licenses being used by the drivers in the State in April this year and verified 1852 Licenses. The drive was in close coordination with the Traffic

Realizing the magnitude of the matter, a special cell has also been created in the Directorate of Transport under the Asst. Director of Transport, on 5th June 2017. Earlier 1773 Licenses have been submitted for verification and 400 fake licenses have been detected. FIRs are being lodged by the DTOs concerned and documents have been submitted to SP (CID/CB) for

necessary enquiry.
The Department is also concerned with the frequent complaints received from the public regarding unscrupulous and corrupt

practices by its officials. Under the aegis of the Anti-Corruption Cell, action has been initiated against an ASI (Taxation), DTO/Bishnupur and the concerned official has been placed under suspension.

Another achievement of the Department is the launching of VAHAN and SARATHI at DTO/ Ukhrul by the Chief Minster, Shri N. Biren Singh on the11th April 2017. This will facilitate issue for SMART Cards for SMART Cards for registration of Vehicles and issue of Driving Licenses for the citizens of Ukhrul District. It is worth to recall that the Department of Transport under the mandate of the present Government has taken up the initiative of reviving the public transport system. After a gap of 15 years, the Department launched the public transport system christened as MANIPUR STATE TRANSPORT on 25.6.17. It is conceived with the objective of providing an economical, efficient, sustainable,

coordinated transport system for the State of Manipur. This will also bridge the gap between the demand for good public transport system and its poor supply by the private transport operators that is further compounded by the lack of standard and reliability in the private transport system and at the same time, it breeds unhealthy competition and factional disputes.

It is proposed that the fleet size will be around 150 buses (mixed) to be achieved in three phases. Initially, the Government has approved five buses (Marco-Polo) for procurement. Initially, combined with the 10 (ten) Semi Low Floored (SLF) buses, the fleet size will be 15 buses (mixed). These buses will be used for inter-district and city bus services. The routes being covered are-City-Bus Service from ISBT and MST Complex, Moirangkhom in clockwise Ima Market complex: for Imphal-Thobal-Yairipok, SLF Imphal- Moirang; Imphal-Mayailambi-Kakching; Imphal-Noney; Imphal- Moreh and Imphal- Pherzawl will operate from MST, Complex Moirangkhom. The fares for the city bus are

charging at a flat rate of Rs 10, whereas, for the interdistrict buses, rate of Rs.1 per Km for valley section of the route and Rs. 1.20 for the hill section of the route is being charged. The initial response has been very positive and steps for consolidating the system by increasing the no. of routes and fleet size are

being taken up. The Transport Department is also appraised and conscious of the various concerns regarding road safety and awareness. Keeping the need for public safety and awareness, signages indicating intersection points, cross roads, speed limit, pedestrian crossing and school ahead have also been affixed.

# HC defers hearing of NPF whip case

Kohima, Sept. 22: The Kohima Bench of Gauhati High Court has deferred the hearing on Naga People's Front (NPF) whip case to 12th of next month. This was revealed by Member of Rajya Sabha and NPF Secretary General K G Kenye during an interaction with media persons at NPF Central office in Kohima yesterday. The NPF Secretary General

said under no circumstance can the Legislature Party elect the Party Whip because the Chief Whip is an appointed post which can only be appointed by the party President. Legislators can elect their

Legislative Party leader but not the Chief Whip, he said, adding that even the NLA Speaker had broken the Assembly Rule of Business by accepting T R Zeliang as the NPF whip without even rejecting the appointment of Kiyanielie Peseyie as the Party Whip since November 2014. On the claims of the NPF led by Lok Sabha MP Neiphiu Rio that over 32,000 Party workers rejected Dr Shurhozelie Liezietsu's presidentship during the general convention called by him and held in Dimapur on Wednesday, Kenye said they may claim, but whether attendees were actual NPF Party workers is questionable. He said that the actual list of active NPF Party workers was submitted to the Election Commission of India while the Master Register of the same is in the NPF Central Headquarters. Kenye said Neiphiu Rio and Zeliang group are trying to fool the Naga people with all the wrong moves but Election Commission cannot be fooled.

# SC takes stern view of cow vigilantism, asks states to ensure compensation for victims

New Delhi, Sept 22: The Supreme Court on Friday observed that all states are obliged to compensate victims in cases of violence by cow vigilantes. The apex court noted that law and order is 'essentially a state subject.'
"Victims are to be compensated. It is obligatory on the part of the state to on the part of the state to compensate the victim of crime," a bench headed by the Chief Justice Dipak Misra said. Under the Code of Criminal Procedure, the state is under obligation to have a scheme for victim compensation and if they don't have then they should have one, it added. In the previous hearing on 6

September, the court had directed the chief secretaries of every state government to file the status report and had directed all state governments to appoint a senior police officer as a nodal officer in each district to ensure that incidents of cow vigilantism are prevented and dealt with

effectively. During the hearing on Friday, Gujarat, Rajasthan, Jharkhand, Karnataka and Uttar Pradesh filed their compliance reports giving details of action taken against incidents of cow vigilantism, as reported by ANI. The apex court asked other states to file their reports soon and fixed the matter for hearing on 31 October. Senior counsel Indira Jaising,

appearing for one of the petitioners, had urged the apex court to order compensation to the victims of violence by the vigilante groups. He said that there should be a National Policy for the Prevention of Crime. Senior counsel Kapil Sibal,

also appearing for one of the petitioners, told the court that while the perpetrators of violence in the name of protecting cows were on bail, the victims faced FIRs and persecution.
The apex court was hearing a

PIL filed by Tushar Gandhi, great-grandson of Mahatma

Gandhi, seeking various reliefs, including a direction to all the governments to take preventive measures against cow vigilantism.

In July, the Supreme Court had asked the centre and the states not to protect any kind of vigilantism and sought their response on violent incidents in the garb of cow protection. The centre had stated that it condemns any kind of vigilantism, but that law and order is a state subject and it has no role to play in the

"You say that law and order is a state subject and states are taking actions as per law. You don't protect any kind of vigilantism," the bench had asserted.

Besides Gandhi, Congress leader Tehseen Poonawalla had filed a similar petition on the issue in August 2016. The top court had agreed to

examine Poonawalla's plea which sought action against which sought action against cow vigilantes who were allegedly indulging in violence and committing atrocities against minorities. In his plea, Poonawalla had alleged that these groups were committing atrocities against Dalits and minorities in the name of protecting cows and other bovines and they needed to be "regulated and banned in the interest of social harmony, public morality and law and order in the country". The plea sought to declare as funconstitutional" Section 12 of the Gujarat Animal Preservation Act, 1954, Section 13 of Maharashtra Animal Preservation Act, 1976, and Section 15 of Karnataka Prevention of Cow Slaughter and Cattle Preservation Act, 1964, which provide for protection of persons acting in good faith under the Act or

Seeking action against the vigilantes, the petition said the atrocities committed by them were punishable under various provisions of the Indian Penal Code and under the Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act.

### Model turned militant commander arrested in Dhaka

Dhaka, Sep 21: Law enforcers of Bangladesh Thursday claimed arrest of a suspected militant of the "Sarwar-Tamim Group" of the Neo-JMB, who they say is a militant commander trying to regroup

the organisation. Arrestee Imam Mehedi Hasan alias Abu Jibril is a commander of the group's "Brigade Ad-Daraqutni", Rapid Action Battalion (Rab) said.

Hailing from Patuakhali and engaged in efforts to regroup the organisation. Mehedi was arrested from Khilgaon in Dhaka, Rab said in a press

briefing in the capital.

Mehedi Hasan, son of Md
Khorshed Alam, had come to Dhaka in 2011 and had a brief career in ramp modelling, said

his brother Waliur Alam BRA graduate from Darul Ihsan University, he ran a home decor business for some

Mehedi gave up his ramp modelling career due to complaint from his family, Waliur told The Daily Star. He went missing on May 4 and his mobile phone was shut since then. A general diary was filed with Khilgaon Police

Station on May 5. He is married and now expecting a baby.

Under initial interrogation, Mehedi confessed his involvement with JMB's Sarwar-Tamim group since 2015. He had connections with top militants including Holey Artisan attacker Nibras Islam, said Rab.
