Union Cabinet clears ordinance for death penalty to child rapists

The Union Cabinet on today approved the promulgation of an ordinance that seeks to award death penalty to those convicted of raping children

below 12 years.
The Cabinet cleared the amendments to the Criminal Law ordinance 2018, a senior government official confirmed, adding that it will come into force once President Ram Nath Kovind approves it, which should

take a day or two.
The move comes against the backdrop of nationwide outrage over the brutal rape of an eight-year-old girl in Kathua district of Jammu and Kashmir

Currently, the maximum punishment for aggravated sexual assault on minors under the POCSO Act is life imprisonment. The law came

those below 18 years. The Indian Penal Code, however, prescribes death penalty for gang rape.

Other provisions included in the ordinance are for speedy investigation and trial of rape cases not more than four months together, an increase in the minimum quantum of punishment for rape convicts and the scrapping of anticipatory bail if the victim

The ordinance also requires the National Crime Records Bureau to maintain a national database and profile of sexual offenders, data of which will be shared with states and Union territories for tracking, monitoring and investigation, including verification of antecedents by police.

The government has also decided to implement a series of measures, including new

fast-track courts to try rape cases, to supplement legal provisions.

On Friday, the government had informed the Supreme Court that it is actively considering amending the penal law to introduce death penalty to those convicted of

penalty to those convicted of sexually abusing children up to 12 years of age. Referring to the Unnao and the Kathua rape cases, Prime Minister Narendra Modi had last week said that such incidents shake our sensibilities and no criminal sensibilities and no criminal will be spared and "our daughters will get justice". Recently, the Rajasthan government had approved a bill seeking death penalty for those convicted of raping girls under 12 years of age. Two other BJP ruled states — Madhya Pradesh and Haryana — have also given the go-ahead for a similar

DFO Thoubal intervene large-scale earth excavation, deforestation at Kairembikhok area

District Forest Officer (DFO) Thoubal, RK Amarjit today intervene large scale earth excavation by cutting trees at Seram Hills in Kairembikhok area of Thoubal district, A case has also been registered against the illegal excavation of forest land by the DFO.

Talking to media persons, Amarjit said that the area where illegal earth excavation are taking place for soil collection by cutting the large number of trees is under the jurisdiction of the Gwarok Reserved Forest. He said the trees that have been cut down illegally have been counted and will be collected at the earliest possible time.



He also added that the department have been planning for planting of saplings at the area where the excavation is being taken

According to the Indian forest Act 1927 and Forest Conservation Act 1980 those responsible in excavation and collection of soil by cutting

DFO, Rk. Amarjit further added that elected persons of Wangjing Tentha Assembly constituency came to his office for seeking permission of constructing a road at foothills where the large scale excavation is being taken place. They also mentioned that concerned Minister had already granted permission As per ruling of the Manipur High court, collection of soil, carrying out excavation by cutting trees at reserved forest areas – either it may be private or government properties, is totally banned . The DFO appealed the people to co-operate with the Forest department in conservation of the forest properties as it directly affects the climate

The ceasefire agreement is between the central government and the National Socialist Council of Nagaland (Reformation) and the National Socialist Council of Nagaland(Neopao Konyak/ Kitovi) has been extended for one more year with effect from April 28

Reports reaching here said that the agreement was signed on Thursday by Joint Secretary Satyendra Garg on behalf of Home Ministry, Jack Jimomi, supervisor GPRN/ NSCN) and Viniho Kiho Swu, co-supervisor) on behalf of NSCN/NK, and Toshi Longkumer on behalf of NSCN/R.

The two armed rebel groups, which operate in Nagaland, are among several other armed groups of the state such as NSCN (Isak-Muivah) and NSCN (Khaplang).
While the NSCN(I-M) has entered into

entered into a ceasefire agreement in 1997 and has been maintaining it since then, the NSCN(K) had abrogated the peace talk in March 2015.

After abrogating the ceasefire, Khaplang's rebels went on a killing spree, attacking Indian soldiers in Nagaland and Manipur. The outfit mounted a deadly ambush on an army convoy in Manipur's Chandel district on June 4, 2015, killing

PPFA calls for genuine space to citizenship debates

Expressing concern over creating sentiments with unhealthy debates and aggressive attacks over the organizations, which reportedly supported the Centre's initiative to amend the citizenship laws at the Joint Parliamentary Committee hearing in New Delhi recently, the Patriotic People's Front Assam (PPFA) insists on ra-tional debates over the pertinent issue.

The forum, in a statement issued to the media, claims that a section of Assamese intellectuals and civil society groups have tried their best to project the citizenship amendment bill 2016 in a bias perception as if the whole initiative is Assam centric.

"Those biased individuals have made the hue and cry that once it turns into a law, millions of Bengali Hindu millions of Bengali Hindu people from Bangladesh would be dumped into Assam and the practice will continue for decades. So whoever supports the initiative (s)he should be termed as Jatidrohi (read anti Assamese)," said the PPFA statement.
