Politics on Naga issue - Is this for electoral gains?

Either it is at Manipur the hot spot of Insurgency Theater, or at Nagaland where Naga insurgence have full power to influence the electoral politics, the age old unsettled issue of the Naga always comes up in public domain when general election or parliamentary election is knocking at the door.

A news report, collected form official source, and published at one of the most respected newspaper "Indian Express" says that the Naga Accord is nearly at the final stage. It further added that the accord will not change boundaries of any neighbouring states of Nagaland particularly for the state of Manipur.

Incidentally, the news report appeared when the Election commission of India (ECI) announced the by-election date for the lone Nagaland Parliamentary Constituency.

As per the announcement the election for the lone MP seat will be held on May 28, 2018.

Before that, in September 2017 Governor of Nagaland PB Archarya had also assured the people of Nagaland that the issue will be solved in two months.

Strike by resident doctors partially affects healthcare services in AIIMS

The strike called by the resident doctors of the All India Institute of Medical Sciences (AIIMS), after one of their colleagues was assaulted by a senior doctor partially affected healthcare services at the premier institute Friday.

In a statement late Thursday night, the AIIMS said the incident in question took place on Wednesday, following which the senior doctor apologised to his junior.

The doctors have demanded immediate suspension of the senior doctor, who also heads a department at the premier institute. The Resident Doctors' Association (RDA) has also urged that the doctor in question should not be allowed to take in thesis candidates and conduct any kind of verbal or written examination.

As a mark of protest, the doctors Thursday worked wearing helmets. They also sought a written apology from the senior doctor concerned. In the wake of the strike, the hospital has instituted contingency measures to take care of the admitted patients, including those in the ICUs and wards. Emergency and ICU services

Emergency and ICU services remained operational, but all routine surgeries have been cancelled, outpatient clinics being run in a restricted manner and all academic activity and exams postponed indefinitely, a senior officer of the administration said.

The hospital administration has put

The hospital administration has put in place a contingency plan for patient care services, as a part of which faculty-on-call in all clinical departments will physically man the in-patient wards.

"OPD services will function on restricted basis till such a time that normalcy is restored. Only followup patients with prior appointment will be registered in OPD. New Patients OPD registration will be done as per availability of faculty in respective OPD as decided by Head of Department/Unit concerned. No walk-in registration (new and old) will be done," the order by the administration said. Routine surgeries will remain suspended and only emergency cases will be taken up for surgery. Diagnostic services will function on a restricted basis as maximum possible for the faculty, it stated. "Head(s) of all clinical departments will make arrangements for round-the-clock availability of doctors of speciality concerned either from research staff or by the faculty members. Under no circumstances any inpatient ward will function without physical availability of doctors of speciality concerned," the order read.

In a statement late last night, the AIIMS said the incident in question took place on Wednesday, following which the senior doctor apologised to his junior.

In a letter to AIIMS Director Randeep Guleria, the RDA alleged that the senior doctor slapped a senior resident in front of attendees, nursing staff and colleagues, and that the resident doctor was under depression and had gone home.

The resident doctors also raised the reported misbehaviour of the senior doctor towards the female residents. "Dear Director sir, we talk about violence against doctors by relatives of patients, but this act has caused great anguish among residents and shattered the sacred student-teacher relationship," read the letter. "We expect an immediate and strong action from your side so that a message goes out that doctors are not here to be beaten," it said.

The AIIMS director had also instituted a five member committee to be chaired by the Dean-Research to enquire into the incident

The director has appealed the RDA to call off the strike in the interest of patient care.

Govt collects Rs 7.41 lakh cr from GST in FY18

The government mobilised Rs 7.41 lakh crore from the Goods and Services Tax (GST) during 2017-18, according to the finance ministry. The government rolled out the GST regime from July 1 last year.

"During the year 2017-18, total revenue collections under GST in the period between August 2017 and March 2018 has been Rs 7.19 lakh crore. Including the collection of July, 2017, the total GST collections during the 2017-18 stands provisionally at Rs. 7.41 lakh crore," the Finance Ministry said in a tweet.
"This includes Rs 1.19 lakh crore

"This includes Rs 1.19 lakh crore of CGST, Rs.1.72 lakh crore of SGST, and Rs 3.66 lakh crore of IGST (including Rs 1.73 lakh crore on imports) and Rs 62,021 crore of cess (including Rs 5,702 crore on imports)," it said.

Technology moving faster than the law: cybercrime expert

Technology is moving "much faster" than the law, making it necessary to understand why cybercrime happens and who are the people behind it, says a global expert, warning that everyone is at risk of becoming a target.

According to Dr Vasileios Karagiannopoulos, Senior Lecturer of Law and Cybercrime at the University of Portsmouth, it has become important for people to know how to protect themselves from cybercrime, particularly in light of the recent Cambridge Analytica controversy. His comment comes amid growing concern about online privacy in India, after Facebook recently admitted that data of over 5.6 lakh Indian users was harvested by an app that shared its records with UK-based analytics and consulting company Cambridge Analytica.

"We have developed quite a few laws, but technology has a way of bypassing law. So the pattern has been to constantly to bring new laws to regulate technology, instead of regulating behaviour," Karagiannopoulos told PTI.

"This is what makes it necessary for students to understand why cybercrime happens, and who are the people behind cybercrime," he said. Hoping to equip the new generation with the skills to fight the global rise of cybercrime, Karagiannopoulos has launched a new graduate level course in Criminology and Cybercrime at the University of Portsmouth.

"Both the young and the older generation, along with small organisations and businesses, don't really know how to protect themselves. But everyone is at risk of being targets of cybercrime," said Karagiannopoulos.

His concerns were shared by another expert, Sandeep Mittal, joint secretary of Parliament Security, who cautioned that constantly sharing travel plans, locations and photos of our homes on platforms like Facebook makes us easy targets for circlined.

"We are our own enemies when it comes to social media," Mittal said at a panel discussion on 'Human and Social Dimensions of Cybersecurity here last week.

He added that it was important for people to know how to keep their private family lives separate from their professional lives.

"Is there need to 'check-in' every time we go to the airport?" he asked, referring to a popular feature on Facebook that allows users to easily share their current location.

The internet, he added, is being used to commit serious crimes like drug trafficking. The discussion was followed by the signing of a

Memorandum of Understanding (MoU) between the University of Portsmouth in the UK and the Raksha Shakti University in Guiarat

The MoU aims to exchange knowledge on how India and the UK are dealing with cybercrime.

These include the lack of admissibility

These include the lack of admissibility of digital evidence in courts, the sale of cheap, unregulated off-the-shelf products that could have malicious codes, as well as low reporting of such crimes due to the lack of confidence of the general public in the police force.

The anonymity and the sheer reach of internet across the world makes it difficult for law enforcers to nab the criminals, the experts said.
