Bomb threats:

Two hand grenade found at 2 brick field with extortion notes



Unknown miscreants today placed hand grenades at two different brick fields located at two different places of Thoubal district under Khongjom Police Station. Knongjom Police Station. Extortion notes with written notes demanding monetary demand were also placed along with the hand grenades. Police bomb disposal squads

Police bomb disposal squads safely detonated the two bombs at a nearby field popularly known as Khongjom Sabal Leikai. The two brick fields where

the bomb were placed are YMC (Yumnam Construction) located at the

road side in between Khongjom to Phundrei Village road and Arbindro Brick Field located near

Khongjom Kheba Ching.
The hand grenade at YMC was found by the labourers at around 7 am today morning. The owner of the brick field is identified as Yumnam Choaba also known as AE Chaoba from Thoubal Athokpam Makha Leikai.

The other hand grenade at Arbindro brick field was found at around 8 am today. The owner of the brick field is identified as Sapam Arbindro from Sapam Mamng Leikai in Thoubal district

According to report from both the brick field, both the

owners had received extortion threats from armed group PREPAK (Nongdrenkhomba). The source added that the outfit had demanded a sum of Rs. 2 lakhs from YMC brick farm while it demands some monetary help to the AS Brick field.

Meanwhile, workers of both the brick field staged a sitin-protest in front of the brick fields. The workers condemn placing of bomb at the work place as it would result injury to the workers if blasted.

On the other hand one old bomb was also found at Sora village under Kakching district while digging drains using excavator at around 11 am today.

I&B ministry withdraws circular on fake news after Modi intervention

Information and Broadcasting Information and Broadcasting Ministry had withdrawn the punitive measures for checking fake news announced earlier as per intevention by the Prime Minister yesterday. The withdrawal however wasn't an entirely celebratory mood among the journalist

mood among the journalist fraternity across the country. The measures, contained in a press release, "Guidelines for accreditation of journalists amended to regulate fake news", caused widespread outrage among media organizations and were withdrawn after Prime Minister Narendra Modi's intervention.

The press release said that any complaint on fake news would be referred to the Press Council of India for print media and the News Broadcasters Association for electronic media. If confirmed as fake, the accreditation of the journalist shall be suspended for a period of six months for a first offence, a vear if it's the second offence and permanently after the third.

JFA bats for MCI to deal with fake news menace

Journalists' Forum Assam (JFA), while reacting to the recent debates over government initiatives to curb the menace of fake news in various media outlets, advocates for empowering the Press Council of India (PCI) comprising the print, electronic and alternate/social media and also renaming the quasi-judicial body as Media Council of India (MCI).

It may be noted that the information and broadcasting ministry lately declared that the accreditation of a journalist might be cancelled

if (s)he was found spreading fake news. However, Prime Minister Narendra Modi directed the ministry to withdraw the harsh guidelines and commented that the matter should be addressed by the PCI

According to the I&B ministry guidelines, the complaint of intentional false news published in newspapers were scheduled forreferring to the PCI, where as in case of television news

it was directed to be referred to

It was directed to be reterred to the News Broadcasters Association (NBA). "As there was no mention of alternate or social media in the I&B ministry order, which is

otherwise aggressively engulfing the Indian public domain, we urge the government to go for an empowered MCI to deal with the new found menace in a comprehensive manner," said a statement issued by JFA president Rupam Barua and secretary Nava Thakuria. The scribe's forum, in another

The stalemate continued in Parliament today, as both the Houses witnessed adjournments, following Opposition protests on different issues including the nation-wide agitation by Dalits. The Rajya Sabha was adjourned till 2 PM, and the Lok Sabha till noon.

In the Rajya Sabha, members belonging to AIADMK, DMK, Telugu Desam, Congress and other parties forced the adjournment after trooping into the well raising slogans. Chairman M Venkaiah Naidu adjourned the House immediately after

administering the oath to 12 of being anti-Dalits, saying newly elected members. of being anti-Dalits, saying that during its long regime,

Expressing grave concern over the repeated disturbances, Mr Naidu appealed to the members to allow the House to take up some of the important bills including the Prevention of Corruption (Amendment Bill) in the next two days before adjourning sine die

Despite repeated appeals by the Chair, the agitating members continued to raise slogans displaying placards in support of their demands leading to the adjournment. Amidst noisy scenes, Minister of State for Parliamentary Affairs Vijay Goel accused the Congress the party had not taken steps for the welfare of Dalits.
