GPRN/NSCN-IM condemn raiding of its Steering Committee member by AR

IT News Imphal, Aug 11,

The Government of the People's Republic of Nagalim has expressed strong resentment over the act of the 32nd Assam Rifles personnel that raided the residence of Mr. Kishore Jeedung, Member, Steering Committee at Dhansiripar, Dimapur

A statement by the MIP of the GPRN/NSCN-IM said that about 20-30 persons came wearing mask and without insignia deliberately violating the Cease Fire Ground Rules (CFGR) on 09/08/2018 at around 6.40 PM.

"The intruders forcefully made him to sign a NOC which stated that the intruders returned from his house without conducting any form of intrusion or raid at his residence. However, right after he signed the paper, the intruders unleashed their real motive to raid and abuse (physically and verbally) his family", the statement said. The NSCN-IM also alleged that the intruder tried to loot the family's possession, but could only seize his Identity Card. The ordeal lasted for more than one and half hour until the Cease Fire Monitoring Cell (CFMC) intervened

" The unfortunate incident was witnessed by the Village Gaon Bura and village elders. Despite the Cease Fire agreement which came into effect from August, 1997 and the same reinstated reinforcement (the CFGR 13/06/2018 at Chumukedima) to observe in letter and spirit the mutually agreed Cease Fire Ground Rules keeping in mind the Framework Agreement that was signed and for the safe landing of the Indo-Naga political settlement, the repeated Assam Rifles offensive against NSCN members is highly condemned, and at the same time warned of any

possible confrontation.
"The GPRN with regard to another incident of unprovoked firing by the Indian Army at New

Ngaolong village in Peren district on August 8, 2018 where a jawan of the 6 Sector Assam Rifles sustained injury, it is made clear that the NSCN has no intention of creating unwanted situation at this crucial hour. Rather, the GPRN expect the Indian Army to reciprocate the NSCN gesture of respecting the mutually agreed Cease Fire Ground Rules. The violation from the Indian Army led to the injury of the

Under this scheme the Merger Agreement' drive was brought out to be entered into with the rulers. Bodhachandra Singh Maharaja was one of the few rulers including the Nizam of Hyderabad and the Maharaia of Jammu and Kashmir, who refused to sign the agreement. However he was coaxed and compelled to sign the Manipur Merger Agreement through threat and coercion by the then Governor of Assam Prakash, who summoned the Maharaja to Shillong. The agreement was signed on 21s of September 1949 by Bodhachandra Maharaja of Manipur and the Governor of Assam, Shri Prakash and V.P. Menon, Secretary to the States Department, Govt. of India were the witnesses.

Main points of Manipur Merger Agreement: The Maharaja ceded to the Dominion Government all his administrative powers and he would retain the powers over the religion, customs and usages etc. The Dominion Government guaranteed Bodhachandra Singh to enjoy the title of Maharaja a privy purse of three lakh rupees annually and succession to the gaddi according to the law of primogeniture and custom. The administrative powers of the state were vested with the Dominion Government and would be exercised by an administrator to be appointed by the Government of India. 15th October 1949.

The Manipur Merger Agreement came into effect on the 15th October 1949. The Mergei then Dewan of Manipur, Major General Rawal Amar Singh announced the merger of Manipur with India on that day at a ceremonial function held at the 4th Assam Rifles Ground. Rawal Amar Singh also became the first Chief Commissioner of Manipur. He was assisted by an advisory Board whose members were nominated by him along with the merger of Manipur with India not only the administrative powers of the Maharaja, who was a constitutional monarch were divested but the popularly elected Assembly and Council of Ministers also stood abolished with immediate effect, according to with the provision of the Central Govt. known as the Manipur Order 1949. The Maharaja was neither allowed to consult the Council of Ministers nor refer the matter to the popularly elected Assembly on the question of merger. The Merger Agreement also caused the lapse of the Manipur Constitution Act, 1947.

Status of Manipur lowered.

The after effects of merger of Manipur with India also lowered the political and constitutional status of Manipur. It became a Part-C state with a popular Ministry without responsible to an elected Assembly. All key posts of the state, which were enjoyed by the sons of the soil even during 56 year rule of British, were given to non Manipuris. All the democratic institutions were abolished or suppressed. The overall result was popular discontent creation of an atmosphere of public agitation and suspicion of bonafide of nonassist and advise the Chief Commissioner. They were nominated by the Chief Commissioner from Manipur. (concluded.)

Central Silk Board Notifies Recently Developed Races of Silk Worm Seed

Imphal, Aug 11,

Central Silk Board (CSB) has notified recently developed races of silk worm seed of mulberry and Vanya silk for increasing the productivity of cocoons and to increase the income of the farmers engaged in sericulture. Silk worm breeds for specific agro-climatic condition are essential for increasing the

productivity of cocoons. Tropical Tasar Silkworm (BDR-10) race developed by the CSB have 21% more productivity than the traditional Daba breed. Farmers can get upto 52 kg cocoons per 100 disease free layings (dfls). This silkworm breed will help the tribal farmers of Jharkhand, Chattishgarh, Odisha, West Bengal, Andhra Pradesh,

Maharastra, Madhya Pradesh, Bihar, Telangana and Uttar Pradesh.

Multivoltine x Bivoltine Mulberry hybrid (PM x FC2) race of silkworm can produce 60 kg per 100 Dfls and the race is better than earlier race PM x CSR. Due to high quality silk and significant egg recovery, this race is suitable for the farmers of Karnataka, Andhra Pradesh, Tamil Nadu, Telangana and Maharastra. Eri Silkworm (C2) race has been found better than local breed and it can produce 247 numbers of Eri cocoons per 100 Dfls. This race is suitable for the farmers in Arunachal Pradesh, Assam, Bihar, Maharastra, Madhya Pradesh, Manipur, Meghalaya, Mizoram, Nagaland, Odisha, Sikkim, Uttar Pradesh, Uttarakhand and West

Cabinet approves continuation of Pradhan Mantri Gram Sadak Yojana beyond 12th Five Year Plan period

The Cabinet Committee on Economic Affairs, chaired by the Prime Minister Shri Narendra Modi has given its approval for continuation of Pradhan Mantri Gram Sadak Yojana (PMGSY) beyond 12th

Five Year Plan period. It will help in connecting 38,412 habitations at an estimated cost of Rs. 84,934 crore (Central Share is 54,900 crore and State share is 30,034 crore). The fund sharing pattern will be same. Habitation (population 250+)

would be covered by March,

2019. PMGSY-II and LWE blocks (100-249 population) would be covered by March 2020. Initially the targets of PMGSY

were to be achieved by March 2022, however, the sunset date of achievement of PMGSY-I was pre-poned to March, 2019, with enhanced fund allocation and changed funding pattern i.e. in the ratio of 60:40 between the Centre and State for all States except for 8 North Eastern and 3 Himalayan States (Jammu & Kashmir, Himachal Pradesh & Uttarakhand) for which it is 90:10. The Task of connecting 1,78,184 eligible unconnected habitations under PMGSY on its way towards completion by March, 2019. So far, 95% habitations (1,69,415) have been sanctioned, of which 91% habitations (1,54,257) have been connected including 16,380 habitations connected by the States from their own resources. Against the sanctioned length of 6,58,143 km, 5,50,601 km road length has been completed. Under, PMGSY-II, against the target length of 50,000 km works of upgradation almost 32,100 km road length have 32,100 km road length have been sanctioned in 13 States, which have transited to PMGS Y-II. Against the sanctions issued, 12,000 km road length has been completed up to March, 2018.
