Manipur's Independence Day celebrated

Leishemba Sanajaoba demands pre-merger status for Manipur

Titular King of Manipur, Leishemba Sanajaoba has demanded pre-merger political status of Manipur, while speaking on the 72nd Manipur's Independence Day celebration at Sanakonung. here in Imphal today. The Independence Day

celebration was organized by Coalition for Indigenes Rights Campaign (CIRCA) under the theme - 'Why pre-merger status for Manipur' with the motto-"Celebrate The Spirit Of Freedom"

Addressing the large gathering, Titular King Leishemba Sanajaoba said that Kangleipak (now known as Manipur) was once a sovereign state. But after it was annexed to Indian Union post-independence the freedom of the people and governance was systematically subjugated.

Further, Leishamba said, due

to selfish ploy of some leaders, Manipur was merged into Indian Union in 1947. Following which, a separatist movement existed since 1952. He also said that the celebration of Manipur Independence Day is not anti-national nor against the nation, but it is against the ill-treatment of Indian treatment of Indian government towards the land and people of Manipur; it is to earn self- respect and dignity as paid by British to then independent Manipur. The titular king also appealed the government of Manipur to review the Instrument of Accession-1947 and grant a special status for Manipur to endow larger authority and rights for self-empowerment of the state governance as well

being affecting the state. As part of the celebration, the titular king hoisted a red flag decorated with the image of decorated with the image of Pakhangba (Meitei deity) in gold at the centre in the Sana Konung which was also hosted in the history by the Late King of Manipur Meidingu Bodhchandra Singh

"Socialist Students' Union of Manipur (SSUM) expressed strong condemnation to the s attack on Umar Khalid of JNU terming it as State Sponsored heinous attack. A statement by Bhushan Longjam, General Secy. of SSUM said that the attack is another assassination attempt to kill Democratic voice who are strongly criticizing Hindutva hatred politics and Hindutva Ruling Government

"Let us stand not only with Com. Umar but also against such coward attempts to attack the people who stand for Justice and truth".

The statement said that Comrade Umar Khalid was attending a meeting at Constitution Club, against Lynchings that are happening after BJP came nappening after BJP came into power. While he was having tea outside the Constitution Club gate, suddenly someone from behind held Umar and tried to aim the gun at him. He tried to push away. Meanwhile, other comrades Khalid Saifi, Shariq Hussain and Banojyotsana Lahiri tried to overpower him, he escaped and Shariq chased him. While running away, the gunman turned around and fired but fortunately Shariq was not

hurt. The gunman left the gun on the road and escaped. Only a few months back, Ravi Pujari, the infamous 'underworld gangster' had also issued death threats to Umar and when the Govt. was approached and demanded police protection, the police and the government have purposely put the matter on backburner and gave encouragement to the terrorists who are after Comrade Umar Khalid's life, the statement alleged.

300 army officers to move to SC praying for protection of their fundamental rights

Imphal, Aug 14.

Over 300 Army officers are filing a petition to the highest court of the country challenging legal action against on duty army officers. This comes against the backdrop of cases regarding the actions of on-duty Army officers coming under the scrutiny of internal security agencies and the judiciary, around three-hundred serving officers of the Army, in their personal capacities particularly in the state of Manipur and Jammu and personal

Kashmir. Republic TV report says that the petition will be filled on Tuesday seeking protection of their fundamental rights.

The officers are to file a writ petition in the country's apex court asking a number of questions, among which are, 'Can the discretion of a soldier be put under legal scrutiny?' and 'Can anything be above national security?' On August 2, an Army officer



was booked by the CBI in relation to an alleged fake-encounter in Manipur. The central agency was conducting its probe on the orders of the Supreme Court, and the case, which relates to a 2009 incident, had been registered under murderrelated sections of the Indian Penal Code. The incident had been termed a fake encounter

the SC-appointed commission. Earlier, in July 2017, the Supreme Court had entrusted the CBI with over 40 cases of alleged extrajudicial killings. Meanwhile, in Jammu and

Kashmir, an FIR had been filed by the police under sections 302 (murder) and 307 (attempt to murder) of the IPC against Major Aditya and his unit of the 10 Garhwal Rifles over the the 10 Garhwal Rifles over the Shopian Firing incident of January 27 when three civilians were killed after Army personnel fired at a stone-pellting 200-strong mob of protestors in J&K's Shopian district. The Supreme Court is currently hearing the plea of Major Aditya's father, Lt Col Karamveer Singh, seeking to quash the FIR against his son. Lt Col Singh had said in his petition that Major Aditya was "wrongly and arbitrarily" named in the FIR as the incident relates to an Army convoy that was on bonafide military duty in an area under AFSPA.
