The package includes the following, among others, common heart conditions and treatment modalities: Heart Attack, Heart Failure, Heart Valve Diseases, Birth Heart Defects, Palpitation, Pacemaker Implant Operation, Palpitation, Coronary Angioplasty with Stent, any Open Heart

Surgery, Surgical Closure of Holes in the heart, Heart Valve Replacement Operation (Single/Double), Coronary Bypass Surgery (CABG), Device Closure of various holes in the heart, Balloon Dilatation of blocked heart valves, RF Ablation for various palpitation (PSVT VT) etc.

Mumbai: Four dead. 14 injured in fire at Crystal Tower in Parel

At least four people were killed and 14 injured in a level-3 fire that broke out in Crystal Tower near Hindmata Cinema in Parel area around 8 am on Wednesday. At least 20 firefighting tenders were rushed to the spot.

The rescue operations were completed and the fire was doused after two hours. At least 25 people were rescued from the Crystal Tower and 16 people were taken to KEM hospital, of which 2 were brought dead; I was a senior citizen. An officer from fire department said, "The electrical wiring in the duct

area of the building caused the fire to start on the 12th floor. There were fire extinguishers but they were not operational. Because of the smoke and heat on the 12th floor, the people on upper floors were also trapped. The building is declared unsafe and power and water supply is stopped now The evacuation process is completed. A thorough investigation will be conducted into the incident." The fire broke out on the 12th floor of the residential tower. People trapped in the staircase area due to smoke were rescued using a crane The cause of the fire is still

India to decline all foreign help to rebuild Kerala, will focus on domestic effort

Soon after flood-hit Kerala's Chief Minister Pinarayi Vijayan on Tuesday announced that the United Arab Emirates (UAE) has promised an assistance of USD 100 million (about Rs 700 crore) for the state's reconstruction, sources said the Central government has decided to decline all offers of financial help from foreign countries. Vijayan, who chaired a meeting

of the state Cabinet to seek a Rs 2,600 crore special package from the NDA government under Centrally-sponsored schemes and called a special meeting of the state Assembly on August 30 to discuss the flood situation, said, "Sheikh Mohammed Bin Zayed Al Nahvan, the Crown Prince of Abu Dhabi, called up Prime Minister Narendra Modi and made the offer for assistance Sources in New Delhi said that the NDA government has "taken a considered decision to rely solely on domestic efforts to tide over the

challenges". Kerala has struggled to find its feet after the devastating deluge that left 223 dead in a fortnight. About 10.78 lakh people, including 2.12 lakh women and one lakh children under 12, have been displaced and sheltered in 3,200 relief

camps.
On Monday, the Union home ministry declared Kerala floods, the worst in 100 years, a "calamity of severe nature". This tag paves the way for higher Central assistance to the state.

The chief minister had earlier estimated the damage to be about Rs 20,000 crore and so far the Centre has, in phases, announced interim assistance of Rs 680 crore for the state. On the Union government's decision not to accept offers of financial help from foreign countries sources said that New Delhi wants to convey that the country is capable of handling the flood situation on its own both, financially and logistically. According to some reports, even the previous UPA-2 government had declined foreign aid in 2013 when floods struck Uttarakhand.

The Modi-government has apparently also communicated to all embassies its position on not accepting foreign financial help for Kerala tragedy. In a message to Indian missions, the government said, "If a foreign government makes an offer of help, you may kindly express your appreciation for the sincere sentiments and willingness to

Earlier, Vijayan told reporters that Kerala would ask the Centre to hike the limit of loan it can secure from the open market for the massive arrangement, Kerala can obtain three per cent of its gross state domestic product (GSDP) as loans and wants the limit to be raised to 4.5 per cent so the state can mobilise an additional Rs 10,500 crore from the open market, he said. With rains easing and water receding in some areas of flood-ravaged Kerala, people started returning to their homes as Union minister KJ Alphons appealed for cooked food and skilled workers to rehabilitate the displaced

respite from the rain in the last two days, the water level has not come down in several areas of the Ernakulam. Thrissur, Pathanamthitta, Alappuzha and Kollam districts, officials said State government officials and defence forces said rescue efforts will continue till the last person is brought to safety. As the state drowned in unprecedented misery, the Muslim festival of Id-ul-Adha

on Wednesday is expected to be low key. State government events to mark the Onam festival on August 25 have also been cancelled.

Road and rail services have resumed in most parts of the state but clearing houses of the debris washed up by surging flood water is a daunting task. The state government is also

preparing a comprehensive health action programme to prevent outbreak of waterborne diseases.

The Southern Air Command has said the Indian Air Force (IAF) said it will continue all out efforts in coordination with the civil administration to ensure that the people of the Kerala recover quickly from

the calamity.

Individual parents needn't be given right Boost Sri Lanka's to challenge fee hike, says HC

Individual parents need not be given the right to challenge fee hike by a school when the Parents Parents Teachers Association's Executive Committee has a right to do so. the Bombay High Court has

A division bench of Justices SC Dharmadhikari and Bharati Dangre, observed that the provisions allowing both PTA EC and the management the right to go to second level appeal, while only the management to go for first level appeal, were adequate. The first level appeal is before the Division/District Regulation Committee and the second level appeal is before the Revision Committee. The court was hearing a petition filed by one Khed Taluka Vidyarthi Palak Sangh, seeking

The bench, owever, observed that a PTA's EC, as provided in the law, was different from the management, and, would also include parents apart from teachers and the principal/headmaster of the school. it does. It's only when the difference is more than 15 per cent that the management has the right to approach the divisional/district fee regulation committee.

Japan has pledged to help strengthen Sri Lanka's maritime security, authorities said Tuesday, in a new sign of efforts to counter China's strategic grip on the Indian Ocean island.

President Maithripala Sirisena thanked Japan's Defence Minister Itsunori Onodera for donating two coast guard patrol craft costing over \$11 million in total, his office said in a statement after talks in Colombo.

'Attention has been drawn to further strengthening maritime security cooperation between Japan and Sri Lanka," the statement said. The visit came a week after the US State Department gave \$39 million to strengthen the island's naval capabilities.
