Stop targeting Human Rights and Environment Defenders- YFPHR

Youths Forum for Protection of Human Rights (YFPHR) has expressed strong opposition to the continuous threat to the human rights and environment defenders in the state committed by the state's armed forces.

As we learn that on the 13th of August, around six Manipur or August, around six Manipui police commando personnel came in a gypsy at Mr. Jiten Yumnam residence at Kwakeithel Mayaikoibi Ninthoujam Leikai around 2:30 pm and summoned him at Manipur Police Commando complex at the time when he was visiting Sikkim for

environment programme. No written document and reasons were furnished to his family by the police personnel for his summon to the Commando It further said that the visit by the armed forces of the state in full uniform to a civilian's residence creates an residence creates an environment of anxiety and fear among the family members, especially the children and also creates negative impression towards the locality. It could also be noted that on

the 12th of August, 2017, two person who identified themselves as CRPF of Group Centre Langjing visited the house of the President of

YFPHR asking about his whereabouts providing any reasons.

Such continuous threat to the Human Rights Environment Defenders is believed to have been carried out systematically by the state to suppress the people's voice against the brutalities and inhumane treatment committed by the state to the public, the Youth Forum said. The forum appealed the government of Manipur to respect the UN declaration of the Rights of Human Rights Defenders, 2008 and to stop targeting the Human Rights and Environment Defenders immediately.

Hyderabad: Modi 'assassination plot' By Priyanka Courtesy: Siasat Daily Hydrabad, Aug 28,

Maoist ideologue and revolutionary writer P Varavara Rao was arrested on Tuesday by Pune Police in Hyderabad on charges of being part of a plot to assassinate Prime Minister Narendra Modi, sources close to his family said.

The arrest was preceded by searches for nearly eight hours at Rao's house in Gandhi Nagar and those of seven others, including two journalists close to him and a professor at English and Foreign Languages University (EFLU), in different parts of

Kranthi, was also arrested after police reportedly seized his laptop and several documents allegedly showing his connections with the Maoist

party. The 78-year old Rao was first taken to Gandhi Hospital in Secunderabad amidst tight security for a medical examination. He is likely to be taken to Pune after being produced in a local court in (POW) president P Sandhya

P Vara Vara Rao arrested from

Hyderabad later in the evening.

Tension prevailed at Rao's house, where a large number of his followers and representatives of various social organisations assembled with placards

condemning his arrest.
"It is highly atrocious on the part of the Maharashtra police to arrest Vara Vara Rao on false grounds. How can an ordinary person sitting in Hyderabad plot to kill the Prime Minister? They are fabricating the case against him," Progressive Organisation of Women

Pune Police told a local court on June 8 this year that they had found a letter from the Delhi residence of a Maoist sympathiser Rona Jacob Wilson, one of the five people arrested for their alleged links with the banned Maoist party The letter reportedly mentioned the requirement of Rs 8 crore to purchase M-4 rifle and four lakh rounds. It also discussed the possibility of "another Rajiv Gandhi incident".

The letter also mentioned that Rao and Surendra Gadling, an advocate who was also

the revolutionaries in carrying out successful attacks in the past. The letter mentioned that Rao "had arranged for funds for the same (for another sensational attack) and Surendra would provide you with the fund." Apart from Wilson and Gadling, Pune Police also arrested three others – Sudhir Dhawale from Mumbai and Shoma Sen and Mahesh Raut from Nagpur.

However, Rao told media on the same day that he had nothing to do with the socalled "incriminating letter", which quoted his name as being involved in a plot to assassinate Prime Minister Modi. Rao, however, admitted he knew Gadling and Wilson. "I don't deny that I know the people who were arrested by the Pune Police. They have all been working for the downtrodden and release of political prisoners. They are all against murder politics," he had said, adding that he did not believe Maoists had the

TSA refutes HTC. Moreh media statement regarding July 13 Moreh terror attack

The Thadou Students' Association (TSA) has appealed the Hill Tribal Council (HTC), Moreh not to try and obstruct the process of justice over the July 13 Moreh incident of shooting and bombing of innocent children and civilians, including the president of TSA Moreh Block, Thongminglun Haokip, his pregnant wife and their two children below the age of five years by heavily armed cadres of the Kuki National Organisation/Kuki national Army (KNO/KNA). In a statement the TSA express strong condemnation to the the president of HTC, Ginkhosei Lhungdim, for threatening Littingdim, for infraetening TSA leaders(s) over phone to withdraw the Public Interest Litigation (PIL). TSA has already lodged with the Manipur High Court on August 16, 2018 in connection with the July 13 Moreh attack. If Ginsei or any other persons or groups threaten any of the TSA leaders again, TSA will no longer hesitate to file an FIR or

take them to Court

The media release of HTC, Moreh that appeared in various newspapers on August 28, 2018 in connection with the July 13 Moreh attack was nothing but merely a desperate attempt to cover up the evil and criminal act of the KNO/KNA and to mislead the public and the Court. TSA has previously clarified through the media that the attack was an unprovoked firing and bombing by the KNO/KNA to murder innocent children and civilians and that it was not a gun fight between

two armed groups.
"TSA has also previously clarified through the media on July 30 that TSA's demands for justice in the July 13 Moreh terror attack have nothing to do with the relation between two underground groups, the UKLF and KNA, and that neither TSA nor Thingminlun had no knowledge nor involvement in the peace commission or peace banquet at Moreh on July 23 between the two groups. If HTC negates this then it should come out with proper evidence instead

of making baseless and false propaganda to downplay the seriousness of the terror attack and to hide the truth", the

no longer have confidence in State police to bring justice in the incident and therefore we prayed to the Court that the case be handed over either to National Investigation Agency or Central Bureau of Investigation to ensure the case is investigated in the most free and unbiased manner and justice is delivered in a timely and effective manner", the statement added.

As the supreme commander of KNO/KNA which has claimed responsibility for the attack PS Haokip, the president of KNO has been included as one of the respondents in the PIL writ petition along with his associates, including Thahpi Haokip alias Thangboi alias Thahpi, Moreh commander of KNO/ KNA and the alleged leader of the attack team in the July 13 Moreh terror attack, added.

Manihar Singh, Joint Director, Health Services, Govt. Of Manipur and W. Ibohal Singh, Retd. District Youth Coordinator, Nehru Yuva Kendra Sangathan were the Chief Guest and President respectively.

Ch. Basanta Singh, District Programme Manager, District Health Society Thoubal welcomed all the participating ASHAs, Anganwadi Workers and Youth club leaders. He



also highlighted about the importance of organising the programme. He stated that the programme was organised for the 5th time in Thoubal District during this month Similar programmes were organised at Tekcham, Lilong, Thoubal Kiyam and Heirok villages of Thoubal district.

Dr. M.A. Sattar, ENT Specialist Resource Person of the day explained about the prevention and control of deafness to the public during the Awareness Campaign. He stated that hearing loss can be caused by aging, illness or disease, by excessive exposure to high noise levels and by trauma. Hearing loss is of mild, moderate and severe. He also says that

W. Ibohal Singh, Retd. District Youth Coordinator cautioned the present day youth who frequently used Loud Speakers and ear phones the fearness of hearing loss. He also expressed about the need for general awareness for using Loud Speakers and other noise who pollute the environment as well as increase of deafness in general public. Dr. T. Manihar Singh, State Nodal Officer, NPPCD, State

Health Society, Manipur explained about the hearing loss in children. He says that a newborn can suffer from hearing loss. It happens because of heredity, rubella or because of heredity, rubella or other infections in the pregnant mother, low birth weight of body, severe jaundice following birth or other illness such as maninglitis etc. He appealed the participants to spread the awareness about the control of deafness. He says that there is hearing test facility at JNIMS. hearing test facility at JNIMS and RIMS so hearing test for new born child should be done before they are discharged.
