The United Committee Manipur (UCM), All Manipur United (UCM), All Manipur United Club Organisation (AMUCO) and the Committee of Civil Society Kangleipak (CCSK) have been opposing any form of division among the people or land of the state while solving the issues of NSCN-IM.
