Rajasthan polls: Congress, BJP to slug it out for ten seats in Gehlot's home turf

As poll campaign gains momentum in Rajasthan, former chief minister Ashok Gehlot's home turf Jodhpur is bracing for an interesting fight with the Congress putting all its efforts on 10 seats of the district, of which the BJP had swept nine in the last assembly elections in 2013

The Congress has given tickets to eight new candidates, while retaining Gehlot from Sardarpura and Hira Ram from the Bilada constituency.
On the other side, BJP has

repeated all its sitting legislators in the nine seats it had won last time. On the one seat the saffron party lost last time, Gehlot's Sardarpura, the party has again fielded the candiate who had fought against the Congress heavyweight five years

ago. BJP has pitted Shambu Singh Khetasar opposite Gehlot, who was defeated in the 2013 election by 18,478 votes. Khetasar is the chairman of the State Seed Corporation and enjoys a ministerial status in the current BJP

government.
"Sardarpura is a strong bastion of Gehlot. He has

been elected from this seat consecutively since 1998," Congress Congress on Ajay spokesperson Trivedi said.

"In the last four assembly elections, the BJP had changed its faces to defeat Gehlot, but none of them has been able to snatch Sardarpura from the Congress," he added. The BJP candidate, however, exuded confidence of winning the

"Gehlot has an upper hand due to a caste-based vote bank. There is no other basis. Public sentiments are not with the Congress. Gehlot has neglected constituency, Khetasar told Agency. Gehlot has, however,

rubbished these

allegations.
"Since Jodhpur is my hometown, it has suffered a step-motherly treatment by the Vasundhara Raje government purposefully deprived Jodhpur from developmental works," he said.

Congress' other candidates for the district's assembly seats include three faces from well-known political families of the state. including some linked to controversies in the past.

Former US president George HW Bush dies

George H W Bush, the 41st president of the US who led America during the collapse of the Soviet Union and the turning back of an Iraqi invasion of Kuwait, died on Friday. He was 94.

His death, which was announced by his office, came less than eight months after that of his wife of 73 years, Barbara Bush.

"Ieb Neil Marvin Doro and I are saddened to announce that after 94 remarkable years, our dear Dad has died," George Bush Jr. who went on to serve as the 43rd US president, said in a statement. He was "a man of the

highest character and the best dad a son or daughter could ask for. The entire Bush family is deeply grateful for 41's life and love, for the compassion of those who have cared and prayed for Dad, and for the condolences of our friends and fellow citizens," Bush Jr added. President Bush was suffering from suffering from Parkinson's disease that forced him to use a wheelchair in recent years, and he had been in and out of hospitals in recent months as his health declined.

There were fears that after his wife. Barbara, died in April, Bush might die, too. He was admitted to a hospital with a blood infection on April 23, one day after the funeral for the former first lady, and remained there for 13

He was hospitalised again in May for low blood pressure and

arriving in Maine to spend the summer. He released a few days later and celebrated his birthday on June 12 -making history by becoming the first former president to reach the age of 94. The decorated war pilot

and former CIA chief was elected president on November 8, 1988. He was sworn in on January 20, 1989, and served until January 20, 1993.

During his term in office, a revolution of human liberty swept the globe. emancipating tens of millions of people and unleashing a series of transformative events: collapse of the Soviet Union and the end of the Cold War; the Berlin Wall "fell", and Germany united within NATO following 45 years of

postwar division. From Eastern Europe to the Baltic States to Latin America to the former Soviet republics, many liberal democracies supplanted totalitarian regimes. During this "historic period of cooperation" as he called it, President Bush worked with Soviet leader Mikhail Gorbachev and other key global figures to end the Cold War peacefully and usher in a new geopolitical era marked by political self-determination, the spread of market capitalism, and the opening of closed economies.

In August of 1990, after Iraqi troops under dictator Saddam Hussein invaded neighbouring Kuwait, President Bush forged an unprecedented coalition of 32 countries to restore Kuwaiti sovereignty and phold international law

He subsequently convened the Madrid Peace Conference in the Fall of 1991, bringing Israel and her Arab neighbours together in face-to-face discussions for the first time in history.

President Bush also drastically reduced the threat of nuclear attack by signing two Strategic Arms Reduction Treaties in 1991 and 1993, and negotiated the North American Free Trade Agreement (NAFTA) in 1992 which President Bill Clinton later signed into

North-east not dumping ground for illegal immigrants: NSF

The Naga Students' Federation (NSF), the apex students' body in Nagaland, has demanded withdrawal of the controversial Citizenship (Amendment) Bill 2016, (Amendment) Bill 2016, saying the north-east cannot be a "dumping ground" for illegal immigrants. The NSF took out a protest rally here Friday to press for the bill's scrapping. "The north-east is not a dumping ground for illegal Bangladeshis," NSF president Kesosul Christopher Ltu said at the rally. The NSF is part of the North East Students' Organisation (NESO), an umbrella organisation of different student unions in the region which is opposed to the citizenship bill. The bill, introduced in Parliament in 2016, seeks to make Hindus, Sikhs, Buddhists, Jains, Parsis and Christians from

Afghanistan, Bangladesh

or Pakistan eligible for Indian citizenship after staying in the country for a period of six years.

Effigies of illegal immigrants and the bill were burnt by the students during the protest rally. Ltu said all the north-

eastern states were facing the problem of illegal immigration from Bangladesh, which posed a threat to the social fabric of the region and the demography of the states. "We have noticed disturbing machinations of the Union government to encourage further illegal immigration from

Bangladesh," he said.
"We will strongly resist the creation of another Tripura in the north-east," Ltu said, urging the Centre to recognise the efforts of the student community to strengthen the nation's secular fabric.

The bill was a threat to the language, culture and identity of the indigenous people of the north-east, he

said, adding that the NESO and the people of the region would not accept it. The NSF had submitted a letter to the Nagaland government in August, urging it to strengthen the state's mechanism to curb the influx of illegal

immigrants.

The state government had then assured the students body that it would come out with an interim report on illegal immigrants within two months, but had not done so till date, Ltu said. NSF general secretary Imtiyapang said the organisation had taken out a similar rally here and also in Dimapur in April, following a call by the NESO demanding the inclusion of Dimapur district under the purview of the Inner Line Permit.

The Inner Line Permit is an official travel document issued by the government to allow inward travel of an Indian citizen into a protected or restricted area for a limited period.

remains very poor for sixth consecutive day: Authorities

Delhi's air quality

Delhi's air quality remained in the "very poor" category for the sixth consecutive day Canarday with the Saturday with the meteorological conditions remaining unfavourable for dispersion of pollutants, authorities

said. According to Central Pollution Control Board (CPCB) data, the overall air quality index (AQI) of Delhi was 322, which fell in the "very poor"

category.
An AQI between 0 and 50 An Aql between 0 and 50 is considered "good", 51 and 100 "satisfactory", 101 and 200 "moderate", 201 and 300 "poor", 301 and 400 "very poor" and 401 and 500 is considered

to be "severe". The CPCB said in 27 areas of the national capital, the air quality was in the "very poor" category, while in five areas, it was recorded in the "poor"

PM2.5 particulate matter in the air with a diameter of less than 2.5 micrometre) level was recorded at 155 and the PM10 level at 310, it added. Ghaziabad, Faridabad and

Noida in the National Nota in the National Capital Region (NCR) recorded a "very poor" air quality while Gurgaon recorded a "poor" air quality, the CPCB data

Delhi's air quality has been in the "very poor" category for the past one week with several areas recording a "severe" air quality, the authorities

According to the Centrerun System of Air Quality and Weather Forecasting (SAFAR), the air quality is likely to remain in the same category with a slight decline in the pollution levels by Sunday due to an enhanced wind speed.

"However, it (AQI)) is likely to increase thereafter for the next two days to register in the upper range of the 'very poor' level. This deteriorating AQI on December 2-3 would mainly be due to expected adverse meteorological conditions and a decline in the wind speed. The contribution of long-range dust or stubble biomass is negligible," it said.

Andhra Pradesh-Centre Rift Widens as CBI Sees Red Over Stalled Consent. Info Leak in Officer's Arrest

The stand-off between the Central Bureau of Investigation (CBI) and the Andhra Pradesh government took a turn for the worse late on Friday night, with the probe agency accusing the latter of not allowing it to set a trap for a union government official accused in a bribery case. The CBI said the state's anti-corruption bureau (ACB) instead surreptitiously used the information it had provided to arrest the employee. Sources said the CBI had

received a written complaint from K Lokesh Babu on November 28, accusing a Central Board accusing a Central Board
of Indirect Taxes and
Customs (CBIC)
superintendent of
demanding a bribe of Rs
35,000.The official, MK Ramneswar, had allegedly demanded the money for not raising objections in the CGST returns filed by the complainant's firm.
The central agency wrote a 'secret' letter addressed

to the principal secretary (Home), Andhra Pradesh government, on the same day and sent it by hand through a deputy superintendent of the CBI. In the letter, it was requested to issue specific consent to the agency to lay a trap in the case, while also seeking that the information be kept confidential, sources

said. The next day, the s u p e r i n t e n d e n t personally called on the principal secretary and requested for early action in issuing the consent under Section 6 of the Delhi Special Police Establishment Act. The step was crucial to

register a case and also lay a trap as the Chandrababu Naidu government had withdrawn the General Consent given to the CBI on November 8, barring the agency from the agency from conducting probes or raids without permission. After there was no response from the state government, another letter was sent to the principal secretary with a copy marked to the chief

secretary from the CBI's Head of Zone on November 30. The letter requested for immediate issuance of specific consent. However, the Andhra

Pradesh government, instead of issuing the consent, shared the case details with state Anti-corruption Bureau, which then lay a trap to catch the accused, the CBI said.

In a press statement issued late on Friday, the CBI "deeply regretted" the non-cooperation by state home department in the matter. "The state ACB issued a press release as if the complainant has directly approached them. CBI deeply regrets such non-cooperation by the State Home Department in this matter. This will only make the fight against for the anti-corruption agencies and the mutual trust between agencies will be vitiated," read the statement, which emphasised eradication of corruption through cooperation and trust.
