Promising young pugilists surface in preliminaries of Junior National Boxing

TN's Kalarasan forces Harsh to ropes as coach throws in the towel

The fancied boxers in both men and women sections moved up a rung on the opening day of the BFI's second Junior National Boxing National Boxing
Championships with
preliminary rounds
underway at the
University Hall here
yesterday. The day,
which saw as many as 58 bouts in men's six categories and 27 bouts in women's four classes, went along the expected way, interspersed with some one-sided fights some one-stadd rights and some RSC verdicts. The day began with a bout in 46 kg being abandoned in the second round when S. Kalarasan of Tamil Nadu forced Rajasthan's Harsh Chandra Meena's coach to throw in the towel after his ward received solid pounding from the Tamil Nadu pugilist. Kalarasan was severe from the start down and sent down combination punches on his Rajasthan opponent managed withstand the first round. However, the second round proved to be his undoing and his coach judged the gravity of the situation to pull him out of contest before any major damage was

caused With favourites having received byes in both sections sitting pretty awaiting the main draw,



the boxers in preliminary rounds churned out e fantastic verdicts like the one between Daksh Chauhan of Chhattisgarh and Deepak of Chandigarh. local lad was unlucky as he lost the 46 kg bout 2:3 in a neck and neck race, Chauhan clinching it in the last round. Karan Mehar of Uttarakhand received a spilt (3:2) decision when he overcame a tough opponent Lalmuankima from Mizoram

Sarha, who won a RSC-I verdict in the same weight class over Nikhil Bhuiva of Jharkhand. was joined by state mate Vikas later in the day when he defeated Om Prakash senapati of

Odisha on points (5:0) in 50 kg class. From neighbouring Himachal, Diyas Gautam beat Bihar's Karan Kumar in the same category 50 kg with a RSC second round verdict. Manish Rathore of UP and Sanjeet of the Services ended up on the winning side in the 46 kg catgory against their opponents from Gujarat and Odisha, respectively, when the referees stopped contest in the third round.

Shouting 'Ayyappa', Kerala man sets himself ablaze at BJP Sabarimala protest venue

A middle-aged man set himself on fire in front of a BJP protest venue in Thiruvananthapuram in the early hours Thursday morning.

Advertising At around 2 am, the man in question, Venugopalan Nair, 49, poured petrol over his body, set himself ablaze and advanced towards a tent in which BJP leaders and workers were protesting the police restrictions imposed by the ruling LDF government on the premises of the Sabarimala temple.

CK Padmanabhan, one of CK Padmanabnan, one of the senior leaders of the state BJP who has been undertaking a hunger strike on the issue, was present at the venue when the self-immolation attempt took place. BJP workers and locals, who were present at the spot, immediately tried to douse the fire. Nair was taken to the Thiruvananthapuram Medical College with 90 per cent burns and is said

to be extremely critical.

Jijin G Chacko, subinspector of the Cantonment Police Station, said Nair was reportedly shouting 'Ayyappa, Ayyappa' while setting himself on



. At the same time, he said Nair was abandoned by his family, including his two wives and children, and could have taken the extreme step due to personal reasons. The police has initiated an investigation into the

Interpol Arrest Warrant **Against Fugitive** Mehul Choksi On CBI's Request

Agency New Delhi, Dec. 13

Global police body Interpol issued a red corner notice against fugitive offender Mehul Choksi, wanted in the 13,000-crore bank fra case, on Thursday, The Interpol arrest warrant came on a CBI request. The CBI and Enforcement Directorate (ED) had filed a charge sheet against him in a Mumbai court.

Authorities in Antigua are now likely to trace him and inform India. Mr Choksi's movements will be tracked and he won't be allowed to leave the country. The 59-year-old had left India in January for medical treatment in the

Mr Choksi was last traced to Antigua, where he has been granted citizenship. He had taken the oath of allegiance as a citizen of Antigua on January 15 and just days later, or January 29, the CBI filed a case and started investigating M Choksi and Nirav Modi Last month, Mr Choksi's lawyer told the Choksi's lawyer torume investigating agencies that he is not in a position to record his statement. "If his condition gets better" Mr Choksi may return to India, the lawyer had said. In July, the Interpol had issued a similar notice against Nirav Modi, the main accused in the bank fraud cases. Mr Choksi and his

nephew, celebrity jeweller Nirav Modi, are being sought by multiple investigating agencies after it was revealed that the two extracted crores in loans from banks abroad on the basis of fake guarantees in the name of Punjab National Bank, India's second

December 16 gangrape case: SC dismisses plea seeking immediate execution of death row convicts

The Supreme Court Thursday dismissed a Public Interest Litigation (PIL) seeking direction on the immediate execution of four death row convicts in the December 16 gangrape and murder case

A bench comprising Justices Madan B Lokur and Deepak Gupta asked the petitioner, "What kind of prayer are you making?" It further said, "You are making the court a joke."

The PIL filed by lawer Alakh Alok Srivasatava sought direction from the central government to execute all the four death row convicts within two weeks.

The Supreme Court on July 9, 2018 had upheld its verdict of awarding the death penalty to the convicts in the December 2012 gangrape case and a three-judge bench had rejected the review pleas filed by three- Mukesh (31), Pawan Gupta (24) and Vinay Sharma (25) of the four convicts. The apex court said the death row convicts failed to point out "error apparent on the face of the record' in the judgment.

A paramedical student was gangraped and brutally assaulted by six men in a private bus and thrown out of a moving vehicle along with a friend after which the victim was admitted to a South Delhi hospital. On December 29, the victim succumbed to

SC notice to Devendra Fadnavis for 'not declaring' criminal cases in election affidavit

New Delhi Dec 13, Supreme Court

Thursday issued a notice to Maharashtra Chief Minister Devendra Fadnavis for allegedly concealing criminal cases registered against him in his 2014 election affidavit. The petition filed by social activist and advocate Satish Ukey states that the BJP leader did not detail two pending criminal cases in his affidavit, thereby violating the

provisions Representation of the People's Act 1951. The plea seeks annulment of his election to the Maharashtra Assembly. Advertising

A bench comprising Chief Justice Ranjan Gogoi and Justices S K Kaul and K M Joseph sought response of the chief minister on an appeal filed against a Bombay High Court order. According to Fadnavis' nomination on

myneta.info, Maharshatra CM has a total of 22 criminal cases registered against him.
Some of the charges
against him include
"abetment of such assault, if the assault is committed", "voluntarily causing hurt by dangerous weapons or means", being part of an unlawful assembly, rioting, voluntarily causing hurt and wearing garb or carrying token used by public servant with fraudulent intent"

J&K: Two militants killed in encounter with security forces in Sopore

Delhi Dec 13.

At least two militants were killed Thursday in an encounter with security forces which started at BrathKalan village of North Kashmir's Sopore district Wednesday district Wednesday evening. The encounter is still underway.On Wednesday, security forces launched a cordon and search operation in BrathKalan area following information about the

presence of militants there, a police official said according to PTI. He said the militants opened fire at the security forces, leading to an encounter.

On Tuesday, four Jammu and Kashmir policemen were killed in a militant attack on a police picket in South Kashmir's Shopian district. The attack was a first by militants in the Valley after they suffered several blows in multiple encounters

in South Kashmir, Police officers said that the policemen who were killed were guarding a picket meant for the security of a few Kashmiri pandit families living in Zainapora area of Shopian. Four weapons belonging to the policemen were also taken by the militants after the attack, officials said. The four policemen were identified as Abdul Majeed, Mehraj-ud-din, Anees and Hameed-ul-lah.
