In a major setback to the Mamata Banerjee-led government, the Calcutta High Court on Thursday allowed the West Bengal allowed the West Bengal BJP to hold its proposed rath yatras, which was scheduled to be flagged off by party chief Amit Shah, across the state. The court also directed the administration to ensure that also there is no breach of law and order.Laying down a set of conditions to avoid trouble, the single bench of Justice Tapabrata Chakraborty said the yatras must not cause any inconvenience to the public and must be peaceful in nature. Addressing the media, he said the three medical colleges will be set up at Kokrajhar, Nalbari and Tinsukia in the next three vears Each new medical college with 100 seats for medical education

will have 500-bed capacity, he Assam Chief Minister

Sarbananda Sonowal will lay the foundation stone for the new colleges in January. At present there are six medical colleges in Assam: Gauhati

Medical College, Assam Medical College, Assam Medical College, Silchar Medical College, Tezpur Medical College, Jorhat Medical College and Barpeta Medical College. These six

colleges together have 726 MBBS seats.

Apart from the three proposed colleges, four medical colleges are under construction at Dhubri, Lakhimpur, Nagaon and at Diphu, which will together have 400-student capacity. After completion of all the medical colleges, Assam will have 1,426 seats for medical students, the minister said.

West Bengal Chief Minister Mamata Banerjee has said the issue of opposition prime ministerial candidate could be discussed after the 2019 Lok Sabha polls.

Sabha polls. Her comments came in the backdrop of Dravida Munnetra Kazhagam (DMK) president M K Stalin's proposal to announce Congress chief Rahul Gandhi as the opposition's prime

ministerial candidate. "It could be discussed only after the 2019 Lok Sabha elections, once the opposition alliance emerged winners. All (opposition) parties will meet and decide on the issue. We will accept that," Banerjee said on Wednesday. Asked whether she was one

of the contenders for the job, the Trinamool Congress supremo said, "This is not the time to discuss this issue. And I am not alone. We are

working together. We are solidly together," she said. The TMC earlier said ncing prime ministerial candidate now would be premature would as it would divide the Opposition camp. On reports of the Bahujan Samaj Party (BSP) and the Samajwadi Party (SP) coming together for the 2019 Lok Sabha polls without the Congress, Banerjee said,

"This is very good. It is local compulsion. We appreciate that."
