"Strengthen Manipur State Human Rights Commission'': Justice Shishak

Agency New Delhi, Dec 3,

Mr Justice Shishak former Chief Justice, High Court of Chhattisgarh and former Chairperson, Manipur State Human Rights Commission emphasized the need for appointment of people with honesty, integrity and impeccable character to strengthen the Manipur State Human Rights Commission in order to address human rights violations. Pointing out that Manipur has been neglected for long and has been battling with serious human rights violations, he made a strong plea for treating Manipuris a honourable citizens with dignity for creating a just society. These views were expressed

at a consultation on 'Potential Transitional Justice Framework for Manipur' held on December 1st at New Delhi It was organized by the Centre for Human Rights Studies (CHRS) and the Centre for the Study of Knowledge Systems of Jindal Global Law School (JGLS), O.P. Jindal Global University (JGU).

The consultation analysed the applicability of a suitable transitional justice model with a strong focus on effective transition from conflict to peace and reconciliation in the state of Manipur. Panellists deliberated on factors which lead to the erosion of accountability in relation to human rights violations perpetrated by the security forces and insurgent groups

in the region. In his welcome address, Professor (Dr.) Y.S.R. Murthy, Executive Director, Centre for Human Rights Studies, JGU said, "Torture, disappearances and extra-judicial killings are very serious human rights violations and each such allegation must be thoroughly investigated and justice is prvided to victims or to their next of kin. In this context, the situation of widows and children orphaned by conflict must be fully addressed. Our

Professor (Dr.) Shiv Visvanathan Professor and Vice -Dean, JGLS & Director Centre for the study of knowledge systems, JGU said, "This room has a wider audience and a wider group of human activists who are worried about the Indian democracy. These three activists from Manipur are also storytellers, one talking from the conflict perspective, one looking at human rights, one begins as a victim, becomes a storyteller and an activist for an entire community. So we have these three perspectives, may be three kinds of theories to look at the question of Manipur. We might be tired of Manipur,

but Manipur is not yet tired of Indian democracy." Mr. Babloo Loitongbam, Manipur said, "We have organised the victims together and have filed 1,528 cases in the Supreme Court which is a class in itself. We started this journey six years back in 2012 by filing a PIL in Supreme Court and till now we have not seen any clear indication that for sure justice will be done. We are making good progress

but still seem to be as far from justice as we were when we started in 2012. It is time for us to look at the whole phenomena of this impunity,

promoted by AFSPA, and its effects over a prolonged period of time." Mr. Sanjoy Hazarika, Director, Commonwealth Human Rights Initiative (CHRI) said, "In an environment of impunity and intimidation fostered by archaic laws such as AFSPA, truth-seeking and truth-telling is very difficult as is upholding the rights and the interests of the victims. These laws defy logic and need to go."

According to Mr. Satnam Bains, Director, Punjab Documentation & Advocacy Project (PDAP), "We must learn from the experiences from Punjab, where impunity led to innumerable problems in addressing accountability or even documenting the extrajudicial killings. What the Manipur civil society has done is remarkable but they must be mindful of the challenges that lie ahead in finding out the complete truth.3

The aim of the consultation was to bring together participants, such as the victim families, academics, NGOs, journalists, researchers, in order to inform the deliberations regarding peace, justice, conflicts and reconciliation issues. The consultation concluded with an agreed roadmap to work on a potential transitional justice framework, in relation to Manipur.

Sessions were split into three parts that emphasised on the broader processes that need to be activated for effective transition to peace in Manipur. The first being 'Current situation in Manipur, taking stock of the EEVFAM case and the need for Transitional Justice' chaired by Professor (Dr.) Shiv Visvanathan, Professor, Vice Dean and Director, Centre for the Study of Knowledge Systems, JGU; session two on Components of transitional justice models in India and across the world chaired by Professor Gudmundur Eiriksson, Professor and Executive Director, Centre for International Legal Studies, IGLS: and the third acceleration JGLS; and the third session titled, 'Application of transitional justice principles for Manipur', was principles for Manpur, was chaired by Professor (Dr.) Stephen P, Marks, François-Xavier Bagnoud Professor of Health & Human Rights. Harvard University & Member, Governing Body, JGU.

As the Nagaland Hornbill Festival is going on at the Naga Heritage Village at Kisama, the people of Kohima town are badly suffering from

town are badly stineting from acute shortage of water and LPG supply. According to a press release issued by Nagaland Public Health Engineering Department (PHED) on November 2, regarding the Kohima Water Supply disruption, the restoration work for improvement and widening of National Highway-29 is still under progress. Now, the department, in a

separate release said, restoring water supply to Dairy Farm, Lerie colony, AG colony, PWD, Chandmari and some portions of Kohima town will take another 3 to 4 weeks (to fully restore the Phesama source main line). The Department stated that it will continue to keep the public posted on the progress and thanked the general public for their continued understanding and patience. Meanwhile, the Liquefied petroleum gas (LPG) refilled cylinders are not coming to Kohima for last four weeks. According to one official of a LPG distribution company, the LPG carrier trucks are not

coming to Kohima due to abnormal demands of some Naga undergrounds factions and according to him,

negotiations are going on to carry refilled cylinders by the trucks to Kohima, which is anticipated by the next week. For now, several thousands of

tourists, delegates, representatives and reporters for the Nagaland Hornbill Festival are staying in various hotels, lodges and home stays in and around Kohima town, who are suffering badly and they are depending on mineral water bottles or package water. This is a cheer neglect of the Department officials, who have failed to perform their duties,

the local people said. In the mean time, the Power supply of Kohima town also playing hide and seek game in this capital town, where the Kohima nights have come to life once again with the long awaited Hornbill Night Carnival kicking off on

Saturday. The carnival is part of the annual Hornbill festival, an event aimed at promoting

tourism in the state. The event features food stalls for food lovers, street musicians for music lovers and different shopping stands for shopaholics and many more exciting activities including the Mela. The load shedding and unusual Power supply has annoyed the people, who are to

enjoy Hornbill Night Carnival in dark, but the authority was silent. Meanwhile, more than 60,000

people have visited the Hornbill Festival since its inauguration on Saturday, a state Tourism official said Sunday. Union Home Minister Rajnath
