At least 11 passengers are reported to have died and several others were injured in a bus accident in Poonch district of Jammu and Kashmir on Saturday

The accident took place

when a passenger bus registration number JK02W0445 — heading from Loran to Poonch skid off the road and fell into a deep gorge at Plera. Plera is nearly 30 km away from Poonch A police official said that the driver appeared to have lost control of the bus. The badly mangled bus came to a halt at the bottom of the gorge by a river bank. The injured have been shifted to a sub-district

hospital in Mandi for

The death toll is likely to go up. Further details are awaited.

### Goa govt opposes PIL for declaring CM's health status in HC

### Agency Panaji, Dec 8

Citing the fundamental right to privacy, the Goa government has opposed a plea seeking the High Court's direction to the state administration to declare the health status of Chief Minister Manohar Parrikar.

In an affidavit filed before Justice R M Borde of the Goa bench of the high court Friday, state Chief Secretary Dharmendra Sharma questioned the maintainability of the petition filed by activist Trajano D'Mello a month

If a person is directed to disclose his health ailments to the public merely because he happens to be the CM, the same would be the violation of Right to Privacy under Article 21," it stated.

In his public interest litigation, D'Mello had claimed "administrative

year, is currently recuperating at his private residence here since he was shifted there from AIIMS in Delhi in October The present petition is absolutely lacking in good faith which is an essential prerequisite for the maintainability of public interest litigation," the

unsubstantiated, vague and is entirely based on hearsay which cannot be the basis of a PIL, it said. "The petitioner, through this PIL, indirectly seeks to assail the right to privacy of the CM, as an individual," the affidavit

In his plea, D'Mello had raised apprehension that Parrikar's signatures on several official documents

are being forged.
"Despite physically incapacitated and bedridden in the ICU. Parrikar constitutional trust by virtue to remain as CM despite the fact that he is physically and mentally incapable of discharging his constitutional obligations," D'Mello's affidavit said.

The chief secretary stated that there is no genuine grievance by the petitioner to substantiate allegation administrative collapse in

He stated that the chief minister chairs cabinet meetings regularly, meets legislators and takes decisions on various matters concerning the

"The petitioner has relied upon only those press items which suit him. The petitioner is therefore guilty of suppressing vital information from this

"The entire petition is lacking in any material particulars and as such is a roving and a fishing inquiry which prima facie inadmissible," affidavit said.
The HC will hear the

matter on December 10.

### Voting for panchayat polls underway in J-K

### Mueller files new papers in court on Russian investigations The president and the

Special Counsel Robert Mueller has filed a new set of papers in court that may increase the legal woes of US President Donald Trump in connection with the alleged Russian interference in the 2016 election and possible contacts between the Trump's presidential campaign and Moscow. While the court papers does not answer the central question of whether Trump or his associates conspired with the Russians, the documents suggest that the president's legal woes are far from over and reveal a previously unreported contact from a Russian to Trump's inner circle during the campaign, according a report in the

Washington Post. The Court papers directly implicated Trump in plans to buy women's silence as far back as 2014 and offering new evidence of Russian efforts to forge a political alliance with that show the deepening political and legal morass enveloping the administration, said the

report.
In his filings before a US federal court in Washington DC, Muller said that Paul Manafort, former Trump campaign manager lied to prosecutors about his contacts with the White House and an associate with suspected ties to Russian intelligence.

White House denied of any wrongdoings.
"Totally clears the President. Thank You,"
Trump responded with his characteristic fiery tweets. In another court submission, Mueller said personal attorney of Trump, has gone to "significant lengths" to assist his ongoing Russia investigation.

Mueller said Cohen has provided the special counsel "with useful information concerning certain discrete Russiarelated matters core to its investigation that he obtained by virtue of his regular contact with company executives during the campaign."

A federal court in New York is scheduled to give sentencing order against Cohen on December 12. In August he had pleaded guilty to the charges of campaign-

finance violations and tax recommended substantial prison time for Cohen.

The White House said none of these filing showed any involvement of the president.
