## India's coal output up 10% to 156 MT during Apr-Nov

Agency New Delhi, Dec 9

India's coal import rose 9.7 per cent to 156.08 million tonne (MT) in the April-November period of the ongoing fiscal, as against 142.25 MT in the corresponding months a year ago, according to mjunction services Ltd, a joint venture between Tata Steel and SAIL. Coal imports in November

this year also increased 10.1 per cent to 19.47 MT, over 17.68 MT in the corresponding month of the last fiscal, mjunction data showed.

"Imports during November 2018 stood at 19.47 MT (provisional)...Earlier, coal and coke imports in November 2017 stood at 17.68 MT," it said.

Of the total imports last month, import of noncoking coal was at 14.24 MT, against 15.23 MT imported in October 2018 Commenting on the coal import trend, mjunction CEO Vinaya Varma said, "The significant correction in thermal coal prices in November

prompted buyers to take a wait and watch approach. There, however, was a stable trend in met coal market and this was reflected in

the buying pattern. The import of coking coal was at 3.93 MT in November 2018, almost flat against 3.94 MT imported a month ago.
"Metallurgical coke imports during the month were at 0.50 MT, while 0.53

MT was imported in the previous month," it said. India's coal and coke import during November 2018 through 31 major and non-major ports is estimated to have decreased by 5.32 percent over october 2018, according to a provisional compilation by mjunction, based on monitoring of

vessels' positions and data received from shipping companies. Coal India accounts for over 80 per cent of the domestic coal output. Coal India had earlier said

there is a need to revisit the timeline of one billion tonnes of production target by state-owned CIL by FY 2019-20.

"The Congress and its leaders are heaping abuses on investigation agencies and threatening them. These agencies are acting against corruption. Congress leaders say season is changing but they should know that the country is changing. Action would be taken against those involved in corruption," Hussain said. ### Soldier accused in Bulandshahr violence brought to UP by army, arrested

Agency Bulandshahr, Dec. 9

An army soldier who is accused of killing a police inspector in Uttar Pradesh's Bulandshahr was arrested past midnight after his unit handed him over to the UP police for investigation.

"We've arrested Army jawan Jeetendra Malik, he was handed over by Army at 12:50 am today (Sunday) Preliminary interrogation has been done," senior superintendent of police, Special Task Force, Abhishek Singh said, reported ANI news agency. Jeetendra Malik alias Jeetu Fauii was brought to Meerut by his unit based in Kashmir's Sopore and handed over to the STF after completion of necessary formalities with local army officials. He was taken to Bulandshahr subsequently and handed over to the special investigation team investigating the killing of inspector Subodh Kumai Singh in the violence that broke out in Bulandshahr on Monday over alleged illegal cow slaughter. A

local youth named Sumit Kumar was also killed. "He (Malik) accepted he was there when the crowd started gathering. Prima facie, it has been found It's not ascertained if he is the one who shot the inspector or Sumit. He said he went there with villagers, but denied pelting stones on police. Forensic police. Forensic (examination) of his mobile will be done. Singh added, as per ANI. After scanning video recordings, the state police began searching for the soldier, who is reportedly seen firing during the Bulandshahr violence that led to the death of the police inspector and the youth. A senior police officer privy to the investigations confirmed that one of the videos shows the army man, a resident of Bulandshahr, firing, but his involvement in the

killings is yet to be

The UP police team investigating the case had contacted the army and sought custody of the soldier who had left his home soon after the violence.

Sources said that after getting nod from top officials of the army, it was decided to hand over Malik to the police. On Friday, an army spokesman had said that police had contacted the Army's northern command and fullest cooperation was being extended to them.

Malik's wife Privanka, who had spoken to her husband on Friday, had told media that an army team will bring her husband to Meerut on Saturday. She, however, claimed that he is being falsely implicated in the case as they were in the Svana market when the violence erupted.

His brother Dharmendra Malik who is also in the army, has alleged that his brother had became victim of a conspiracy and demanded help from UP chief minister Yogi Adityanath for a fair probe Malik's mother has said that she would kill him herself if it was proved that he had shot dead police inspector Subodh Kumar during the violence in Bulandshahr, as was claimed through some

## Kannur Airport inaugurated, Kerala gets its fourth international airport

Kannur Dec. 9

Kerala's fourth international airport, the Kannur International Airport, was inaugurated Sunday morning amidst much fanfare. The inauguration was marked by a ceremonial lamp being lit by Kerala Chief Minister Pinaravi Vijavan and Union Civil Aviation Minister Suresh Prabhu in the presence of various ministers, including Sports and Industries Minister EP Jayarajan, and Social Justice and Health Minister KK Shylaja. Its inaugural commercial

flight, a Boeing 737 to Abu Dhabi, was flagged off by CM Pinarayi Vijayan and Union Civil Aviation Minister Suresh Prabhu, and it took off from the 3050 metre long runway at 9.55 AM on Sunday, Later on Sunday, its inaugural day, Air India Express and GoAir flights are scheduled to operate out of the airport flights to

Thiruvanathapuram, Bengaluru and Delhi. The Chief Minister, speaking at the event, mentioned that the new airport at Kannur was a source of particular pride and happiness to Kerala. He also said that the airport at Kannur would be useful to people from

Kerala, such as those travelling to and from Mangaluru, Coorg and Mysore. He also mentioned that the government is

conducting studies to uncover logistics around the construction of a new airport at Erumely near Sabarimala to ease access of pilgrims to Sabarimala. Intriguingly, the airport and its maiden flights have a unique father-son link. When the airport saw its first landing in 2016, of a 228-Dornier Indian Air Force aircraft, one of those present in its cockpit was Kannurnative Raghunath Nambiar. His son, Ashwin Nambiar, will be the first officer of the first domestic non-revenue flight landing in Kannur airport, which will be a GoAir flight from New Delhi to Kannur. A few hours after this flight lands, he will be the First Officer of the first domestic flight taking off from Kannur airport, from

Kannur to Bengaluru The festivities around the inauguration of Kannur International Airport began at around 6 AM on Sunday morning. The event was attended by over 2000 members of the public, included

music and dance groups, including a percussion set headed by renowned percussionist Mattannoor Sankarankutty. The fourth international

airport in Kerala, and the second to be built under the Public-Private Partnership (PPP) model, the new airport's terminal building is said to be the largest

India. Onmanorama reports that the runway, too, will be expanded from its current 3050 meters to 4000 meters, making it, upon expansion, one of the four largest airports in India. The new Kannur airport currently boasts numerous self-check in machines, 24 regular check-in counters, 32 immigration counters and bays to park 20 planes at a given point of time. The new airport is expected to be of particular service to Keralites working in the Middle East, and ease access to tourist destinations like Coorg, Mysore, Kasargod and access

Wayanad. Kerala Ports Minister R a m a c h a n d r a n K a d a n n a p p a l l y inaugurated the airport's VIP lounge, while the ATM counter was inaugurated by transport minister AK Saseendran, who cut a ribbon tied around the ATM and withdrew a few Rs 2000 notes in the presence of the media. The foreign exchange counter was inaugurated by health minister KK Shylaja, and the food and beverage service at the airport was inaugurated by revenue minister E Chandrasekharan with a

ribbon cutting. The inaugural event was boycotted by BJP and UDF MLAs, who have boycotted various government events, including the swearing in of new minister K Krishnankutty, and disrupted the progress of the Kerala Legislative Assembly in protest against the imposition of curfew under sec 144 at Sabarimala, UDF MLAs in particular have boycotted the airport's inaugural to protest the fact that two former Kerala Chief Ministers, VS Ministers, Achuthanandan and Oommen Chandy, both of whom played key roles in

#### Vijay Mallya's extradition case edges towards ruling extradition on the grounds

Embattled liquor tycoon Vijay Mallya is scheduled to return to Westminster Magistrates' Court in London on Monday when his extradition trial is listed for a judgment hand-down The 62-year-old former Kingfisher Airlines boss wanted in India on alleged and money ring charges fraud laundering amounting to an estimated Rs 9,000 crores, has been on bail since his arrest on

an extradition warrant in

April last year. He has contested his

that the case against him is "politically motivated" and the loans he has been accused of defrauding on were sought to keep his now-defunct airline afloat. "I did not borrow a single rupee. The borrower was Kingfisher Airlines. Money was lost due to a genuine and sad business failure. Being held as guarantor is not fraud," he said in his recent Twitter post on the issue.

"I have offered to repay 100 per cent of the principal amount to them. Please take it." he tweeted

that his intervention has anything to do with the extradition case, it came just days before Judge Emma Arbuthnot expected to present her ruling in the case.

The trial, which opened at the Magistrates' Court on December 4 last year, has gone through a series of hearings beyond the initial seven days earmarked for it. It opened with the Crown Prosecution Service (CPS) team, led by Mark Summers, laying out the Indian government's prima facie case of fraud and money laundering against Mallya.

Summers sought to establish a "blueprint of dishonesty" against the businessman and that there are no bars to his extradition on human rights grounds. Mallya's defence team, led by Clare Montgomery, deposed a series of experts in an attempt to prove that the erstwhile Kingfisher Airlines' alleged default of bank loans was the result of business failure rather than "dishonest" and "fraudulent" activity by its

The court was also told that a consortium of Indian banks, led by State Bank

of India (SBI), had rejected an offer by the liquor baron in early 2016 to pay back nearly 80 per cent of the principle loan amount owed to them While the CPS argued that

Mallya never intended to repay the loans he sought in the first place because his airline's demise was inevitable, the defence tried to establish that Kingfisher Airlines was suffering from consequences of a wider global financial crisis around 2009-2010 and that its failure was a result of factors beyond the company's control.
