### Manipur College still blacklisted by UGC over state authority failures to initiate appropriate action against former in-charge Principal for Financial irregularities

IT News Imphal, Jan 11: The one time premier college of the state – Manipur College, located at Singjamei Chinga Makhong, has stop receiving any aids from the University Grant Commission (UGC) since 2013, as the college has been black listed after the UGC found financial irregularities by the in-charge principal of that time. Source with the Imphal Times said that request for lifting of the ban by the state authority has been denied by the UGC and the ban continues till today.

As per source, a wrongful payment by mistake from the UGC was transacted to the Manipur College account when Dr. Kh Jayantakumar Singh, presently serving as

#### Associate Professor in the Associate Professor in the Economics department, Manipur College was in-charge Principal of the college. The source added the wrongful payment was refunded with interest only after conducting an inquiry by the Directorate of University and Higher Education, Govt. of Manipur on the pressure from the UGC. Even as the wrongful payment was refunded, the Standing Committee on Vigilance of UGC decline to lift the blacklisting on the ground that the wrongful payment was refunded only after the UGC directed to do

so The Deputy Secretary (Hr. & Tech. Education), Govt. of Manipur in a letter to the Joint

Secretary (UGC, (HERO) Guwahati on Nov. 16, 2015, had urged to lift the black listing of the college in the interest of the students as the matter for financial irregularities by the then in charge Principal Dr. Kh Jayantakumar Singh was being underway by both Directorate of University and Higher Education and Administrative Department of Higher Education Govt. of Manipur. The Deputy Secretary also assured appropriate necessary action against the former principal subject to the outcome of the enquiry. The UGC further denied to lift

the ban and denied any assistance to Manipur college as they are not

satisfied on the state government authority in taking up appropriate action against the in-charge principal. As of now, Directorate of

University and Higher Education and Administrative Department of Higher Education Govt. of Manipur have not initiated any initiative to lift the ban on the college by the UGC. The then in charge Principal Dr. Kh Jayantakumar Singh still serves as Associate Professor at the Department of Economics of Manipur College. Source said that the UGC

want the state authority to intimate appropriate action against him failing which the ban will continue.

Government had already issued an office memorandum to shorten file procedures to enable prompt

release of funds. The Chief Minister also asked the authorities of different banks to devise methods of making the procedures of providing funds to the public easier. On the other hand, N. Biren also exhorted the public to develop better relationship with banks by properly utilising the loan amounts

utilising the ioan amounts and repaying it on time. During his speech, he also directed the authority of Manipur Rural Bank to study together with the officials of Imphal Municipal Corporation (IMC) to find out whether there is any feasibility of extending financial assistance to street

vendors of Khwairamband Bazaar so that they may start their own business at their own localities. Once an extensive survey is

made, the street vendors can also be extended assistance through various schemes introduced by the Government under the supervision of Prime Minister Shri Narendra Modi, he

added. Informing that the State has more than 7.5 lakh unemployed youths as per the reports gathered from different Employment Exchanges, the Chief Minister said that the present Government is seriously trying to find out a means to provide them employment in a time-bound manner. As such, the State Budget for

the fiscal year 2018-19 will give thrust to self employment through skill development, he said while adding that the Government would also help educated youths to start their own business through StartUp project, for which Rs. 35 crore had been earmarked. On the other hand, the Chief

Minister also expressed concern that there are some groups of individuals who intentionally try to discredit the present Government by uploading fake and fabricated

videos on the social media. Speaking at the occasion as the Guest of Honour Forest and Environment Minister Th. Shyamkumar said that it is a matter of delight for the people of Manipur that the present Government had started providing loans to deserving loanees without any hassle under the strict directive of Chief Minister N. Biren Singh. It is a clear testimony that the Chief testimony that the Chief Minister is concerned about the welfare of the people, he opined. Manipur Rural Bank Chairman Dr. Prasanna Kumar Bal was the president of the function.

The Chief Minister and other dignitaries distributed loans amounting to Rs. 709.54 lakh to 961 persons and SHGs, out of which 626 (Rs. 561 lakhs)

The bank currently has 22 branches across the State During the fiscal year 2017-18 up to December 31, 2017 the bank has disbursed 6201 loans amounting to Rs. 3853.51 lakhs.

On receiving the information the Lamphel Police OC team rushed to the site and conducted search operation and double barrel rifle were

for the said perspn at around 9.30 am yesterday morning. Police source said that the person was arrested from his residence at around 10.30 am yesterday. From his possession the police team recovered one 0. 32 revolver bearing number FG255 00 loaded with 6 live rounds 1 double barrel rifle bearing number 7258611,18 numbers of 0. 32 live ammunitions, one M 20 pistol bearing number N010418 loaded with one life round, 1 gun licence bearing number 5018/iw issued in his name one iPhone 8 plus with Airtel sim and 1 Samsung Galaxy 8 with Vodafone SIM card. Kaiyenpaibam Sanjit told the police that the weapons he possessed- 0.32 revolver

in respect of his particular gun licence. However he failed to produce any relevant documents in respect of the M20 pistol which clearly indicates that the said weapon is in his or unauthorised position he further admitted that he sometimes knows himself is a police personnel showing off his handguns to others to carry out illegal activities like threatening others.

He was arrested on the spot at around 11.0 5 a.m. from his house along with the fire arms on the charge of unauthorised possession of firearms.

A case has been registered against him and the handed over to the concern Imphal police station for necessary legal action.

### TSA calls 36 hours bandh on January 16

Imphal, Jan 11: Thadou Students' Association has announced 36 hour bandh on January 16 at Imphal-Moreh, Imphal-Dimapur, Imphal-Jiribam and Imphal-Churachandpur roads. A statement of the Union

said that the 36-hours bandh will start from 6 am of January 16 and continue till 6 pm of January 17 and is being called over the failure of the State government to bring justice in the 5th May 2017 Sugnu double murder case the brutal murder of Mr Thongkhogin Haokip, an Assistant Teacher at Molnom Junior High School, Tengnoupal district, on February 29, 2016, and the non-introduction of Thadou Kuki (MIL) subjects at Higher Secondary Schools in the valley.

The statement signed by Michael Lamjathang Haokip, Secretary General, Thadou Students' Association said that 21-year-old private school teacher Miss Nengkhokim Haokip alias Cicilia/Shila from Moltinchan village in Chandel district was allegedly gang-raped and brutally murdered and her dead body found near Sugnu. Mr Kaikholen Tuboi was also found brutally murdered, it added. Despite repeated appeals to

the authorities concerned for justice, the culprits have not been brought to justice to date. A team of TSA met with the Superintendent of Police, Kakching District, Investigating Officer (SDPO Kakching) of this case and ADGP (L&O) in this regards. TSA has on December 22,

2017 served an ultimatum to the Home department, to bring justice in the case on bring justice in the case on or before January 10, 2018, but no satisfactory action has been taken up to date. On the matter for introduction of Thadou-Kuki (MIL) Subjects in the higher secondary schools in the valley, the statement of TSA said that the State government has in 2016 already issued an order for introduction of the same. But, the order still remains a mere piece of paper and

it has not been implemented till now. TSA considers this as a deprivation of the rights of the Thadou tribal students

to their language. The student body also threatens further agitation if the government fails to listen to their demand ...
