### Strong quake hits central Myanma<sub>r</sub>

Agency Imphal, Jan 12: Five days after a strong quake with magnitude 5.5 shook Manipur and its neighbouirng area another strong 6 point magnitude earthquake hit a remote region of central Myanmar

early today morning. The US Geological Survey said, the shallow quake struck some 40 kilometres west of the town of Pvu. It was followed by three weaker tremors in the region, of magnitudes 5.3. The USGS said, there is a

low likelihood of casualties and damage, but noted that residential structures in the region are typically vulnerable to earthquake

shaking.
The epicenter was located in a sparsely populated region between the capital Naypyidaw to the north and commercial hub Yangon to the south.

forensic science laboratory whose advisory board has former Chief Justice of India, former chairman Law Commission of India, former Vigilance Commissioner etc. The candidates who got their RTI copies of the answer scripts observed that there is a wide variation in the signature of the examiner of the essay paper which according to the MPSC was evaluated by only one expert/ examiner. On suspicion of forged signatures by different persons other than the assigned examiner, the candidates pursued on their independent capacity to verity the alleged matter. The forensic report proves the contention of the candidates. The forensic report is of the view that out of the 5(five) signatures that had been examined, only 3(three)

signatures (Q1[candidate with code 62938], Q2[candidate with code 93686] & Q5 [candidate with code 50950]) are of the same person while for the remaining 2(two), the report raised serious doubts whether they are of the same person or not. For Q3 [candidate with code 61384] the signature could not be analyzed as the signature shows some discontinuity. And one important finding of a report is that, the signature Q4 [candidate with code 86815] is done slowly and is a defective reproduction. It may be noted that the signatures which are done slowly usually leads to case of forged signature. Upon consulting the experts of the lab regarding whether they could give a definite opinion whether the signature Q4 belonged to a different person

other than the examiner, they told that they can give definite opinion only when the specimen/original signature of the examiner is provided to them. Moreover, the expert(s) of the lab is/are willing to testify their findings in any court of law if summoned during the course of legal proceedings. It is important to point out here

that the Group of Aspirants could afford to send and verify only 5(five) signatures due to financial constrains. We are of the opinion that if appropriate authority directs to conduct a thorough investigation into the said matter, many more cases of such forgery will unearth. Nevertheless, now the onus lies on the MPSC to explain why there was a need to engage other person(s) other than the examiner for

SC judges' alarming charge against CJI Dipak Misra

New Delhi, Jan 12: In an
extremely unprecedented development, four sitting judges of the Supreme Court, the second senior most judge Justice J Chelameswar along with Justice Ranjan Gogoi, M B Lokur and Kurian Joseph, held a press conference.

Addressing the media from his residence at Delhi's Tughlaq Road, Justice Chelameswar stated that they were 'compelled' to address the nation through the media since their repeated requests on a particular matter were not heeded by Chief Justice of India, Dipak Misra.

"With no pleasure, we are compelled take the decision to call a press conference. The administration of the SC is not in order and many things which are less than desirable

have happened in last few months," Justice Chelameswar said, beginning his address stating that this was an extraordinary event in the history of this nation and the Judiciary as an institution.
"We met the Chief Justice of
India with a specific request which unfortunately couldn't convince him that we were right, therefore, we were left with no choice except to communicate it to the nation that please take care of the institution,' Chelameswar.

The judges stated that they had jointly submitted a letter raising an issue of an assignment of a case. The matter pertains to the plea seeking an independent probe into the death of special CBI judge B H Loya, who was hearing the Sohrabuddin Sheikh encounter case. Reportedly, a particular bench was to hear the case but then the case was moved to a different bench at the last When asked if the press

conference came after the developments in the hearing of the Justice Loya case, Justice Gogoi said "yes." In a letter addressed to the CJI,

the four judges had raised

their objection to a particular issue and how it was being handled by the judiciary.

A bench comprising Chief

Justice Dipak Misra and Justices AM Khanwilkar and D Y Chandrachud had taken took note of the submission seeking an urgent hearing on the plea for a probe into Lova's death on December 1, 2014.

# Niti Aayog to provide rankings to 115 aspirational districts

New Delhi, Jan 12: Niti Aayog will provide rankings to the 115 aspirational districts. In its presentation at the 'Transformation of Aspirational Districts' conference which was held earlier this month, the Aayog said the ranking will be on 10 parameters which will include nutrition, education and

health among others. It will also set up a mechanism for real-time monitoring of government's development programmes by April 2018. The government think-tank said it will create a dashboard which will reflect the change in ranking of districts on continuous basis by the end of March this year. In its website NITI Aayog

said that government targets to sanction over 12 lakh houses in 115 backward

districts identified for development in 18 months under a housing scheme. Currently, 6.32 lakh houses

have been sanctioned under the Pradhan Manti Awas Yojana (Urban) for these

# 65 people died of drug abuse in Mizoram in 2017

**Aizawl, Jan 12 (PTI)** At least 65 people, including 12 women, died from substance abuse in Mizoram last year, according to the records of the state Excise and Narcotics department. Of the 65 drug-related deaths

last year, 28 people died from

heroin overdose while the rest

died due to abuse of other narcotics, the records show. An official of the Excise and Narcotics department said around 6.035 kilogramme of

heroin, 13,400 Methamphetamine tablets and 1,59,471 tablets of Pseudo-ephedrine were

seized during raids in 2017. The department also seized 392 kilogramme of ganja (cannabis) and destroyed 4,127 ganja plants.

This year, one person has died due to drug abuse in the first week of January, the official

The state recorded maximum number of drug-related deaths in 2004 with 143 people succumbing to addiction.
The excise and narcotics

department records show at least 1,468 people have died from substance abuse in the state since 1984.
