Congress Party is trying to hit the Bull's eve

Legal issues become needless controversies when politics

casts a dark shadow on them.
For almost 10 months, political observers in the state had almost forgotten that there is a strong opposition party in the state as no words - either about breaking the constitutional provision of 10th Schedule or allegations to the past government has never been heard clarifying from the Congress Party. For almost 10 months none including the former Chief Minister or the President of the Manipur Pradesh Congress Committee had come to the public sphere to clarify the continues allegations by the present government. Regarding the series of allegation about misappropriation of public money and rampant corruption during the last 15 years congress rules have kept them silent as they know things that were made public will not get public support if someone from among them clarify.

But when it comes to violation of the constitutional provisions, the Congress party finally turn up assuming it as an opportunity to strike at the present government. Peoples' support of the government will not give any effect to the recent move of the congress party, which is demanding disqualification of 12 MLAs for holding office of profit.

The Supreme Court in its verdict of July 26, 2017 had declared that appointment of Parliamentary Secretary amounts to holding of office of profit which is against the constitution of

India.

The Congress party had submitted a memorandum urging disqualification of the MLAs holding office of profit on March 23 last year. And for the second time the Congress party submitted another memorandum demanding the same yesterday. If the governor of Manipur takes time in taking up any action regarding the demand of the Congress Party, they will go the Law Court. This was stated by the President of the Manipur

Pradesh Congress Committee yesterday.

Another serious matter is the defected MLAs of the Congress party who had joined the BJP. By virtue of their position and sides they have joined the ruling party violating the provisions of the 10th Schedule of the Indian Constitution.

These issues cannot be taken lightly as it would amount constitutional crisis. A ruling party will find hard to put this matter under carpet as there is a law court to check them.

The only real threat to the N. Biren Singh led government is these two issues. The Congress now is trying to hit the bull's eye and if the present govt. fails to tackle it with extreme seriousness - there is a possibility that the congress override the N. Biren Singh led govt.

AR conducts pulse polio immunization and medical camp

What is the punishment for a fake Facebook account?

Nowadays creating Fake Facebook accounts are very common. Sometimes these fake accounts may spread spam as well as viruses to steal our private data. Also, Offenders set

up fake online accounts to take revenge on other people and uploads malicious photos. Offenders may steal our identity to create their accounts. You can file a complaint in such situations.

Here are some sections and punishments for creating a fake Facebook account. Section 468 of the IPC and Section 66D of the IT Act will be used in this case and punishment under Section 468 can

be jail up to 7 years. Section 468 in The Indian Penal

Code

468. Forgery for purpose of cheating.—Whoever commits forgery, intending that the 1[document or electronic record forged] shall be used for the purpose of cheating, shall be punished with imprisonment of either de-s c r i p tion for a term which may extend to seven years, and shall also be liable to

Section 66D of The Information
Technology Act, 2000
Punishment for cheating by personation by using computer resource. -Whoever, by means for any communication device or computer resource cheats by personating, shall be punished with imprisonment of either des c r i p tion for a term which may extend to three years and shall also be liable to fine which may extend to one lakh

66E. Punishment for violation of

Whoever, intention intentionally knowingly captures, publishes or transmits the image of a private area of any person without his or her consent, under circumstances violating the privacy of that person, shall be punished with imprisonment which may extend to three years or with fine not exceeding two lakh rupees, or with both

xplanation - For the purposes of this section-

(a) "transmit" means electronically send a visual image with the intent that it be viewed by a person or persons;

"capture", with respect to an image, means to videotape, photograph, film or record by any

(c) "private area" means the naked or undergarment clad genitals, pubic area, buttocks or female breast: (d) "publishes" means reproduction in the printed or electronic form and

making it available for public; "under circumstances violating privacy" means circumstances in which a person can have a reasonable expectation that—

(i) he or she could disrobe in privacy, without being concerned that an image of his private area was being captured; or

(ii) any part of his or her private area would not be visible to the public, regardless of whether that person in a public or private place.

Section 67 in The Information

Technology Act, 2000
Punishment for publishing or transmitting obscene material in electronic form: Whoever publishes or transmits or causes to be published or transmitted in the electronic form, any material which is lascivious or appeals to the prurient interest or if its effect is such as to tend to deprave and corrupt persons who are likely, having regard to all relevant circumstances, to read,

see or hear the matter contained or embodied in it, shall be punished on first conviction with imprisonment of either des cription for a term which may extend to three years and with fine which may extend to five lakh rupees and in the event of second or subsequent conviction with imprisonment of either des c r i p tion for a term which may extend to five years and also with fine which may extend to ten lakh rupees.

Section 67A in The Information

Technology Act, 2000
Punishment for publishing or transmitting of material containing sexually explicit act, etc., in electronic form. -Whoever publishes or transmits or causes to be published or transmitted in the electronic form any material which contains sexually explicit act or conduct shall be punished on first conviction with imprisonment of either des cription for a term which may extend to five years and with fine which may extend to ten lakh rupees and in the event of second or subsequent conviction with imprisonment of either des cription for a term which may extend to seven years and also with fine which may extend to ten lakh rupees.

Trump condemns Taliban role in Afghan attacks, says no talks

Washington, Jan 30: President Donald Trump told visiting members of the UN Security Council today the US would no longer talk with the Taliban following a recent string of deadly attacks in Afghanistan.

Trump railed against a series of 'atrocities" in Afghanistan and said as a result the US would not engage in any future talks with the Taliban as the administration seeks to end a stalemate in America's longest war.

"Innocent people are being killed left and right.
Bombing, in the middle of children,

in the middle of families, bombing, killing all over Afghanistan," Trump said. "So we don't want to talk with the Taliban. There may be a time but it's going to be a long

The president's comments followed a deadly car bombing attack in Kabul, the Afghan capital, that killed at least 95 people and wounded 158 more. Earlier this month, Americans were killed and injured in the Taliban's 13-hour siege of a hotel in Kabul.

Trump's remarks at the diplomatic luncheon marked a shift in tone on Afghanistan. The US has said previously that any peace talks with the Taliban need to be part of an Afghan-led process, but the US has never precluded talking to the

New Delhi, Jan 30: The Indian Olympic Association (IOA) today appointed its joint secretary Vikram Singh Sisodia as the Chef-de-Mission for the upcoming Commonwealth Games to be held in Gold Coast, Australia.

The IOA also appointed three team managers to accompany Sisodia and help him in the day-to-day

duties during the Games.
The three team managers are
Modern Pentathlon Federation of India General Secretary Namdev Shirgaonkar, Asian Sailing Federation official Ajay Naarang and Andeman and Nicobar

and Andeman and Nicobar Olympic Association Secretary General V A Shiyad. "Mr Sisodia, who will be embarking on this major assignment, is currently the Joint Secretary of IOA. The three team managers will help Mr Sisodia in the execution of day- to-day duties during the Games," the IOA said in a release.

Sisodia is also currently the president of Chhattisgarh State Tennis Association.

The 21st Commonwealth Games will be held from April 4 to 15 in Gold Coast, the second largest city in Australia.

IOA President Narinder Dhruv Batra said he's confident that the four officials would discharge their duties and do a good job during the Games.

"I am sure they would take good care of the Indian contingent. I wish them all great Games," Batra said. IOA Secretary General Rajeev Mehta said, "Though the job is new to Mr Sisodia and his team of officials, I know their capabilities as administrators. I am quite assured they would discharge their duties to the satisfaction of all concerned.
