Procrastinations and protests

The build-up to the 48 hours general strike called by MUSU and staunchly supported by various student's organizations which began from midnight of 17 July have been long and gradual in the making. After a considerable lull in protests and social disruptions after the BJP-led coalition government snatched power from the Congress, the state is now truly back to its familiar albeit uncomfortable social scenario, with uncertainty, suspicion and a general air of pessimism pervading the entire state. Meanwhile, the adamancy of the BJP-appointed Vice Chancellor whose resignation is being demanded by every quarter of Manipur University without exception clearly manifests the collective attitude of total disregard and disdain of the BJP at

of the people of the state to the point where even the Chief Minister has to almost plead with the power at the centre to take up the issue with right earnestness. If the issues and concerns raised by the people of a state under BJP rule is neglected and dismissed, the thought of the plight of the people in states under non-BJP rule is scary to put it mildly.

The escalating tension and social disruptions is an avoidable tragedy. The Chief Minister have finally found the wisdom to take steps to settle the issue by knocking at the corridors of power at the centre and appraising them of the developments in the state to those who matter. Meanwhile, the call for the resignation of N Biren as Chief Minister is getting shriller. His image of a proactive and decisive leader has taken a huge dent, more so after the determined and orchestrated portrayal as a leader with a radical and hands on approach which raised the expectations of the people to unrealistic heights during the initial euphoria of maneuvering into power. Promising the moon and delivering mediocrity will definitely prove to be the perfect recipe for social disaster and chaos, and if the present government of the state has enough wit about itself. there should not be another next time of disruptions and social unrest to force it into action. It would be pertinent to point out that the state government failed to correctly feel and read the pulse of the society- whether from overconfidence or from lack of foresight and finesse is anybody's guess.

The most important- or perhaps the only question that matters is -what now? If our opinions and suggestions would have any impact on the thoughts and actions of the power that be in the state, then the following points might provide some

food for thought and action. First off, taking proactive steps to settle issues before things spin out of control and become a grave issue affecting the lives of the public. Use of public posts and positions for other political or personal gain should be discouraged and publicly dealt with without further ado. The state force should be sensitized on the matter of handling protests and public demonstrations as ruthless gagging would only make matters worse- for themselves and everybody, what with the already notso-favorable perceptions of the general public of their integrity and dedication towards duty. But above all, a strict delegation of rights and responsibilities towards authorities will ensure things will not get out of hand and issues will get resolved in a more pleasant and amicable manner.

During the long reign of 40 years, Pamheiba changed his faith so frequently. From 1709-1717 the king followed Rudra Sampradaya, from 1717-1724, he felled to Goudya Vaisnavism. Then he changed to Ramayet cult from 1724 and continued

1736AD. Then he got baptised to Nimandi cult and professed the same from 1736- 1739. In the fag end of his life, the king adopted Goudya Vaisnavism once again till he breathe his last but he could not influenced his subjects much. Thus, Manipur became an arena for testing different religious cults from 1709- 1748 under Pamheiba alias Garibniwaz which made untold misery to his subjects.

The 3rd Manipur State Conference of All India Lawyers' Union (AILU) was held at Cheirap Court Hall, Imphal this Sunday.
The Inaugural Session of the conference was addressed by

AILU National President Bikashranjan Bhattacharya, CPI(M) State Secretary Kshetrimayum Santa, AILU Tripura President Haribal Debnath, Columnist Advocate Chongtham Narendra , Uma Chandra from AILU Tripura and Puyam Tomcha Meetei AILU Manipur President. After floral tributes to the martyrs and welcome address by state Vice President of AILU Maisnam Jagajit Singh a condolence resolution was adopted and a two minutes silent was observed as a silent was observed as a homage to the departed members of the union specifically mentioning the name of Comrade Hashim Abdul Halim, who was instrumental in the launching of AILU Manipur State unit. Bikashranjan Bhattacharya, inaugurating the conference inaugurating the conference in his speech talked about the Vishwa Kavi Rabindranath Tagore's contribution to the Manipuri dance and the influences on him by the Manipuri culture traditions for his writings on Chitrangada and the opening of Manipuri Dance Department in Viswabharati at Shantiniketan. Coming to the legal system, he further said that our issues in this country is concerning the justice delivery system to the people irrespective of caste, creed, colour and class. He, pinpointing the Constitution of India, said that our people should have equal justice on social, economic and political life but the present legal practice in the country denied the rights of the people enshrined in the Constitution which was framed by the Constituent Assembly . Emphasising the conditions of the masses Bikashranjan Bhattacharya pointed out that the 70 years of injustices meted out to the toiling masses steeled the lawyers and justices and enabled them to stand against the dictates of the ruling class administration for a better legal practice and system. He continued by noting that the rise of the far right forces, the Hindutva forces, coincide with the coming of BJP led NDA Government at the centre which is on the onslaught to the people in the of capitalist development The development . He concluded that we have to defend the independence of judiciary from the tyranny of fundamentalists Hindutva ruling combination and this can be achieved only through a united struggle and called for a people centric alternative policy. Greeting the delegates and

participants to the inaugural function of the conference Kshetrimayum Santa, the State Secretary of CPI(M), reminded the contributions to the establishment of AILU unit in Manipur made by the AILU leadership led by Comrade Hashim Abdul Halim, since deceased, including D K Aggarwal, former General Secretary of AILU ,Bharati Mukherjee,K Parthasarathi and S P Singh in 2009 .
