United Committee Manipur (UCM), and Committee of Civil Society Kangleipak (CCSK) today called on the legislatures of the state assembly to make a resolution to the statement of the RN Ravi which was published at almost all newspaper including national media today. A joint press conference held

today at the office of AMUCO at Kwakeithel here in Imphal, President of AMUCO Ph Devan said that the report appeared at National newspaper Indian Express and The Hindu indicated on ethic line will never be implication of article 371 A which is giving special Devan said. which is giving special provision for the state of Nagaland, to all the Naga inhabited area of the state

"This is against the will of the people of the state as it is more like dividing the state on ethnic base", Devan said. He added that the civil society

of the state including AMUCO, UCM and CCSK had already warn about serious consequences if any division is made to the integrity of the state. He also question how it will be possible when there is no such place in the state of Nagaland where only a specific community inhabited.
"Manipur is a multi ethnic state and any divisive policy

As per report appeared in Indian Express RN Ravi was quoted as saying that rticle 371A of the Constitution makes it clear that they are special and a special status has been accorded to them. A similar kind of status, with some local variation, and some change to the Nagas in the neighbouring States can be explored. According to the report, Mr. Ravi also informed the committee that the Nagas had now reached a common understanding with the government that "boundaries of the States will not be touched" and "some special arrangements would be made

for the Nagas, wherever they

'It is meaningless to keep the territorial boundary intact while different administration is enforce for one community and another administration for another community", Devan reacted.

National Students' Union of National Students' Union of India (NSUI) Manipur state today extended support the ongoing agitation by Manipur University community demanding removal of the Vice Chancellor Adiya Prasad Pandey saying that the body will organise mass protest at New Nelhi in consultation with its head office.

Speaking to reporters today afternoon at its office room general secretary of Manipur State NSUI N. Samananda said the deteriorating education atmosphere in the state is not a signed of good governance and government inability to find a

solution to the present impasse id unfortunate. Reacting to the Chief Minister's N. Biren statement at which he stated that the MU community are not allowing the fact finding committee, Samananda said that the fact finding committee formed to investigate the matter has already been rejected by not only the Manipur University community but also by the people of the state. The demand is constitution of an enquiry committee under the commission of enquiry act which is head by a retd. Judge from any high court.

The NSUI State general secretary further said that it is very unfortunate for the BJF led government of the state which had gone to Dekhi to apprise on the situation and return back empty hand without finding any solution.
The student leader of the NSUI further said that appointment of head of institution should not be made to any persons who are affiliated to political parties. The NSUI Manipur State unit general secretary also condemn the Anti National tagged to MU community and demanded immediate revocation of such tagged. On the other hand the NSUI

Manipur state unit appealed students who had failed to get admission because of the ongoing impasse at Manipur University. He said government should make arrangement to make sure that no student loss academic career because of the present impasse resulted from an inefficient Vice

Chancellor.

Most tear gas shell fired to disperse protestors on Thursdays were expired

Imphal, July 21,

Of the nearly 50 tear gas shells fire to disperse protesters on Thursday evening at uripok and Singhjamei area, many were found to have been expired, while others did not have expiry dates mentioned on them.

Large number of women folk with torch on

their hand stage protest rally at Singjamei and Uripok area supporting the demand of the Manipuri University community for removal of the VC Prof. Pandey and also condemning the police brutalities to students protesting in front of BJP office as well as at CMO gate.

A Police officer talking to Imphal Times said that most of the tear gas shell fired didn't explode if expired. Health hazard from expired tear gas shell is not expected the police officer

while talking over phone said. Tear gas shells fired by the police on Thursday evening were found to be expired on April

There were many shells which had expired three years ago. Others had no expiry date written on them," said a protestor at Uripok who did not want to disclose his identities. "These are not antibiotics which can harm if



taken after expiry date. These shells become less intensive in

releasing gas," another police officer told Imphal Times. According to experts tear gas when expired turns toxic, and far more dangerous to humans and other organisms. It can cause severe pulmonary damage, and the chemical compound 2chlorobenzalmalononitrile which is the main constituent of tear gas shells, popularly known as the CS gas, have also been known to cause significant damage to the heart and liver, as have been reported in some cases.

As according to expert, tear gas turns toxic on expiry which had

dangerous health effects. The tear gas can cause permanent blindness, chemical burns, miscarriages, fatal exacerbation of Asthmatics, seizures and even death if canister hit the person

It's not clear how that might affect people

differently from unexpired gas.
"Some experts contend that expired tear gas may lead to more dangerous health effects than its non-expired counterpart— for people heavily exposed to it," an international journal report.

Outdated pyrotechnic items which include tear gas, are considered hazardous waste as per "The Resource Conservation and Recovery Act" of 1976 and disposal of this items must be done in accordance with "Environmental Protection Agency" waste anagement regulations.
Il commercial munitions which include tear

gas, after expiry date are no longer guaranteed to function as designated. Using outdated munitions are prohibited under law

and open a liability on the operator. However the most shocking part is that some people are collecting these shells and selling it to some mysterious buyers. who

selling it to some mysterious buyers, who are apparently being paid a very high price for the canisters.

The question is will the Manipur government book those people responsible for the supply of expired tear gas shells or Is it intentionally used by state police force?

Plastic bags imported from Myanmar are Non-biodegradable and hazardous not only to human beings but also to aquatic lifes. Moreh Consumer Clubs demand help and support from State and Central Govt. to make a pollution and plastic Free Country by stopping the importing of Nonimporting of Non-biodegredable Plastic bags from Myanmar and China. If the Government lacks to look after this issue then Plastic bags from Myanmar and China will make India .the
