

If a person throws stone to Shops , should we wait for the magistrate to prove or should the police act? – MU Community

While stating that the core objective of Education is the search for truth and the means to arrive at the truth, The Manipur University community who has been on strike for over 55 days today stated that they are fully committee to this exemplary example.

In a statement signed by Presidents of MUSU, MUTA and MUSA, it is stated that if a person throw stones at a shop at Paona Bazar and cause damage, is it right to wait for the magistrate to arrive and give judgment that whether the person is throwing stone to the shop? This comes as a reply to those protagonists who are talking about 'natural justice' in connection with the unstated demand for removal of AP Pandey from his VC post of Manipur University.

" Talking about natural justice in the present context of Manipur University is no different from inviting the magistrate before security forces arrest the person causing damages to the shops.

The Manipur University Community is still firm on the demand for removal of the present VC AP Pandey, from his position coupled by an Independent enquiry to his financial and administrative misdeed to establish accountability and generate lessons for posterity, the statement added.

Pointing out the irregularities and damage caused by the VC AP Pandey, the statement said that the VC is still not at his station of his posting , he left Imphal on July 25, 2018.

"True to his habit the date of his return is unspecified. Even more he left station without handing over the charge to anybody in the University.

AP Pandey in his clarification stated that there is no mandatory requirement , as per the Manipur University Act 2005 to hold meetings of the Executive Council and the Finance Committee minimum of 3 times a year. But the Article 13 (3) of the Manipur University Act 2005b writes that the VC may , if he is of the opinion that immediate action is necessary on any matter, exercise any power conferred on any authority of the University by or under this Act and shall report to such authority at its next meeting the action taken by him on such matter.

In Article 22 (2) it is also stated that " Subject to the provisions of this Act, the Court shall have the following powers and Function :- a) to review , from time to time , the broad

policies and programmes of the University and to suggest measures for the improvement and development of the University; b) to consider and pass resolutions on the annual report on such accounts.

Article 18 (5) says that the finance Committee shall meet at least thrice every year to examine the account and to scrutinize proposals for expenditures.

The statement also stated that Prof AP Pandey not only indulges in continual violation of the Constitution Norms but also put in writing in the public domain that he does not have to follow these. "Does not the open and profuse violation of the constitution demand immediate impeachment?" the MU Community question.

Send her to 18th Asian Games 2018- Kshetrimayum Santa

The Manipur State Committee of CPI (Marxist) expressed serious concern to the Anti-Doping test Gold Coast Commonwealth Games weightlifting gold medalist Sanjita Chanu and condemn in the strongest term.

A statement by Kshetrimayum Santa, Secretary, Manipur State CPI-M said that the party feels that the alleged vindictive nature of the Indian Weightlifting Federation and International Weightlifting Federation (IWF) to the Gold Coast Commonwealth Games weightlifting gold medalist Sanjita Chanu are condemnable.

The "administrative mistake" mentioned in the report of the IWF to National Anti-Doping Agency (NADA) on the doping process of Sanjita Chanu's urine sample which was collected on 17th November, 2017 at Las Vegas, USA by the United States Anti-Doping Agency (USADA) highlighted the casualness and unprofessional practices in conducting the tests, Shanta added in the statement.

It further said Miss Sanjita Chanu was a victim of the maladministration in conducting the doping tests by the concerned Agencies. Her fame was tarnished and she was in deep trauma after getting the unexpected report on May 15

this year on her doping test from the IWF. She ran from post to pillars to get justice, even to the state office of CPI (Marxist) and Chief Minister Office, Manipur. Her trauma was short lived as she believes that she is winning the battle against the injustice committed to her. She was encouraged by the media and people to fight till the end to get justice.

"Her case is a case of bold and bravery in the history of doping test in the country in particular. The Manipur unit of CPI (M) appeal to the authority of sports in the country to send Sanjita Chanu as a member of Indian weightlifting contingent to the 18th Asian Games 2018 to be held at Jakarta, the Capital city of Indonesia from August 18 to September 2, 2018, to keep her name in the list of Target Olympic Podium (TOP) Scheme, to accord her due promotion as a distinguished sportsperson and a suitable award to compensate the unnecessary trauma she experienced. The party demand for constitution of an inquiry to look into the "unmistakable" mistake and to punish the culprits. And, the party appeal to the state government to arrange a suitable post for Sanjita Chanu in the state service to enable her to represent Manipur", the statement further added.

Deputy Commissioner of Imphal East District has notified that issue of Computerised Jamabandi (Patta) in respect of the revenue villages namely 60-Sangsabibi and 76-Tellou under Sub-Deputy Collector, Sawombung shall be started w.e.f 03/08/2018 in the Office of the Deputy Commissioner, Imphal East District, Porompat, Manipur during 11 am to 3 pm on all working days. The Computerised Jamabandi/ROR shall be issued on payment of Rs 50/(Rupee: fifty) only per Jamabandi (Pam) copy through T.R-5 done from the Office of the Sub Deputy Collector, Sawombung. Henceforth, the practice of issuing manually processed Jamabandi (Putts) of the revenue village mentioned above has been discontinued with immediate effect.

Prof. A. Santa Singh, Director of Regional Institute of Medical Sciences (RIMS), Imphal inaugurated newly constructed OPD counter, Public Kitchen and Public Lavatory of the Department of Psychiatry, RIMS, Imphal. During the inauguration, Prof. A. Santa Singh said that there were not enough basic facilities in the Department last so many years. But, now, under the initiative of the Department of Psychiatry, such basic facilities like OPD counter, public kitchen and

public lavatory can be constructed in time and dedicated to the public. Such facilities will be immensely benefited to the patients. He also urged other departments to take more initiatives for the development of the institute. Prof. RK. Lenin Singh, head of department of Psychiatry stated that before 10 years only 20 to 30 patients used to visit Psychiatry OPD but it is increased to more than 100 patients per day. The present problem of congestion could

be solved after the inauguration of new OPD counter. The newly constructed lavatory will solve earlier problem of public toilet facility in the department.
