2012 Delhi gangrape: SC upholds death sentence for 3 convicts, dismisses review petition

The Supreme Court on Monday upheld the death sentence of three of the four convicts in the Dec 16 2012 Delhi gangrape and murder of a 23-year-old woman saying there was no error in the judgment. The three had filed a review petition after the top court upheld the death sentences on May 5,2017.

A bench comprising Chief Justice Dipak Misra and justices R Banumathi and Ashok Bhushan delivered its judgment on the pleas of Mukesh (29), Pawan

of Mukesh (29), Pawan Gupta (22) and Vinay Sharma (23). The four death row convict, Akshay Kumar Singh (31), did not file a review petition against the apex court's order on May 5,2017. "Review applications

cannot be entertained... convict cannot be allowed to re-agitate the grounds of appeal. There has to be an apparent error on record to show it resulted in miscarriage of justice," the bench said in its judgement.

The death row convicts failed to point out 'error' in the judgement," the court said. "Convicts were heard elaborately during appeals and no grounds have been made out for review of its verdict. The top court in its 2017 verdict had upheld the capital punishment awarded to them by the trial court and confirmed by the Delhi high court in the case of gangrape and murder of a 23-year-old paramedic student on December 16, 2012 that had left the country shocked and outraged. The Manipur University community – which comprises members of Manipur University Students' Union (MUSU), Manipur University (MUSU), Manipur University Staffs Association (MUSA) and Manipur University Teachers' Association (MUTA) begins relay hunger strike from 11 am today at the University complex.

Ibobi also said that when states like Ngaland, Meghalaya and Assam can directly stand against the Citizenship Amendment Bill 2016 why is the Manipur Government can't give a stand against the passing of the Bill as every knows that the Bill will only affect the people of the state as it will be another dumping ground. On the issue resgarding the implementation of the 7 pay commission for the government Employees Ibobi said that why the state government cannot announced it before the 15 finance commission as i9t would affect the employees had not it been implemented before that.

'We know lack of resource is the main problem and it will be difficult for state to face the consequences if 7 pay has been implemented, but being a government they should take some risk", Ibobi said.

He further added that when the state government under congress ruled implanted 6 pay commission the government could not pay salary for 3 months and that time it was NDA government again headed by the BJP at the center

Ibobi said that he have to urged the center for urged the center for assistance to the state as the state have no resource. If the government is committed enough they should fixed an immediate

effective date for implementation of 7th pay by managing the arrear part on instalment payment.
