Curfew imposed in Shillong after social media-triggered communal tension

Agency Shillong, June 1

A journalist and four civilians were injured in the clash. Rumours generated via social media about the death of a tribal man led to communal tension in Shillong on Thursday evening, forcing the authorities to clamp curfew in parts of the city. Superintendent of Police

(City) Steve Rynjah said a clash broke out between drivers of State transport buses and residents of Them Iew Mawlong locality, also known as Sweeper's Lane, on

Thursday afternoon. An incident of eve-teasing allegedly involving a conductor of one of the

buses and a girl of the locality was said to be the trigger of the clash between tribal people and Dalits. Some claimed the fight started after women of the locality objected to the parking of a bus that blocked the way to a water collection point. In that scuffle, a tribal boy in

the bus got injured. "But a rumour that a local

person had died during the incident went viral on social media, following which scores of people marched to Sweeper's Lane. We had to use tear gas to disperse the angry crowd and bring the situation under control," Mr. Rynjah said. Locals said despite the presence of police, tension

prevailed till 2 am on Friday as waves of people tried to force their way to the locality. The authorities of East Khasi Hills district, under which Shillong falls, later imposed curfew in 14 localities around Sweeper's Lane. These include Iewduh or Bara Bazaar, the commercial hub of the city.

"Information is received that there is a serious breakdown of law and order in Shillong city... there is every likelihood of serious breach of peace which may lead to acts of arson, targeting vehicles and causing loss of life and property," East Khasi Hills District Magistrate P.S. Dkhar said in an order promulgating curfew indefinitely from 4 am.

India, Singapore agree to deepen economic and defence ties

Prime Minister Narendra Modi and his Singaporean counterpart Lee Hsien Loong today agreed to deepen the bilateral economic ties and build on defence cooperation as the two sides signed eight agreements including one on logistics cooperation between their navies.

The two leaders, who held wide-ranging discussions on regional and global issues of mutual interests, also called for a peaceful, open, and friendly maritime environment in the Indo-

Pacific region. Prime Minister Modi said that the strategic partnership between India and Singapore has stood the test of time in

the real sense. "We have been able to conclude successfully the second review of Comprehensive Economic Cooperation Agreement (CECA) but we agreed this is not just our target and goal but this only means to an end," Modi said in a joint press statement after the

meeting. "Our officials will soon begin discussions on upgrading

and reforming this agreement," he added. Since CECA was signed in 2004, India-Singapore bilateral trade more than doubled from SGD12 billion (USD 8.97 billions) to SGD 25 billion (USD 18.69 billion). Singapore was the second largest investor in India in FY-2016. Modi hailed the close

defence cooperation between the two countries and welcomed the completion of the logistics agreement between the two navies.

"In the coming times, dealing with cyber security and extremism and terrorism will be important areas of our cooperation," the prime minister said.

Modi and Lee also exchanged views on the regional and global challenges and reiterated their principled position on maritime security and expressed commitment to 'Rules Based' Order. The two leaders also agreed on the need to maintain an open, stable and fair

international trade regime. "We both have reaffirmed our views on maritime security and have shown our commitment to a 'Rules Based' order...We also agreed for a peaceful, open, and friendly maritime friendly maritime environment in the Indo-Pacific region," Modi said. China is engaged in hotly contested territorial disputes in the South and East China Seas. Beijing has also made substantial progress in militarising its manmade islands in the past few years, which it says it has the right to defend

China claims sovereignty over all of the South China Sea. But Vietnam, Malaysia, the Philippines, Brunei and Taiwan have counter claims. In the East China Sea, Beijing has territorial disputes with Japan.

The South China Sea and the East China Sea are stated to be rich in minerals oil and other natural resources. They are also vital to global trade. On his part, Lee said the bilateral defence ties have grown stronger. "Our defence ties have strengthened, our navies

have signed an agreement today on logistics cooperation and will also celebrate 25th anniversary of annual Singapore-India Maritime Bilateral Exercise (SIMBEX) this year," Lee

said He said India and Singapore are collaborating on technology, smart cities and skills development, both at the national and the state level

Lee pointed out that two projects, that arose from Prime Minister Modi's 2015 visit to the city-state, have been completed. "Andhra Pradesh Amaravati

He said the international launch of RuPay, BHIM and UPI based remittance app in Singapore yesterday represented Digital India

initiative and the renewed partnership between the two sides. Lee said Indian tourists will be able to use their RuPay cards for electronic payments at Changi airport

Sports Ministry's Target Olympic Podium Scheme for her Asian Games preparations. But her name is expected to be struck off from the list if she is finally ruled to have committed the dope offence. The latest dope flunk will hit Indian weightlifting

hard after a clean recent past, especially after Mirabai Chanu's 48kg category gold medal in the

World Championship. After a dope free 2016, one weightlifter — Sushila Panwar - returned positive in a test conducted by the international federation. Sanjita's case is the first positive result of this year.

result of this year. Recently, the International Weightlifting Federation decided to punish offending countries by limiting their quotas for the 2020 Tokyo Olympics after the IOC asked them to clean the tainted sport. It was decided that countries like Russia, Kazakhstan,

Azerbaijan, Armenia and Belarus will be given only two places each at Tokyo 2020. The new rules state that any nation with 20 or more doping violations from 2008 to 2020 will have just one man and one woman at the Games. Countries with 10-19 doping violations over that same period will be limited to two men and two women in Tokyo. At least nine more countries, including Bulgaria, Iran and India fall into that category. This decision to limit Olympic quotas, however, will not

have much impact on India as the country has not been sending more than two weightlifters each in men and women's sections in the Olympics during the past few aditions

Before Sanjita's case, 12 Indian weightlifters had returned positive in tests conducted by the international federation since 2008.
