of Birth of L. Mahendra Singh, the present Chairman of the Council of Higher Secondary Education (COHSEM) is 1-1-1958 as per record with the Imphal Times. He was appointed as the Chairman of the COHSEM by an order of the Joint Secretary Education (S), Govt. o Manipur on December 24 2016 on deputation for a term ending December 31, 2017. Again on December 23, 2017, Again on December 23, 2011, another order of the Deputy Secretary Education (S) extended his chairmanship for a period of another one year knowing that he already crossed 60 years. As per govt. rules a person whose age cross 60 years cannot remain as the Chairman of the Council. As

per govt. rules posting at the directorate at administrative level should

be repatriated to his college or Higher Secondary School if his upper age limit attain 60 years. This is a single case to show,

how the promises made by the government has been make a mockery. This Government had promised to stop re-engaging of retired government officials with exception to some technical post. But so far many are seen still re-engaging. Forget about the reengagement promises, this

government continue to violate rules and regulation or guidelines to the appointment of top post in govt. body, either knowingly or unknowingly for reason best known to them.

patrolling duty. He said that they were ambushed in midway, wherein two of them identified as Havildar Fateh Singh Negi and sepoy Hungnga Konyak were martyred on the spot while four others sustained critical bullet injuries. The PRO said that involvement of suspected Naga underground groups in the ambush is yet to be confirmed while there have no claims made by any group. Sources also said that Assam Rifles jawans also retaliated but casualty if any on the other side is also not ascertained.

Social activists write to PM warning serious consequences to the creation of Naga Territorial Council or alike

Three social activists of the state – Heigrujam Nabashyam, Hijam Rajendra Singh and Leichombam Dilip Singh has submitted a memorandum to the prime Minister of India showing serious concern to the possibility of creating a Naga Territorial Council or a similar of the Kind in the state of Manipur while resolving the issue to the NSCN-IM.

In the memorandum the three social activist while appreciating the Government of India initiatives to end the Naga Insurgency strongly oppose any destruction in any form to the state of Manipur The memorandum stated that Manipur was an ancient South East Asian nation with over 2000 years of written history. It was also the last territory to be annexed by the British Colonialists in the Sub-Continent Indian following the Anglo-Manipur War in 1891 and therefore Manipur cannot be compared with Arunachal Pradesh or any other states in the region. Geographically speaking it is a state made up of the hills that covers 90% of the state and the remaining 10% is the valley. The beautiful part of the state is that there are 37 different indigenous groups of people who reside in the state. While the valley dwellers namely the Meitei who speaks Meiteilon, also known as Manipuri as their mother tongue were the traditional settlers of the valley. But today all the 37 different indigenous groups of people without any distinction share the same space of the vallev
