15,000 foreigners to be stuck off NRC

At a time when the deadline for the publication of the complete draft NRC is approaching, and despite reports that the NRC may not be published on June 30, the be published on June 30, the authorities coordinating the draft finalization work of the NRC have decided to be rather strict with reference to the inclusion of names of 15 000 individuals 15,000 individuals. This applies to those foreigners who came to Assam

during the period from 1966 to March 24, 1971 but did not get themselves registered as per rules with the Foreigners Regional Registration Office (FRRO).

The FRRO is the primary agency, functioning under the aegis of the Ministry of Home Affairs, which regulates the registration, movement, stay, departure, and also for recommending the extension of stay of foreigners in India. As per rules, such immigrants should have themselves registered within three months after detection, but this period was subsequently extended to six months. Moreover, the names of such people would not be included in the electoral rolls for the next 10 years. In other words, such people would not enjoy any voting rights during that decade. Nevertheless, their names would automatically be included in the electoral rolls following the expiry of the

mandatory 10-year period. However, they could very well reside within the State during this phase.

These provisions are also mentioned in the relevant sections of the Assam Accord. According to sources, the fact remains that altogether 29,000 Bangladeshis who had entered Assam during the period from 1966 to March 24, 1971 were detected. Of them, 15,000 detected or declared foreigners did not register themselves with the FRRO. Sources said many among them have now applied for inclusion of their names in the NRC.

Talking to The Sentinel, State Coordinator of NRC Prateek Hajela said, "As per rules, we'll have to leave out the names of the individuals not registered with the Foreigners Regional Registration Office." Adding that if any among them have applied for inclusion of their names in the NRC, Hajela pointed out: They are not eligible as they have violated the relevant portions of the Citizenship Act related to the State of Assam Our main aim is to ensure a foreigners-free NRC, and there would not be any compromise on this regard." The Citizenship (Registration of Citizens and Issue of

National Identity Cards) Rules, 2003, mentions that the names of persons who came to the State after 1966 and before March 25, 1971 and got registered themselves with the

FRRO, and who have not been declared as illegal migrants by the competent authority, will be eligible to be included in the consolidated list.

Himanta Bishwa files Rs 100 cr defamation suit against ABP News

Assam's Finance Minister Himanta Biswa Sarma on Thursday said that he has filed a Rs 100 crore defamation suit against a Hindi news channel that accused him of being part of "Operation Dalal"

on operation controversy. "I am outraged by a @abpnewstv news report linking me to a person whom I have never met or known in my life," said Sarma. "[The] @abpnewsty news report has defamed me in public light. I have filed a Rs 100 crore defamation suit against ABP News before the civil judge, Sr division, Kamrup district, Guwahati.'

The news channel recently aired a report saying Sarma had close ties with Delhi-based Anuj Poddar who reportedly calls himself a "power broker". It cited "power broker". It cited evidence that income tax officials had reportedly found during a raid at Poddar's Defence Colony home for alleged tax evasion. The report claimed the officials had also found confidential papers on foreign affairs and defence at Poddar's house.

ABP News aired a report that said the state's finance minister had close ties with middleman Delhi 'power broker' Anuj Poddar.

The income tax officials sealed Poddar's house after the raid on May 27. The department has reportedly sent the case to the National Investigation

Agency. After the report was aired, former Assam Chief Minister Tarun Gogoi of the Congress dared Sarma to file a case against ABP News. "A highlevel inquiry should be initiated against Himanta for his close proximity with a 'shady person' like Anuj Poddar," said Gogoi. "If he has the guts, let him file a case against the news channel. When I had dragged his name into the Louis Berger and Saradha scam cases, then, Himanta had filed two cases against me. Now, I dare him to take on ABP News."

Krishak Mukti Sangram Samiti leader and right to information activist Akhil Gogoi said the allegations were serious. "Everyone in Assam knows that Sarma is a corrupt man," he told *Northeast Now*. "He is the most corrupt person in Assam's politics. Sarma is the main man behind mafiarisation of politics." Akhil Gogoi demanded an

inquiry by the Central Bureau of Investigation. "We have been pointing out the corruptions by Sarma in details with proper proofs since long," he said. "But the BJP has covered up his corrupt character by welcoming him in the party." Assam Pradesh Congress Committee Vice President Pradyut Bordoloi, however, was diplomatic. "I have received this news, however, I can't say to what extent it is true," he said. "But if the past of Sarma is observed then it can be said that his name had surfaced in cases like Luis Berger and Dima Hasao corruption cases. So, Sarma's involvement in this case also cannot be ruled out.'
