

Ministry of Electronics and IT to avail benefit of e-Hospital for easy access to health facilities

The Ministry of Electronics and IT, Govt. of India has complemented and selected Regional Institute of Medical Sciences, Imphal along with All India Institute of Medical Sciences, New Delhi for interaction with the Minister Ravi Shankar Prasad with persons availing benefits of e-Hospital for easy access of health facilities. This is in recognition of successful implementation of e-Hospital and automation activities in the institute. The interaction program is tentatively scheduled on 14th June, 2018 from 2 to 4 pm and the same will be telecast live by Doodardshan National. The Online Registration System (ORS) facility of OPD patients is available at the

Regional Institute of Medical Sciences Hospital (RIMS Hospital), Imphal. This facility is a part of the e-hospital program initiated by the Ministry of Health & Family Welfare, Govt. of India under Digital India program in collaboration with Ministry of Electronics and IT, Govt. of India. This facility will enable the patient to book OPD Registration from the computers or mobile phone having internet facility. The patients do not need to stand long queue in the OPD counters of the hospital. There is a separate counter for OPD patients who were registered through ORS and payment can be made either by debit or credit card or cash. 'It was against the practice of unfair means, not against housie for fund drive of local club' - Maoist

Armed rebel group Maoist Communist Party Manipur in a statement said that the earlier warning against the conduct of Housie has been misinterpreted. "Most of the leaders of the Maoist have their background from running local clubs or organizations and the Maoist knows that charity show of Courtyard play, organizing live concert and conducting housie are some means to collect fund for organizations like clubs and other civil society bodies", the Maoist statement signed by Kyonghan Mangang., Coordinator, Standing Committee, Maoist Communist Party-Manipur said. The statement however said that, the outfit only warns unfair means to the conduct of housie by cheating the

public. After the ban on such has been announced, many local clubs, organizations and other individuals had approached the outfit to restrain such decision to ban housie as it is the means for fund drive of local clubs or organization which has been doing work for upliftment of the society. The statement further said that fund drive for the club for taking up good work of the locality either by organizing housie or by organizing courtyard play or live concert by selling ticket will be supported by the outfit as long as the said do not use unfair means and cheat the people. It further added that the party had not imposed any ban on housie by local clubs or organizing concert or courtyard play for fund drive.

RAB charge baton on Chhatra Union activists, picks up Imran

The Rapid Action Battalion (RAB) on Wednesday dispersed activists of Ganajagan Mancha & Chhatra Union, back by left political parties in the capital of Bangladesh charging baton as they went out on demonstrations against 'indiscriminate murders' of unarmed people without any judicial process in the name

of 'gunfights' at Shahbagh. The convener of the platform Imran H Sarkar and two others were also whisked onto in a white microbus carrying sticker of Rapid Action Battalion and taken to unknown destination. A number of Chhatra Union (BSU) activists were also injured police baton charge. The Ganajagan Mancha and Bangladesh Chhatra Union had called human chain programmes against

'indiscriminate murders' of unarmed people without any judicial process. RAB official Emranul said Imran was detained because he was causing nuisance on the street by holding a public meeting illegally. Earlier on Sunday, police foiled Gonojagoron Mancha's protest programme against the ongoing spree of gunfights that left at least 133 people dead in the last 21 days.

NDPP refutes TR Zeliang allegations over the appointment of Nagaland State Vigilance Commissioner

Nationalist Democratic Progressive Party (NDPP) has refuted to the TR, Zeliang allegations regarding the appointment Mayang Lima as the Nagaland State Vigilance Commissioner, stating that no official procedures have been by pass or overlook to his appointment. In a press statement issued by the Media Cell NDPP, it is stated that TR Zeliang, who is the leader of the Nagaland state Assembly has no moral

authority to question the integrity and capability of the appointee in any manner. Rather, the Leader of Opposition has been producing contradictory affidavits year after year thereby insulting the Constitution of India and the laws of the country. Making a counter claim to the opposition leader the NDPP statement said that TR Zeliang claimed to be a graduate from Arts College Kohima, the Registrar of North Eastern Hill University (NEHU) and the

representative of Kohima Arts College categorically deposed in Court under oath that Mr. TR Zeliang appeared for BA Final Year Exams in 1979 but failed in all subjects. He did not reappear for the said exams ever again. On the other hand Mayang Lima is a renowned legal luminary whom Nagas as a whole should be proud of him or reaching such a revered position in the interest of transparency and accountability of the Government's day to day functioning and has had an

unblemished track record in the course of his profession and service in the Government, the statement added. "When Mr. TR Zeliang has been living in a world of lies and deceit, who is he to question the appointment of a person whose service record is an open book for the people to read in black and white?" the ruling party of the Nagaland government asked and sought apology to the people of Nagaland for misleading everyone time and again over the past couple of

decades for bringing immense shame to the Nagas when the whole country came to know that the erstwhile Chief Minister had been giving willful false affidavits on fake educational qualification without any semblance of a guilty conscience. It may be recalled that the ret'd Principal District & Session Judge, Mayang Lima had contested in the last State General Assembly election from 22 Arakong Area Constituency under Mokokchung district from NDPP ticket but lost.

High-powered team reviews situation before NRC draft published in Assam

As the Government of Assam is augmenting security measures in the state in the run up to publication of the second draft of updated National Register of Citizens (NRC) scheduled for June 30 next, a high-level team of senior administration officials and police officials on Wednesday took stock of law and order situation in districts of Bongaigaon, Chirang, Goalpara and Kokrajhar. A high-level team comprising Chief Secretary T Y Das, Additional Chief Secretary (Home) Alok Kumar, DGP Kuladhar Saikia, Special DGP Pallab Bhattacharya, ADGP

(law and order) Agarwala held discussion in Bongaigaon with senior officials of those districts besides officials of Army and Central Armed Police Forces (CAPF), an official source here informed. Deputy Commissioners, Superintendents of Police and other senior officials of those districts were engaged in the discussion by the team regarding measures to be taken to maintain law and order in the aftermath of publication of the final draft of the updated NRC. Various issues related to the NRC updating process were discussed threadbare and importance of constant interaction with people from all walks of life was stressed

to allay apprehension of public regarding the NRC updating process. The officials were sensitized on the importance of making people understand the facilities available to all in respect of submission of claims and objections for which an exhaustive awareness programmer is being launched. This was the first meeting held by the high-powered team of officials which will also visit all the districts of Upper Assam in coming days before publication of second draft of the updated NTC as per directive of the Supreme Court that has been monitoring the whole process.

Seized liquors destroyed at Jiribam

Indian made Foreign liquors seized by the Jiribam district police during the monthlong drive from various area of Jiribam which had been handed over to the Excise Department Jiribam were destroyed by burning it in public yesterday morning. The excise authority dug the ground in the back side of its

office complex located at Gularthon and burnt it inside the pitch so that no harmful gases are emitted. Among the destroyed seized liquor 205 cases of beer bottle were also included. Top officials of excise department including Deputy SP L. Raghu and officer in charge of the Jiribam Police station T. Bangkabihari were also present while destroying the liquors.

History has proven this time and again. Without a doubt in my mind and my heart, I do stand and believe in the thought that, women's full participation and cooperation in the struggle for liberation, independence, freedom, self-determination, justice, and social, political, economic, and cultural independence, is equally important and indispensable. I salute these women who sacrificed and are continuously sacrificing their lives for their countries' freedom, dignity, and independence.
