Agency New Delhi, March 28: A joint team of the Uttar Pradesh Special Task Force and Delhi Police have busted a gang of Staff Selection Commission (SSC) examination solvers who helped candidates cheat in the exams by using remote access tool softwares like Team Viewer.

Viewer. The UP STF identified the accused as Sonu Singh, Ajay Jaiswal, Param and Gaurav. Police said they have identified two other persons — Harpal and Anni

two other persons — Harpal and Anni — who are absconding. The gang would take around Rs 3 lakh to Rs 100 lakh depending on the exam from the candidates, the police said. Furthermore, the gang was also running more than ten examination centres where the candidates would cheat using the Team Viewer software.

"The accused persons would gain access to the computer systems of the candidates who paid the money. The solver would then answer all the questions using the software. When the Team Viewer software could not be used, they would take control of the computer by fixing the LAN connections with that of another computer in the exam centre and answer all the questions," DSP (UP STF) Brijesh Singh said.

SC dismisses plea seeking re-probe into Mahatma assassination

Agency New Delhi, March 28: The Supreme Court on Wednesday dismissed a plea seeking a re-investigation into the assassination of Mahatma Gandhi.

A bench of Justices S A Bobde and L Nageswara Rao, which heard the matter, dismissed the petition filed by Mumbai-based Pankaj Phadnis from Abhinav Bharat.

The apex court, which reserved its verdict on March 6, had made it clear that it would not go by "sentiments" but rely on legal submissions to decide on the petition.

The apex court had said the plea seeking retrial of the case was based on academic research but that could not form the basis to reopen the matter which happened years ago. The petitioner had questioned the 'three bullet theory' relied upon by various courts to hold the conviction of Nathuram Godse and Narayan Apte, who were hanged. He had contended that there was a need to examine whether there was a fourth bullet, which was fired by

someone other than Godse. Phadnis, a trustee of charitable trust Abhinav Bharat, had also sought the expunction of "adverse, unfounded" remarks made by the Kapur Commission in 1969 report against Vinayak Damodar Savarkar and the setting up of a commission to probe the conspiracy behind the incident

Phadnis alleged that the Maratha had a community was "maligned" due to top these adverse remarks, which Gand

should hence be removed. He said there should be a retrial of the case, which led to the conviction and execution of Godse and Apte on November 15, 1949.

The court, however, said it did not share his sentiments that Marathas have been maligned and observed, "Maratha people have survived in spite of all this. You are talking about two persons who happened to be from Maharashtra. They do not represent the state. Observation about two persons does not malign whole Marathis." Phadnis claimed in his affidavit that the alleged conspirators were hanged even before the murder trial had attained legal finality from the transmitted the state.

range in New Delhi on January 30, 1948, by Godse, a right-wing advocate of Hindu nationalism. The assassination case had led to the conviction and execution of Godse and Apte on November 15, 1949. Savarkar was given benefit of doubt due to lack of evidence.

UN chief urges Saudi prince to seek political solution in Yemen

Agency United Nation, March 28: Saudi Arabia today presented a USD 930 million check to the UN for humanitarian aid in Yemen as the UN chief pushed for an end to the war in which Riyadh leads a military coalition.

United Nations Secretary-General Antonio Guterres thanked Crown Prince Mohammed bin Salman for the contribution, but stressed that the war in Yemen requires a political solution, and not just a humanitarian response.

"There is no humanitarian solution for humanitarian problems," Guterres said after receiving the check, which also came from the United Arab Emirates.

United Arab Emirates. The Emirates plays a major role in the coalition, which intervened militarily three years ago to support

backed Huthi rebels. Civilian casualties from coalition air strikes have drawn criticism from rights groups, and in October the UN placed the alliance on a "blacklist" for killing and maiming children. Riyadh insists the coalition respects

its obligations under international humanitarian law. "The solution is political and we are

The solution is pointed and we are entirely at your disposal to work to find a solution" that will "end the suffering in Yemen," Guterres said. The United Nations is making a fresh push for peace talks in Yemen, where the coalition acted to support the internationally-recognized government after the Huthis seized the capital. About 10,000 Yemenis have been

Centre seeks report from West Bengal government on violence during Ram Navami

New Delhi, March 28: The Centre has sought a report from the West Bengal government on incidents of arson and violence during Ram Navami processions in the last two days and offered assistance to deal with the situation, an official spokesperson said.

In a communication, the ministry of home affairs asked the West Bengal government to send a report about the incident, the steps being taken to restore normalcy and the action taken against those involved in the violence.

The injured included several policemen with a senior police officer losing a hand after a bomb was hurled at him during a clash in Raniganj area.

The state government has ordered heavy deployment of police force in violence-hit areas, besides lodging several cases of arson and rioting.

The UN chief has appointed a new peace envoy, Martin Griffiths, who was in the rebel-held capital Sanaa this week for talks on kick-starting the political process, following a first round of meetings in Riyadh. UN diplomats believe the new effort

UN diplomats believe the new effort could succeed because Iran has sent signals that it is willing to pressure the Huthis to seek a settlement.

Guterres will travel to Geneva for a donors' conference hosted by Switzerland and Sweden to raise funds for Yemen.
