Deputy Chief Minister inaugurates Grid Connected Roof Top Solar Power Plant

DIPR Imphal, May 16,

Deputy Chief Minister had inaugurated connected roof top solar power plant at office premise of United Club & Library (UCAL), Uripok Khwairak Selungba Leirak in Imphal The power plant will generate power from solar energy for street lighting has been installed by Manipur Renewable Energy Development Agency (MANIREDA), as a part of the ongoing solar energy generation project jointly undertaking with Manipur State Power Distribution Company Limited (MSPDCL). The plant has a capacity to generate five Mega Watts of power and will provide power to around 80 street lamps in the area. Speaking at the function, Jeputy Chief minister said.

35 different sites in Uripok Assembly Constituency have been identified to install such solar power plants for the first phase. As of now, 12 plants have been installed and have started power generation. 11 more plants will also become functional within three-four days. He further said, such power plants can be helpful in generating clean energy and excess energy can be transmitted to MSPDCL, which in turn generating revenue. Stating that under the ambitious project, almost all places in his Constituency will be covered in phase wise manner, Shr Joykumar Singh said, installation works of the first phase will be completed within 30° of June this year. He said, in the first phase, public places like community halls, clubs and institutions



will be covered. 70 per cent of the total expenditure required in installation of the plants will be borne by MANIREDA. He appealed to the people to extend support while identifying places where it can be installed and to avail such benefits which will be helpful in overall development of power generation in the State.

He said, under Renewable

Purchase Obligation (RPO), 8 per cent of the total power generation in the state per year will be from solar energy and steps are being taken up to generate more and more solar energy to meet the target. As of now, around 6.2 Mega Watts of power can depart of 40-50 Mega Watts per year. The Fate of Press Freedom in India Over the Years

The hyperbole of emotive adjectives did not die down even in 2007-08 as India came out almost untouched by the global meltdown. And in time it was a habit to mix views with news and excitement with facts, where even the presappeared almost starry-eyed by the grandeur of the Narendra Modi campaign lapping up the size and comparison with the presidential elections of the US.

As all of this happened, not necessarily in an absolute sequence, the realities of running a business hit several media houses. Some opted for private treaties and others openly allowed paid news legitimising the same with a pricing menu. Others sold their equity to large industry. With no policy framework in place, this was waiting to happen. Such incidences, for example, allowed the Reliance Group to wom the Network 18. It was

called a 'bail out' for the then promoter, Raghav Bahl, but it eventually cost the large corporation a voice and say in public opinion. Coupled with the growing reality of cronyism between industry and governments, the media was quietly emerging as a critical weapon that the two could share in a self-serving manner. It is no wonder why corporates have bought into or bought out several media houses.

Surprisingly, the respected media man N. Ram, was quoted in *The Hindu* last October saying, "Nobody has figured out a viable business model for quality journalism". While quality of journalism has to improve significantly, why should there be a business model if the media is the Fourth Estate and critical pillar of democracy? Think of it—the government runs without profit and loss as its prime criteria. It is to govern

and provide certain services. The same applies for the judiciary and the legislature in different measure. The fourth pillar should remain unobliged and unapologetic if it is to remain free with a purpose of service to the nation.

But heak to today's realities.

But back to today's realities where press freedom or the lack of is not limited entirely by ownership or a failing quality of journalism or how the law on defamation is used. Fear is a critical component that curtails freedom. At one level it is the fear that the State might go after you for reporting on an issue that damages their image or questions their credibility. At another, the fear that the management might boot you out because you chose to carry two sides to a story, or questioned a policy that probably the owner had some interests in. In both situations. self censorship kills freedom And if there are a string of

deaths of journalists while at work or losing their job because they disagreed with a management diktat, then the fear runs deep and cages expression and consequent plurality. So the matter before us is not

The NEOS represents the students community of the entire region belonging to different languages and religions submit the memorandum to express our dismay and displeasure for bringing the proposal Bill. The NESO represents the students' community of the entire region belonging to different languages, different tribes, different communities and different religions.

Sir, we feel that the North East Region remains a distant place for the Union government. The Union government do not understand our problems and our aspirations. Our social structure, our history and our cultural values are unknown to the rest of the country.

The proposed Bill is the latest example that the lawmakers of the country have no regard for our future of the North East Region.

The entire North East Region is infested with foreigners from the erstwhile East Pakistan and, now, Bangladesh. They have infiltrated into and polluted every aspect of our social life. The politicians have supported them to threaten identity of the indigenous people of the region. All the states have suffered badly due to the illegal flow of the foreigners without any hindrance.

The content and purpose of the Bill have shocked the people of the North East Region. People are wondering how the government of India could think of introducing such a Bill. We have no doubt that the proposed Bill is an attempt to impose the burden of the post-1971 Hindu Bangladesh in the entire

region, in general and on Assam, in particular, of they are allowed to stay in Assam, they will spread to the entire region in course of time.

The proposed Bill defeats the very purpose of signing the

We all have a responsible to avoid such a potentiality. We request the honourable Committee to remember that we are speaking on behalf of the entire students' community as well as people of the whole region. The illegal immigrants have

systematically occupied the government land, the forest land and tribal land in every state if the region. The ethnic communities have suffered politicially and socially. The Assam Accord has promised to evict the illegal immigrants from these area. The promised in the Assam Accord the post-1971 foreigners from Bangladesh should be detected and deported without any further delay. The presence of several dozens of lakhs of foreigners from Bangladesh is harming the economy of the state, it is affecting the entire region The indigenous population of Tripura was outnumbered by the illegal migrants from the erstwhile East Pakistan and Bangladesh. Tripura has already lost its tribal identity.

The proposed Bill is another effort to encourage infiltration of the Hindus from Bangladesh into the different states of the North

East Region. We shall resist creation of another Tripura in any part of the North East Region.

We request our lawmaker, the honourable members of the Committee to appreciate our effort to strengthen fabric of the country. Religion might have played a part at the time of creation of India and Pakistan. But the Indian Constitution was prepared in a secular framework. Religion was not allowed to play any part in the making of our Constitution. The proposed Bill is antithesis to secular idealism of India. That region was a factor during partition and so religion should be a criterion to decide citizenship is a false notion.
