party. Peoples' eyes were to Thanga Assembly constituency MLA T. Robindro until he himself clarified the matter yesterday and until the family members of the minor rape victim disclose that the politician who have been threatening and interfering to the investigation of the case is the

While talking to group of reporters yesterday at the victims residence, father of the 25, one masked men also came 25, one masked men also came to the campus of chief judicial magistrate, Bishnupur and threatened the victim by showing a gun, while she was waiting for her hearing to give her statement, sitting inside a vehicle.

'Appointment of Rapist MLA as Chairman of a labour board is an insult to women community'

Socialist Students Union Manipur (SSUM) and Proletariat Feminists Movement (POFM) today said that appointment of a rapist MLA as the Chairperson of the Manipur Building and other Construction Workers Welfare Board is an insult to not only to the women community of the state but also to the people of the state in general.
Talking to media persons,

Naorem Tonaranjan, Convenor SSUM, said that FIR has been lodged against the MLA by the victim girl and following the complaint a case hearing is being underway but have been delayed as police

still fails to submit chargsheet against the MLA.

The students body convenor said that the victim girl complaint to the Women Police Station of Imphal West Police Station of Imphal West alleging rape and cheating on June 19, 2017. As per the FIR No. 12/(6)2017 the accused Heikham Dingo, who is now the MLA of Sekmai Assembly Constituency is punishable under section 376/417 of the Indian Penal Court.

The court case is still pending as the police still is yet to submit a charge sheet regading the case. SSUM and POFM while

talking to reporters said that all those culprits responsible in rape crime should be punished as per the law of the

land while adding that in certain case which involved high ranking powerfull people are involved the two bodies will not remain quiet. Both the bodies threaten stern agitation if the government fails to expel Sekmai Assembly Constituency MLA before 20

of this month.
Tonaranjan also appealed all sections of people to support in rendering justice to the

victim of rape. The two organisation also announces series of agitation that will be taken up in the following days in consultation with other like minded civil bodies and also with political parties of the state to bring the issue to the notice of the Prime Minister of India.

Civil societies in Manipur protest RN Ravi's statement published on Indian Express

Representatives and United volunteers of United Committee Manipur (UCM), All Manipur United Club Organisation (AMUCO) and CCSK today staged a protest demonstration demanding clarification of the statement reported in National Daily Indian Express in its April 26

Base on official source. The Indian Express had reported that the Naga Accord is nearly final. The report also stated that the agreement will not change the boundary of states but will provides autonomous Naga territorial councils for Arunachal and Manipur: common cultural body for Nagas across states besides setting up of specific institutions for state's development, integration and rehabilitation of non-state Naga militia and the removal of the Armed Forces Special Powers Act. Ravi, who signed the framework agreement with National Socialist Council of Nagaland (Isak-Muivah) or NSCN-IM in August 2015, while talking to Indian Express had stated that the accord is nearing final stage and the Indian Express quoted him as saying "Yes, we are pretty close to finalising the (Naga Peace) accord" without saying any comments to the report about the formation of the autonomous Naga territorial councils for Arunachal and Manipur. Which indicated that the report stands true. Ministerial team inspects illegal River banks encroachers

DIPR Kangpokpi, May 17,

A team of Cabinet Ministers including Revenue Minister, KaramShyam, Water Resources Minister, LetpaoHaokip, TA & Hills Minister, N. Kayisii and Social Welfare and Cooperation Minister, NemchaKipgen, today inspected illegal encroachers at river banks located in and around Kangpokpi District.

Briefing the media during the visit, Water Resources Minister, Letpao stated that the new government is committed in clearing any illegal construction in riverbeds for long-term safety of the masses. On the other hand, the government, through respective DCs has given prior notice that no construction should be set up in river beds under the Manipur Flood Plain Zoning Act 1978. He appealed the general public to take the initiative of the government in a positive light and to co-operate with the government in this constructive developmental work.

And, for those areas that have not been covered, it is due to the reason that the inhabitants have brought their land documents (pattas) and due verification of the papers is being done, hence the delay in the completion of dredging in some areas.

Letpao asserted.

Minister Letpaoalso reminded the public that no constructions can be made in the river bank under the Manipur Flood Plain Zoning Act, 1978 and the Manipur Land Revenue Reforms Act. He appealed the public not to dispose garbage and plastic materials in the river and to materials in the river and to dispose it at the proper places given by the Municipality. He also asserted that the public must support and co-operate with this initiative of the government in the larger interest of the general public and to achieve the objective of preventing floods for long term.

He further stresses on the fact that the government always has serious concern for the frequent floods faced by the state, especially during last year and has been discussing for a long term plan to combat this problem. The dredging work is a result of that discussion. The dredging is almost completed for valley armost completed for variey area and has now reached to Nambol side and WaiselMaril stretch, he added But full result of it cannot be seen due to blocking and narrowing of the river at YangoiKarong and Upokpi area. So, cleaning of river bed in that portion will also be done soon.
