Are the investigating team of Thanga rape case trying to silence the minor victim? YFPHR condemns unethical interrogations of minor sexual assault victim

Pressure from NGOs, students' body and Rights activist have finally handed over the controversial Thanga gang rape case to Crime Branch, however, the Branch, however, the handling of the case by the Crime branch authority once again is sceptic of delivering justice to the minor victim as the interrogation conducted to the minor victim appeared more like lack of professionalism and training as the victim girl fainted twice on two different occasion unable to bear the question. On May 24 a team of the crime branch along with lady police came to the victim's family and interrogated the minor victim for over two hours and due to lack of training how to create friendly environment in

dealing with minor sexually assaulted Children the victim minor fainted and was rushed to the District Hospital Bishnupur. The father of the victim girl even though was not happy on the way the team interrogated could not say or complaint anything as he have no idea of the law.
"I am not happy these police

people are interrogating my daughter who is already in state of trauma", the victim's father told over phone to one of his friend. He further said that he could not said anything as he assume it as normal

The nature of investigation being carried out by the State Police dealing with Thanga Gang Rape case is vehemently condemn by Youth's Forum for Protection of Human Rights (YFPHR). The forum said that the investigation team failed

to maintain the child friendly environment but created an environment of interrogation of criminals beside a member of District Child Protection Unit, Bishnupur was present. "Failure in maintaining child friendly environment by the lady Police Officer clearly indicates that the State Police dealing with the cases have not been trained properly on how to deal with a minor

sexual assault victim and also indicates to victimize the victim not to reveal the case but to stay silent", the Forum

The Forum asked the team. "how many more statement of the victim girl is in need to be recorded besides repeated recording of 161 statements by the WPS Bishnupur in the first instance, also by the Special Investigation Team

which was formed to times recording of 164 statement by the court and also attempt to record another statement by the present investigation team. YFPHR suspect that it is an attempt to victimize and suppress the victim girl by the Investigation Team of the case having nexus with Political influences and the accused family members like earlier".

It could be noted that the

victim girl was fainted due to PTSD on the 26th of April, 2018 while present for the 2nd time recording of 164 statements and on 24th May, 2018 recording of statement by the present Investigation Team as the Lady Police Officer had used harsh words and had heated argument with the victim girl, where we believe that the Investigating Officer

was trained to harass the girl on how to deal with a minor sexual assault victim, the forum alleged.
The YFPHR also condemn the

District Child Protection Unit, Bishnupur for keeping silent besides knowing the fact of such ill treatment by the Lady Police Officer in front of its members who is responsible to protect the rights of the child or the victim. YFPHR urge

YFPHR urged the Investigating Team to stop meeting the child and harassing her in the name of recording statement as the Investigation Team has much statements to review the earlier statement Provided and would like to appeal the CM, DGP and Social Welfare Minister to punish the Lady Police Officer for harassing the

Polling for by-elections to 4 Lok Sabha & 10 Assembly constituencies spread over 10 states held today

Polling is underway for by-elections to four Lok Sabha seats and 10 Assembly constituencies spread over 10 states. Voting began at 7 this morning amidst tight security. Lok Sabha seats where bypolls are being held are Kairana in Uttar Pradesh, Palghar and Bhandara-Gondiya in Maharashtra and the sole parliamentary constituency in Assembly constituencies

where bypolls are being held are Noorpur in Uttar Pradesh, Shahkot in Punjab, Jokihat in Bihar, Gomia and Silli in Jharkhand, Chengannur in Kerala, Palus Kadegaon in Maharashtra, Ampati in Meghalaya, Tharali in Uttarakhand and Maheshtala in West Bengal.

In Nagaland, 60 percent of voters cast their votes till 1 pm in bypoll to the lone Lok Sabha Parliamentary Constituency. Chief Minister Neiphiu Rio cast his vote at a polling booth at Touphema Basa village, around 25 km from the state capital,

around 10 am, sources said.

The ruling People's Democratic Alliance (PDA), which has the NDPP and the BJP as it major constituents, has fielded former from the seat.

Yepthomi is pitted against Opposition Naga People's Front (NPF) nominee C Apok Jamir. The Congress has also extended its support to Jamir. Altogether 11,97,436 people are eligible to exercise their franchise at 2196 polling stations across the Nagaland Chief Electoral Officer Abhijit Sinha said.

Voting began at 7 AM and will go on till 4 PM in 1887 polling stations, while it will end an hour ahead in 309 booths, the CEO said.

"In 309 booths, set up in faraway places with barely any transportation facilities, the polling will end at 3 PM for the convenience of the election

officials," he said.
Altogether, 40 companies of
Central Armed Police Forces along with 80 companies of Nagaland Armed Police, 770 Home Guards and 2600 village

and fair polls, Sinha added.

The bypoll was necessitated after Rio, who is also the Nationalist Progressive Party (NDPP) leader. resigned as a Lok Sabha member in February, days before the assembly polls.
Polling is also underway to the

Rajarajeshwari Nagar Assembly constituency in Karnataka. The election was postponed after thousands of voter cards

along with around one lakh counterfoils were seized from a house in SLV Park View

As alternative, renewable sources of energy to be opted: Dy CM

DIPR Imphal, May 28,

Deputy Chief Minister Yumnam Joykumar Singh said, renewable sources of energy should be opted as an alternative to meet energy requirements in the state. He as speaking at the inaugural function of grid connected roof top solar power plant with generation capacity of five kilowatts, at the Community Hall of Uripok Ahanthem Leikai Development Organisation in Imphal today. Deputy Chief Minister said, non-renewable energy sources like fossil fuels would sources like fossil fuels would be exhausted after some decades but renewable sources like solar energy will last long for decades. He said, with the increasing population, energy consumption level has also been increasing day by day. To meet such energy requirements, solar energy which can be generated using abundantly available sun light should be encouraged. Joykumar Singh further said that street lighting or domestic uses of power can easily be generated if roof top solar



panels are installed. Besides this, excess energy generated from the plant can also be sold to power grid thereby generating revenue as well. Stating that, the project which is jointly taken up by MANIREDA and MSPDCL will definitely help in providing energy requirements in the state, Deputy Chief Minister said, almost all areas under Uripok Assembly Constituency will be covered under the project and street lighting in the areas will be completed within June this year. He said, once street

lighting is completed, it willbe helpful in controlling crime and related activities. He appealed

people to co-operate with this initiative to encourage solar

energy generation in the state.

Director, MANIREDA Shri L Manglem Singh also spoke on the importance of solar energy in helping to provide energy requirements in the state. He said, under the project, 70 per cent of the total cost for installation will be borne by MANIREDA. Only the remaining 30 per cent will be borne by the individual or the company or firm who have applied for the work. He urged people to co-operate with MANIREDA and also asked them to apply through website for installation of solar power

Earlier today, Deputy Chief Minister inaugurated a grid connected roof top solar power plant of five kilo watts at Satjal Academy near Uripok Cheirap Court in Imphal.
