# 2 Congress RS MPs move SC challenging Venkaiah Naidu's rejection of removal motion against Chief Justice

#### Agency New Delhi, May 7

Two Rajya Sabha (RS) Congress party Members of Parliament (MPs) today moved the Supreme Court challenging the Rajya Sabha chair Venkaiah Naidu's decision to reject the removal motion against Justice of India Chief Dipak Misra

They challenged the decision, they said, because the removal motion was signed by more than 50 MPs, which is what is constitutionally required, and yet Naidu rejected it.

The petitioner MPs Pratap Singh Bajwa from Punjab and Amee Punjab and Amee Harshadray Yajnik from Gujarat - in their joint petition said that once a removal motion is signed by the requisite number of MPs the RS chairman has no option but to constitute an inquiry committee to investigate the charges against the CJI. On April 23, Naidu rejected Congress-led the opposition parties' notice to remove the CJI saying it lacked substantial merit. "Having considered the material contained in the notice of motion and reflected upon the inputs received in my interaction with legal luminaries and constitutional experts. I am of the firm opinion that the notice of the motion does not deserve to be admitted. Accordingly I refuse to admit notice of motion," said Naidu.

'I have applied my mind to all five charges made out in impeachment motion and examined all annexed documents. All facts as stated in motion don't make out a case which can lead any reasonable mind to conclude that CJI on these facts can be ever held guilty of misbehavior," said Naidu further.

# Murder during birthday party at Delhi Bar in fight over song, DJ arrested

### Agency New Delhi, May 7

A voung man celebrating a birthday at a bar in Delhi was murdered after an argument with the DJ over a song request on Sunday night. A full-blown bar fight erupted at Raftaar in Punjabi Bagh in west Delhi following an argument. Ishmit in his mid-20s was

celebrating with 10 of his friends on the third floor of the building. The argument started when one of his friends, Vijaydeep, went to the floor above and asked

the DJ, Deepak Bisht, to change the song. Bisht reportedly refused, which led to shouting and blew up. As Ishmit's friends fought with the DJ and other bar staff, chairs were flung and beer bottles were smashed and used as weapons, witnesses told the police. Vijaydeep, a gym instructor was stabbed inside the bar during a birthday party The DJ allegedly took out a knife and stabbed Vijaydeep, who died on the spot. By the time the police arrived, most

### Man caught smuggling 100 iPhone X models at Delhi Airport buybacks as a way of

### Agency New Delhi, May 7

At the Delhi Airport, a man was arrested by the customs for allegedly trying to smuggle 100 iPhone X models into the country. The 53-year-old accused was intercepted by the customs after his arrival from Dubai on Friday. Apple iPhone X is one of the most expensive ensive flagship artphones in the country right now.

The base model of iPhone X with 64GB storage retails at Rs 95,390 while the higher version with 256GB storage retails for Rs 1,08,930. "Hundred iPhone X handsets worth a total of Rs 85.61 lakh were seized from his baggage after a thorough search," said Amandeep Singh, Additional Commissioner of customs at the airport.

Strategy Research firm Analytics reported that Apple sold 16 million units of iPhone X during the first quarter of 2018. It was also the most successful smartphone model in terms of sales during the quarter ending March 2018

Last week, Apple announced record results during fiscal 2018 second quarter ending March 31, 2018. It posted a quarterly revenue of \$61.6 billion, a jump of 16 percent from the same period last year. The record quarter was mainly driven by \$38 billion in revenue from sales of 52 million iPhone during the quarter. Apple said international sales accounted for 65 percent of the revenue. "Customers chose iPhone X more than any other iPhone each week in the March quarter, just as they did following its launch in the December quarter We also grew revenue in all of our geographic segments, with over 20 percent growth in Greater China and Japan," CEO Tim Cook said during the

earnings call. Apple also announced \$100 billion in additional stock

reassuring that iPhone sales are not off the cliff yet. The results last week topped most estimates by Wall Street analysts, who had a cast over Apple's continued success in the smartphone market. However, in India, Apple still continues to struggle due to the already high price of iPhone and the recent hike due to an increase in import duty on CBUs (completely built units) to 20 percent. Apple, however, remains confident of success in India in the next few years as it expands its manufacturing efforts in the country. There is no word on whether

this man brought 100 units of iPhone X with an intention to sell them in the grey market. One thing is clear, the overall price for these devices would have been way cheaper than the operating price of iPhone X in India.

## SpaceX's powerful rocket tech could put lives at risk: NASA advisors

#### Washington , May 7

An approach used by SpaceX to make its Falcon 9 rocket more powerful could put the lives of astronauts at risk, NASA's safety experts have warned. To make the Falcon 9 rocket even more powerful, SpaceX came up with the idea of keeping the propellant at super-cold temperatures to shrink its size, allowing them to pack more of it into the tanks. But the approach comes with a major risk, The Washington Post reported on Saturday citing the experts.

The new approach requires the propellant to be loaded just before takeoff, while astronauts are aboard, but an accident during this manoeuvre, known as "load-and-go," could set off an explosion.

As NASA and SpaceX prepare to launch humans into orbit as early as this year, one watchdog group labelled load-and-go a "potential safety risk," the Post reported.

In a letter, a NASA advisory group warned that the method was "contrary to booster safety criteria that has been in place for over 50 years. SpaceX suffered a setback in September 2016 when a Falcon 9 rocket blew up while it was being fuelled ahead of an engine test. As a result of the explosion, a multi-million dollar satellite was lost. Although no one was hurt in the incident, it raised safety concerns in the minds of the

# Blackbuck poaching: Salman Khan bail plea hearing adjourned until July 17

Salman Khan's bail plea hearing in the 1998 hearing in the 1998 blackbuck poaching case was on Monday adjourned to July 17 by a Jodhpur trial court. The Bollywood actor arrived in Rajasthan's Jodhpur on Sunday afternoon to appear before the court. Khan had on April 5 been convicted in the 19vear-old case and sentenced to five years in jail for killing

two blackbucks in Jodhpur during the shooting of the 1998 movie Hum Saath

Saath Hain. Subsequently, Salman was granted bail after spending two nights in the Jodhpur Central jail. Salman's Hum Saath Saath Hain co-stars Tabu Sonali Bendre Saif Ali Khan and Neelam and Jodhpur resident Dushyant Singh, another accused in the case, were all acquitted due to lack of evidence. The blackbuck case is not

the only instance of legal trouble Khan is facing. Also in April, a Mumbai court cancelled the bailable warrant against Khan in connection with the 2002 hit and run case. The court had issued the bailable warrant as Khan had not completed the procedure of providing surety on the past two dates. Further, a Ludhiana court on May 1 rejected a petition against Salman and Shilpa Shetty that sought action against them under the SC/

ST Act for allegedly using derogatory words against the Valmiki community. In the same case, the Supreme Court on April 23 put on hold proceedings pending against Khan before several courts across the country in cases registered under the SC/ST Act. Salman is set to be back on

## Lunar rock points to hidden water reserves on Moon

Scientists have found a mineral in a lunar meteorite that points to the presence of abundant hidden reserves of water ice under the surface of the Moon which could be potentially useful for future human exploration A team from the Tohoku University in Japan found the mineral, called moganite, in a lunar meteorite discovered in a desert in northwest Africa.
