### Satellite-tagged Amur falcon 'Tamenglong' reach Somalia after 5 days non-stop flight from Manipur

Finally satellite-tagged female Amur falcon 'Tamenglong district of Manipur which was among tens of thousands of Amur falcons after taking shelter in north east states, reached her stop-over site in Somalia after five days non-stop flight covering about 5700 km from northeast India, Scientist Dr R Suresh kumar of Wildlife Institut of India (WII), Dehradun

Terming 'Tamenglong's flight was an epic journey of five days and 8 hours,Dr Suresh kumar who had been tracking the bird through the satellite data when contacted said 'Tamenglong' reach in Somalia around 1 pm (Indian time) on Saturday (November 24). "Now she must be exhausted and likely to spend few days there in Somalia," he said. "I am hoping that she will continue to transmit data that is her location and keep us all excited.'

A WII team in collaboration with Forest department and biologists from Hungary fitted radio transmitters to 'Tamenglong' along with 'Manipur,' a male bird for the first time at a roosting site at Chiuluan village in Tamenglong district of Manipur on November 5. started non-stop 5, started non-stop migratory journey from November 19.But 'Manipur' could not join trip to Somalia after he was killed by unidentified miscreants somewhere in Tamenglong district on

Tamenglong being an adult female and she must have made the Arabian Sea crossing many times before. So is 'Longleng', another satellite fitted female Amur falcon who made her fifth flight over Arabian sea after fitting the satellite transmitter in November 2016.

'Longleng' which started her journey from Assam-Meghalaya border on November 19 reached Somalia around

5 pm on Friday(November 23), the WII scientist who had so far tagged ten birds since 2013 said. "However she continue to move and is currently located close to the famous Tsavo East National Park (one of the oldest and largest National Park) in Kenya where she is likely

From now on the two falcons will make regular pit stops during their next phase of migration that will be another 5000 km journey to their wintering destination in South Africa, the scientist adding that tracking of migratory birds particularly the Amur falcon helps to understand the bird and conservation activities because through its migratory route one can study the environmental

cue including wind pattern etc. Besides you can feel the geography of different landscapes including various wildlife protected areas of the World

Interestingly after the media exposure on its conservation initiatives. people in the country are now somehow connected with Amur falcon (Falco amurensis), one of the least known migratory birds among 69 falcon species, which visited India's northeast states from Russia and China for food(termite,insects etc) and shelter during winter annually.

Whenever someone in other parts of the country including Maharashatra or Goa spotted Amur falcon in their areas, they will click a photograph and felt the pride of witnessing the live bird, he stated and lauded continuous

conservation efforts by the people of Tamenglong,Noney in Manipur and Longleng and Wokha in Nagaland.

## Tripartite MoA signed for export of 15 Mt organic products

DIPR Imphal, Nov. 25

Memorandum Agreement (MOA) was signed today between the Manipur Organic Mission Agency (MOMA), Diocesan Social Service Society (DSSS), Imphal and Riverbeki (OPC) Private Limited, Guwahati in presence of Horticulture and Soil Conservation Minister Thounaojam Shvamkumar.

Addressing the media persons at his New Secretariat office, Minister Th. Shyamkumar said that a tripartite MOA has been signed for exporting organically produced 15 MT (metric tonne) dried ginger and turmeric. He hoped that the initiatives of MOMA under the aegis of Horticulture and Soil Conservation Department will benefit the organic

farmers of the State.
Encouraging the organic farmers of the State to continue to work hard to increase the production, he said that the farmers need not worry to find a market place to sell their produces/products and assured full support from the department. Stating that the buyers will export the products of Manipur in Europe and other countries, he said in the near future the State will

try to export more quantity of products, maintaining the quality of the products.

Minister Shyamkumar further said that the various initiatives are taken by the Horticulture and Soil Conservation Department with a mission that Manipur can become an organic state Stating that the products produced in the State has a unique taste, he hoped that the buyers and consumers will increase the demand of the products thus helping in the economy of the State. He appealed to all the stakeholders including the farmers to fully cooperate to make Manipur a chemical free state and put a name in the global map in the field of organic produces/ products.

K. Debadutta Sharma Project Director, MOMA said that the MOA signed today will benefit 2,000 ginger farmers and 2,500 turmeric farmers of the State. He hoped that the initiative will surely encourage the organic farmers to increase their production and boost their morale.

Speaking on technical issues, he said earlier the organic farmers of the State faced problems of finding a market place to

sell their organic produces/products. He said at present the department is lacking in infrastructure such as grading of the organic produces, shorting out of organic produces, cleaning and packaging

of the products.

He hoped that once the infrastructural requirements are cleared, the State can easily export the products worldwide. He further informed that within next month e-auction of organic produces will be done under the Ministry of Steel and appreciated the higher authorities of the Horticulture and Soil Conservation Department for their cooperation with the MOMA. tripartite

memorandum agreement was signed by Prajnan Kumar Roy, Director, Riverbeki (OPC) Pvt Ltd., Guwahati; Avince Anthony Dilbung, Director, Diocesan Social Service Society (DSSS), Imphal and K. Debadutta Sharma, Project Director, MOMA under the aegis of Horticulture and Soil C o n s e r v a t i o n Department.

Speaking on the sidelines of the press conference, Minister Th. Shyamkumar who also holds the portfolio of Forest and Environment appealed to all to stop illegal construction in and around the Loktak Lake as it can adversely affect the fresh water lake, which is the largest in the entire North East region.

Forest and Environment Minister Th. Shyamkumar appealed to all to stop using unconventional method of fishing in the Loktak Lake using battery and other electronic devices which are damaging the eco-system of the lake. He also appealed to stop the constructions buildings including hospital, school among others without getting clearance from the authorities concerned. He said any such illegal construction in and around the Loktak Lake will attract legal action. The Minister firmly stated that there can be no development at the cost of the environment.

He also clarified that the conventional method used by the residents in and around Loktak Lake and around Loktak Lake for livelihood is allowed including boating considering the hardships faced by them. He appealed to the locals and others to stop any illegal construction and activities which can harm the ecological balance of

# Bangladesh: Writ filed seeking stay on 11th parliamentary election

Dhaka, Nov 25

A writ has been filed with the High Court seeking a stay on the announced schedule of the 11th parliamentary election of Bangladesh.
Eunus Ali Akond filed the

writ with the bench concerned of the High Court on Sunday morning. The HC bench of Mainul Islam Chowdhury and Mohammad Ashraful Kamal is likely to hear the writ anytime today, says

The petitioner also sought the issuance of a rule to declare the schedule as illegal as it was announced without dissolving the national parliament as well as a stay on the election procedure until the issue is settled.

The chief election commissioner, cabinet secretary, law secretary and four others were made respondents to the rule. According to section 66 of the constitution, a person should be disqualified for member, if a person holding any office of profit in the service of the republic or of a statutory public authority, the petitioner

According to constitution, he further said, those who enjoyed government perks and privileges could not contest any election. 'Now ministers and MPs of the present parliament are enjoying government perks and privileges, and they are going to contest

the election, which is contradictory to the Bangladesh: Writ filed seeking stay on 11th parliamentary election constitution, he added. Besides, if the election

was held without dissolution of parliament, there would be two parliaments after the election, and the number of MPs would stand at 600. But, according to section 65 of the constitution, the number of parliament shall be 300,' he added.
