## After week-long student protests, Raipur law university V-C resigns

The vice-chancellor of Hidayatullah National Law University (HNLU), Raipur, resigned Monday, after week-long protests, including a hunger strike during the day, by students demanding his ouster. The students had accused Vice-Chancellor Dr Sukh Pal Singh of allegedly not acting on complaints of sexual harassment, indulging in financial irregularities, a lack of transparency and maladministration. The university

The university administration had denied the charges against the VC and had put out a 17-page rebuttal countering them. "He (Singh) had ignored academic interests over his seven-year tenure. There is rampant corruption and he rampant corruption and ne dismissed grave complaints of sexual harassment," said Abha Dixit, the protest coordinator, HNLU. "That professor (accused of harassment) is still teaching

students." The Student's Bar Association (SBA) had collected 800 signatures from a body of 950 students to push for Singh's resignation.

issue had been simmering for a while. In August, the Chhattisgarh High Court had quashed the 2014 extension granted to Singh, who was first appointed to the post in 2011, on the grounde of on the grounds of irregularities in the procedure of appointment. Ravishankar Sharma, the principal secretary in the state Law Department, had then taken over as interim VC. On 20 September, however,

the Supreme Court issued an interim stay on the month-old high court order following which Singh resumed office as VC

### The allegation-response tussle

tussle In its 17-page response, issued on 30 September, the university had specific counters to the charges made by the students.

by the students. On "rampant corruption", the students claimed that an audit report, prepared after corruption charges were made against the V-C in 2016, had not been tabled in front of university's decision-making authorities because it may contain "embarrassing"

information. The university, however, countered it by stating copies of the special audit inspection report along with comments of the vice-

VC Sukh Pal Singh had been accused of inaction in cases of sexual harassment, financial irregularities and maladministration.

chancellor had been sent to a panel comprising of "Justice A.M. Sapre, judge, Supreme Court of India, Justice Deepak Gupta, judge, Supreme Court, and the V-C vide letters dated 12 April

2018" Using a case from August as an example, the students had accused Singh of adopting a "casual attitude towards complaints of sexual harassment".

The university, however, notes that while students made a complaint in person, no written follow-up was submitted. The case has now been

referred to the "newly-constituted internal complaints committee", the university said. You can read the full response here. The students, however, claim

They have passed the buck There are at least three issues where it was interim VC R.S. Sharma who ordered the changes, except that Singh is claiming them as his decisions", said Achyut Tiwari, public relations head, SBA. The three instances include

uploading university documents regarding minutes of the authority meeting, moot paper and research paper funding, and constituting an internal complaint committee.

"The reply doesn't even address the money allocated for the production of the college song. What happened to those Rs 2 lakh," asked Tiwari.
