# Assam Citizenship Act: JD(U) set to back AGP opposition to Bill BJP supports

### Agency New Delhi Oct. 3,

The Janata Dal (United) has pledged its support to the Asom Gana Parishad (AGP) on the issue of the party's opposition to the Citizenship (Amendment) Bill, 2016, which has set the regional party against ruling alliance partner BJP in Assam. Introduced in Lok Sabha in

July 2016, the Bill is currently with a Joint Parliamentary Committee. It is likely to be taken up during the Winter Session of Parliament.

The Bill envisages crucial changes in Citizenship Act, 1955, making undocumented immigrants — Hindus, Christians, Buddhists, Sikhs, Jains and Parsis from Afghanistan, Pakistan and Bangladesh — who had come to India before December 31. 2014, eligible for grant of

citizenship. An eight-member AGP delegation had met Bihar Chief Minister and JD(U) president Nitish Kumar in Patna over the weekend and sought the party's support against passage of the Bill. JD(U) secretary-general K C Tyagi, who was present in the meeting, told The Indian Express, "Nitishji told the AGP leaders, 'we are with

you'." If carried through, the Bill would facilitate settlement of Hindu immigrants from Pakistan, Afghanistan and

Bangladesh in Assam and other north-eastern states. "This would lead to a demographic change in the entire region," he said. Tyagi said the JD(U) national executive, at a meeting held here on July 8, had adopted a resolution opposing the Bill by describing it as a clear threat to indigenous languages and culture of Assam

About the BJP and AGP having divergent views on the Bill, Tyagi said, "Yes...but one has to understand that even while we (JD-U) agree with BJP on many issues, we disagree with them on many other matters. We have had independent relations with many parties such as the AGP

The AGP delegation was led by party president and Assam's Agriculture Minister Atul Bora and former CM Prafulla Kumar Mahanta, The team gave Nitish a memorandum which states, "We solicit your kind cooperation both inside and outside Parliament...so that the Bill cannot get through Parliament". The Assam ruling alliance comprises the BJP (with 61

The State Bank of India (SBI) has lowered the ATM cash withdrawal limit to Rs 20,000 a day, from Rs 40,000, According to a report, the lower limit will be effective from October 31, in view of spurt in fraudulent transactions at ATMs and to encourage digital and cashless transactions. A bank communiqué to offices told Economic times, "In view of the increase in the number of complaints received by banks around fraudulent transactions at ATMs and to encourage digital and cashless transactions, it has been decided to decrease the cash withdrawal limits of debit cards issued or being issued on 'Classic' and 'Maestro' platforms,".Skimmers, as reported in multiple cases in the past decade, steal the PIN for debit cards from unsuspecting customers using hidden cameras and electronic devices. The Classic cards constitute a sizeable chunk of SBI's card portfolio. The restriction on cash withdrawals comes weeks before the festival season.

Despite the government's digital push and rise in digital transactions, the demand for cash continues to be high and, according to some estimates, it is as high as pre-



demonetisation levels. Asked whether this could cause any inconvenience, SBI managing director PK Gupta said, "Our internal analysis shows most actual withdrawals are of smaller amounts. So, Rs 20,000 should be adequate for most customers. We are trying to see whether smaller withdrawals could minimize frauds." He said customers with a requirement for more can ask for card variants that offer

higher withdrawal limits. Such cards are issued to those keeping a higher minimum balance in their bank accounts. According to a person in the payments technology industry, debit card users are

most gullible when it comes to card frauds. "Information such as the PIN is not just stolen at ATMs," he said. "In fact, I would say (this

also happens at) point of sale terminals in merchant outlets and also by some people carrying mobile card swipe devices. Many debit cards still follow the magnetic stripe

technology and are comparatively more prone to frauds. Only for international debit cards is the transition to chip-based technology taking

place." Smaller cities are driving credit card growth of some of the

card growth of some of the large banks, with cardholders outside the top 10 cities accounting for 40-45% of spending. As per Banking Codes & Standards Board of India (BCSBI) guidelines, at least 30 days' notice has to be given to customers for any change in terms and conditions or charges. SBI has directed all its branches to display the message on notice boards.

Meanwhile, people's demand for cash continues to head northwards, despite the frequency of distinct frequency of digital transactions going up. A Reserve Bank of India (RBI) data in April 2018 revealed that people's demand for cash was 7 percent higher at Rs 18.25 trillion at the end of April compared to Rs 17 trillion at the beginning of November 2016
