Nageshwara Rao's family could have been involved in a financial transaction that appeared to be a case of money laundering, the 1986-batch IPS officer on Tuesday refuted the charges and said that the reports were "incorrect and untrue". In July this year, a Tamil language

portal, Savukku had accused M. Nageswara Rao's wife, Mannem Sandhya, of laundering money through a shell company in Kolkata in which she was an investor. It said that Sandhya allegedly loaned Rs 20 lakh from one Angela Mercantiles Private Limited to purchase a piece of land in Pedapalakaluru village, in Guntur District, Andhra Pradesh. However, it turned out that she had also invested around Rs 1.14 crore in the same company

Indonesia Military Chief "Strongly Believes" Crashed Lion Air Plane Found

The smashed fuselage of a crashed Indonesian jetliner may have been found, the country's military chief said Wednesday, two days after the deadly accident feared to have killed

189 people.
Using sonar technology, Hadi Tjahjanto said authorities were confident they had pinpointed the location of the Boeing 737-MAX

nocation of the Boeing 137-MAX plane that plunged into the sea on Monday.

"We strongly believe we've determined the coordinates of the JT 610 fuselage," he told reporters in lakarte.

"However, it has not yet been confirmed that it is part of the fuselage."

Authorities have been searching for the downed jet's location in water some 30-40 meters deep in the hopes of also finding flight data recorders expected to be crucial to the crash investigation.

The development comes as Boeing officials are to meet with Lion Air on Wednesday, after Indonesia ordered an inspection of the US plane maker's 737-MAX jets.
The Boeing-737 MAX 8, which

ago, crashed into the Java Sea off Indonesia's northern coast moments after it had asked to return to Jakarta on Monday.

Aviation experts say it is too early to determine what caused the accident.

But Lion's admission that the plane had an unspecified technical issue on a previous flight - as well as the plane's abrupt nose dive just 12 minutes after takeoff — have raised questions about whether the plane had any faults specific to the newly released model.

The accident has also resurrected concerns about Indonesia's patchy air safety record which led to a nowlifted ban on its planes entering US and European airspace.

When you have a new plane, you expect the thing to work exactly like it's supposed to in the written contract.. It's in everyone's interest for this thing to work," Stephen Wright, aviation expert at the University of Leeds, told AFP.

'Many questions'
Indonesia's transport minister ordered an inspection of all 737-MAX aircraft on Tuesday, while representatives from Boeing are due to meet with the budget carrier, said Lion spokesman Ramaditya Handoko

Lion Air Group Managing Director Daniel Putut said the airline had "many questions" for the Chicago-based company and they would discuss the delivery of remaining aircraft 737-MAX models, Indonesian news website tirto.id reported.

Lion Air, Indonesia's biggest budget airline which has been engaged in huge expansion, announced earlier this year it was buying 50 Boeing-737 MAX 10 jets for \$6.24 billion.

Boeing suspended release of the fuel-efficient 737 MAX just days before its first commercial delivery last year due to an issue with engines.

But the narrow-body jet was subsequently cleared for commercial delivery and has had thousands of orders from more than 100 customers worldwide.

Boeing said in a statement it was providing technical assistance at the request and under the direction of Indonesian authorities, but did not comment on the reported

The US National Transportation Safety Board (NTSB) will also help out into the investigation of the downed plane.

Search teams have taken up the grim task of separating human remains from plane debris and recovered personal effects, sending the body parts — including from an infant — to hospital for DNA testing.

Some 48 body bags filled with limbs and other remains have so far been recovered, authorities said Wednesday.

Dozens of divers were taking part

in the recovery effort along with helicopters and ships. Indonesia's search and rescue

agency has all but ruled out finding any survivors from the high-impact

The plane was en route to Pangkal Pinang city, a jumping off point for beach-and-sun seeking tourists on nearby Belitung island, when it dropped out of contact around 6:30 am (2330 GMT).

PM Modi to dedicate today to the nation world's tallest Statue of Unity on birth anniversary of Sardar Vallabhbhai Patel

Gujarat, Oct. 31

Prime Minister Narendra Modi will dedicate to the nation world's tallest statue, the Statue of Unity, at Kevadiya in Narmada district of Gujarat today. The 182-metre statue of the Iron Man of India, Sardar Vallabhbhai Patel is being unveiled

on his birth anniversary.

AIR correspondent reports that the dedication ceremony will have many attractions, including flypasts and playing of patriotic music by ceremonial bands of the Army,

rya Kiran of the Air Force will perform aerobatics in the sky over the statue while spreading the colours of the Indian flag in the sky. At the same time, a team of Jaguar fighter aircraft will also fly, and a team of MI-17 choppers will shower rose petals on the statue. Cultural programmes and folk dance performances by artists from Gujarat, Punjab, Assam and Mizoram have also been planned The statue has been built at a cost of about 2,400 crore rupees.

Approximately 70,000 tons of ent in addition to 18,500 tons of reinforcement steel and 6000 tons of structural steel has been

used to build the statue.

1700 metric tons of bronze has also been used. Mr Modi had laid the foundation stone of the project on 31st October 2013 when he was the Chief Minister of Gujarat. With the unveiling, the statue will become a representative and inspiration of Unity, Integrity and Peace across Near the statue, Mr Modi will also unveil the 'Wall of Unity' which has been created with the earth samples collected from various states across the country. As part of the effort to make the region around the statue a tourist spot, many projects like Valley of Flowers and Tent City have been developed.

The Prime Minister will also unveil a 'Light and Sound show' on Sardar Patel in the exhibition hall built at the pedestal of the Statue of Unity. The show will depict the Iron Man of India's fight against British rule.

SC asks Centre to submit details of pricing of 36 Rafale fighter jets

The Supreme Court on Wednesday asked the Centre for pricing details of the 36 Rafale fighter jets India is buying from France in a sealed cover within 10 days but agreed that "strategic and confidential" information need not be disclosed.

In its order, a three-judge bench headed by Chief Justice Ranjan Gogoi, gave some more leeway to government which has been arguing that pricing details are so sensitive that they have not even been shared with Parliament.

The Centre must bring details of the decision making process of the deal into the public domain, except those that are confidential and have strategic importance, the

court said.
The bench said the information must be shared by the government within 10 days and the petitioners could respond to it in the next seven days. It posted the matter for the next hearing on November

"If pricing is something exclusive and you are not sharing it with us, please file an affidavit and say so," the bench told Attorney General K K Venugopal in its oral observations. It was hearing four petitions, including one by advocate Prashant Bhushan and former ministers Arun Shourie and Yashwant Sinha who are seeking a court monitored CBI investigation in the procurement

of the fighter jets.
"That you will have to wait," the
CJI said, adding, "Let CBI put its
house in order first."

The attorney general had expressed reservations about

disclosing the details of pricing of the jets and said its cost was not even disclosed in Parliament.

He also said the documents placed by the Centre before the court are covered by the Official Secrets

The bench, also comprising Justices U U Lalit and K M Joseph said the "core of information" that can be brought in the public domain should be shared with the "petitioner and petitioners in person"

In its order, the bench observed that none of the petitioners have questioned the suitability of the Rafale jets, their equipment and their utility to the Indian Air Force. "What has been questioned is the bonafide of the decision making process and the price/cost at which the same is to be procured,'

the bench said.
The bench also noted that following its October 10 order the government has placed before it a note giving details of the steps taken in the decision making process leading to the process leading to the procurement of 36 Rafale fighter

At this stage, the bench said, the court did not want to record any finding or view on the documents placed before it. It also observed that information

regarding induction of the Indian offset partner be given to the court and the petitioners.

When a counsel appearing for AAP Rajya Sabha MP Sanjay Singh told the bench he has also filed a petition in this matter, the court asked, "What is his interest? We don't have to entertain so many petitions."

Shourie was present in the court during the hearing.

India signed an agreement with France for the purchase of 36 Rafale fighter aircraft in a fly-away condition as part of the upgrading process of the Indian Air Force equipment. The Rafale fighter is a vin-engine Medium Multi Role Combat Aircraft (MMRCA) manufactured by

aerospace company Dassault

Indian Air Force had advanced a proposal to buy 126 fighter aircraft in August 2007 and floated a tender. Following this, an invitation was sent to various aviation companies to participate in the bidding process.
