executive council It is write clear that vice -chancellor cannot appoint by his power "in anticipation" a pro -vc without holding the actual executive council meeting. We cannot declare in advance a candidate "elected "in anticipation before a proper

anticipation because a election. In short the wrong appointment of Prof. K.Yugindro Singh as pro-VC by the power of Prof. A.P.Pandey, is very clear. During this period prof. A.P.Pandey was on leave and he had not convened any executive council meeting for the purpose. Its handing over charge of VC to prof. K. Yugindro Singh is also wrong. The main objection of

Nagaland Cabinet approves scale of pay for ad hoc teachers; detained ANATG leaders released

After months of agitation, the State cabinet has reportedly approved the scale of pay for ad hoc teachers under the banner of All Nagaland Ad hoc Teachers' Group (ANATG) 2015 batch

Four ANATG leaders were detained for defying Kohima district administration order that barred their proposed meeting at Capital Convention.

Agitating ad hoc teachers under the banner of All Nagaland Ad hoc Teachers' Group (ANATG) 2015 batch clinched a major concession from the State cabinet when it approved their scale of pay. School education adviser KT

Sukhalu confirmed the approval on Wednesday.

The cabinet, however, refrained from taking any decision on their regularisation as it decided to wait till the court settled the matter

Meanwhile, four ANATG leaders were detained for defying Kohima district administrati order that barred their proposed meeting at Capital Convention here on Wednesday morning. They were released later in the evening after signing a letter of

undertaking. ANATG spokesperson Bendangtemsu Ozukum informed media persons after their release that they were about to go for agitation since their issue was not taken up at the September 28 cabinet meeting. However, upon learning about

the cabinet meeting scheduled during the day, they decided to give some time for the meeting, he added Stating that a general meeting

was scheduled at Capital Convention Centre, Ozukum added they were prevented to hold the meeting, after which they shifted the meeting venue to NSF Solidarity Park after

obtaining permission from NSF. He, however, alleged that security personnelcordoned the area and stopped them from entering the park. During that time, he said the police officers stopped them and insisted on accompanying them to North police station without

any explanation. To queries, he said the police officers insisted that all four of them sign a bond, in the form of an assurance that they would not agitate and maintain peace, which they refused to. Instead, he said they signed a letter of undertaking letter that they would "maintain peace" and would be "non-violent" without

compromising their sole demand on regularisation of their service. The ANATG spokesperson, however mentioned that they were not locked up and that nothing was forced upon them,

even as he expressed gratitude to Kohima Village Youth Organization (KVYO) leaders for reaching North police station within half an hour after they were detained and stayed with

them till their release On the outcome of cabinet meeting, Ozukum remarked that he learnt that the pay scale matter was tabled at the cabinet meeting. But unless they received the decision in black and white he said the ANATG leaders would not it consider as official as the "government has fooled us in many ways". As out of 1,166 ad hoc teachers, 90% were on fixed pay and 10% on pay scale, he said a decision would be taken after a general

body meeting. Meanwhile, police sources informed that the four ANATG leaders were apprehended as part of "preventive detention" as they were not permitted by the district administration to hold the meeting The sources said, as per the procedure in all police stations, whoever was detained had to sign a bond to maintain peace and not resort to violence, adding that the teachers were asked the same and so asked to sign and leave.

The police said the leaders. however refused to sign the bond and wrote an undertaking later in the evening in their own language. which was more or less the same bond issued by the police stations.

As the Rupee hit a new low As the Rupee nit a new low on Thursday, Congress president Rahul Gandhi said the news was 'not breaking, but broken'. The Rupee sank to a fresh low of 73.77 against the US Dollar, after falling 44 paise in early trade. The rise in global oil prices coupled with concerns over the current account deficit and capital outflows were behind the Rupee's decline.

The Rupee had closed at a record low of 73.34 on Wednesday, down 43 paise or 0.59%. The BSE Sensex, meanwhile, plunged over 500 points, or 1.39%, to 35,447,69 in early trade Thursday. The broader Nifty fell over 160 points, or 1.53%, to 10,693,65. Gandhi's tweet came a day after he questioned the government on its silence in the matter. SC allows ArcelorMittal, NuMetal to bid for Essar Steel

The Supreme Court Thursday granted one more opportunity to mining major ArcelorMittal and Russia's VTB Capital-backed NuMetal to bid for Essar Steel if they clear their Non-Performing Asset (NPA) dues in two weeks

A bench comprising Justices R F Nariman and Indu Malhotra held that both the firms were ineligible under amended Insolvency and Bankruptcy Code to bid for the firm but granted them a fresh opportunity after taking note of the plea of Committee of Creditors that it does not want liquidation of Essar Steel

The apex court exercised its extraordinary power under Article 142 of the Constitution in allowing ArcelorMittal and NuMetal to make fresh bid for Essar Steel. The top court asked the Committee of Creditors to take a decision within eight weeks on rival bids of NuMetal and ArcelorMittal for Essar Steel. It also said that time lost in

National Company Law Tribunal (NCLT), National Company Law Appellate Tribunal (NCLAT) and apex court in dealing with cases under insolvency code shall be excluded from mandatory 270 days resolution period. The top court held that if nothing materialises within eight weeks then Essar Steel shall go into liquidation
