# DUSU President from ABVPAnkiv Baisoya's degree "fake", says TN University letter

Troubles piled up for Delhi University Students' Union President Ankiv Baisoya on Thursday, October 4, when a letter issued by the Thiruvalluvar University Registrar surfaced stating that the education certificates provided by Baisoya from that iniversity were "fake" and that he was not enrolled in the university.

In a letter on October 3 to the Principal Secretary, Department of Higher Education, Tamil Nadu government, Registrar V Peruvalluthi stated: "I hereby submit that Mr Ankiv Baisoya has not enrolled either in our university or in any of our constituent of affiliated colleges and is not our student at all

Taking cognisance of the news reports published regarding Baisoya's alleged fake degree, it further read: "The certificate he has produced is fake and not from our university. The

Controller of Examination has issued a letter stating that the certificate is not genuine after official verification of records of the Controller of Examination office.'

Baisoya has been in the dock over allegations of securing admission in Delhi University on the basis of a fake degree from the Thiruvalluvar University in Vellore, Tamil Nadu. He is currently a student of Department of Buddhist Studies at Delhi University and is the centre of an inquiry by that department.

If found guilty, he may face cancellation of his admission from the university and also the forfeiture of post of president of the university students' union to which he was elected last month.

The controversy surrounding Baisoya's certificates erupted last month when the NSUI circulated a letter issued by the Controller of Examination of the Thiruvalluvar University dismissing Baisoya's graduation mark-sheet bearing that university's stamp and logo as "fake"

#### UPSC to allow candidates to withdraw from exams and Indian Police Service

Claiming that only half of the over 10 lakh aspirants who apply for civil services exam actually write the test, the UPSC on Monday said it has decided to allow the candidates to withdraw from the examination, according to an official statement.

The arrangement will be implemented beginning with Engineering Servic Examination, 2019, it said. Services Addressing an event Monday, Union Public Service Commission chairman Arvind Saxena said the UPSC's experience with the civil services examination is that roughly 50 per cent of the 10 lakh plus candidates who fill in the application forms for the preliminary exams actually write the papers, the statement said.

services The civil examination is conducted annually by the UPSC in three stages - preliminary, main and interview — to officers for select officers for Indian Administrative Service (IAS), Indian Indian Foreign Service (IFS)

(IPS) among others 'The Commission has to book venues, print papers, hire invigilators and ship the documents for all the 10 lakh applicants - which turns out to be a 50 per cent waste of

A start is being made with the Engineering Services Examination, 2019 and more examinations will be brought under this arrangement, the statement issued by Personnel Ministry said. With a view to reduce the stress for the candidates the UPSC has brought an increasing number of exam related interactions and transactions online. In this regard, Saxena said the UPSC is also moving ahead with shifting from a 'pen and paper' mode of examination to a computer-based mode.

"Apart from making the examination process more candidate-friendly, the new systems also serves to cut down the time cycle for each examination," he said.

Bearing in mind the aspirations of the youth for better job opportunities, the chairman said that the Commission is now disclosing the scores and ranking of the the scores and ranking of the  $n \circ n - r \in c \circ m m \in n d \in d$  candidates in some examinations on its website and further linking it with the "National Career Services" portal of the Ministry of Labour and Employment. He said, central ministries and organisations can

conceivably take advantage of this arrangement wherei candidates who have cleared a rigorous screening process in the civil services, engineering services or combined medical services examinations, but could not find a place in the merit list due to constraints of vacancies, can now look forward to being picked up for other government, public sector or private sector jobs, from the same data base

The measure should obviate the need for conducting of multiple and separate examinations by different organisations for posts with similar entry level qualifications, he added. "This will reduce the stress on young job aspirants and also the time taken for recruitment by various bodies," Saxena said

The reply filed on behalf of SP, Shivpuri, said further instructions had been sought, but no instruction had been received from the government Relying on an order passed on September 10 by another bench of the court, the reply said "the arrest of an accused is not mandatory when the offence has been registered for different offences under SC/ST Act and if the Investigating Officer (IO) feels necessary, then he can arrest an accused without any permission from the senior officer." Observing that the reply was

vague, Justice G S Ahluwalia said, "The question was whether any inquiry will be conducted before effecting arrest of an accused under the Act in the state or not? If the

authorities are of the view that the IO 'if feels necessary' may arrest an accused without any permission from the senior officer, then it may give an uncontrolled and unchallenged discretionary power to the IO At this stage, the government counsel prayed for a short adjournment for filing a detailed reply with regard to whether any public statement was made by the Chief Minister or not, and if it was, then in compliance of such public declaration, the police authorities would conduct an enquiry prior to effecting arrest of an accused or not. Posting the matter for further

hearing on October 11, Justice Ahluwalia asked the state to clarify the nature of the inquiry which will be proposed by the state before effecting arrest of an accused.
