People excluded from final list of NRC will be disenfranchised and deported, says Ram Madhav

BJP General Secretary Ram Madhav IANS Madhav IANS Bharatiya Janata Party's General Secretary Ram Madhav on Monday said people excluded from the final list of the National Register of Citizens in Assam will be disenfranchised and deported to their country, PTI reported. "3 [Three] steps will be taken after NRC," Madhav said at a seminar on 'NRC: Defending the Borders, Securing the Culture' in Delhi. "Detect, delete [and] deport. NRC will ensure detection of illegal immigrants. Next step will be disenfranchise – deletion of names of illegal immigrants from voters list [and] deprive them from govt [government] benefits. 3rd [Third] stage will be deportation."

Madhav said no other country tolerates undocumented migrants, but India has become a "dharamshala for illegal immigrants due to

political considerations". Madhav said the country's first Prime Minister Jawaharlal Nehru realised the enormity of the problem of undocumented migrants in Assam and enacted a state-specific law in the 1950s to expel foreigners. "Nehru's great-grandson should read the history and extend support to detect and deport illegal immigrants from Assam," he said referring to Rahul Gandhi

Assam Chief Minister and BJP



leader Sarbananda Sonowal said genuine Indian citizens will get adequate opportunities to prove their citizenship and include their names in the final list of the NRC. He, however, suggested that the NRC be implemented in all states

"This is a document which can protect all Indians," PTI quoted Sonowal as saying. "Those who will be excluded from the NRC in Assam can go to other states. So we will have to take a strong step." The final draft of the National Register of Citizens was published on July 30 leaving out nearly 40 lakh people, including some MLAs and a former chief minister.

The stated aim of the counting exercise is to separate genuine Indian citizens from so-called illegal migrants who might be living in the state. According to the terms of the exercise, anyone who could not prove that they or their ancestors had entered the state before midnight on March 24, 1971, would be declared a foreigner. Launched in 2015, it involved processing the applications of 3.29 crore people who hoped to be included in the register. Over the course of three years, the mammoth exercise has been through several controversies, including allegations of bias against certain communities.

National Herald case: Setback for Sonia and Rahul, HC dismisses their tax pleas

THE DELHI High Court Monday dismissed pleas by Congress leaders Sonia Gandhi and Rahul Gandhi against the Income Tax department's decision to reopen their tax assessments for the financial year 2011-2012 in connection with the National Herald newspaper case.

The "writ petitions have to fail," a bench of Justices S Ravindra Bhat and A K Chawla said while clarifying that the observations in the order with regard to the contentions of the Congress leaders is not conclusive and have been noted only for the purpose of disposing of their pleas. The bench also dismissed a similar plea by Congress leader Oscar Fernandes.

Reacting to the ruling, BJP spokesperson Sambit Patra described it as a "victory of the common man". He alleged that 'Bharat Bandh' call given by the Congress was to divert the people's attention from the hearing involving its "corrupt" leaders

The Congress hit back and dared Prime Minister Narendra Modi to fight a "political battle" with Rahul Gandhi instead of seeking "petty revenge".

The income tax probe against the Congress leaders stems from an investigation into a complaint filed by BJP leader

The complaint accused Sonia Rahul and others of conspiring to cheat and misappropriate funds. It alleged that Young Indian (YI), which was incorporated as organisation in November 2010 with a capital of Rs 50 lakh, had acquired almost all shareholdings of Associate Journals Lts (AJL), which ran the National Herald newspaper. In this process, it was alleged, YI also acquired AJL's debt of Rs 90 crore. YI is a not-for-profit organisation. The tax department had said that the shares Rahul has in YI would lead him to have an income of Rs 154 crore and not about Rs 68 lakh, as was

assessed earlier. It has already issued a demand notice for Rs 249.15 crore to YI for the assessment year 2011-12. The bench, in its Monday order, noted that the premise of the reassessment notices was that the non-disclosure of the taxing event — allotment of shares of YI — deprived the assessing officer of the opportunity to look into the

records. It said in Rabul's case, the nondisclosure of share acquisition constituted tangible material justifying reassessment. In case of Sonia and Fernandes, the bench said returns filed were processed under Section 143(1) of the Income Tax Act, which pertains to 'notice or intimation', and are not treated as "assessments"

16 reserved its order on the pleas of the three leaders after the Income Tax Department had contended that Rahul Gandhi's tax assessment for 2011-12 was reopened as material facts were concealed. The bench had orally asked the tax department not to take any coercive step against Sonia, Rahul and Fernandes till pronouncement of its verdict. Senior advocate P Chidambaram, appearing for Sonia Gandhi, had said he had faith in the oral statement made by the Additional Solicitor General Tushar Mehta, Mehta had argued that the Congress leaders had alleged mala fide on the part of the tax department but had not made any averments in this regard.

2014, excise duty on petrol per litre was Rs 9.20. The first ever mid-air refuelling of the indigenously developed light combat aircraft Tejas was successfully carried out Monday, placing India in an elite group of countries having air-to-air refuelling system for military planes, Hindustan Aeronautics Ltd (HAL) said. The milestone was achieved at 9.30 am when 1,900 kg of fuel was transferred from the mid-air refuelling tanker of IAF's IL78 to the Tejas LSP8 at an altitude of 20,000 feet, said a release from HAL, which has developed the light combat aircraft (LCA).
