

Telangana: CM ordered police to intimidate our leaders ahead of polls, says Congress

Telangana Congress leaders on Wednesday alleged that caretaker Chief Minister K Chandrashekar Rao had ordered police to arrest Congress leaders by reopening old cases to subdue them ahead of elections. Telangana Pradesh Congress Committee (TPCC) president N Uttam Kumar Reddy said that the arrest of former Congress legislator and leader from Sangareddy T Jayaprakash Reddy alias Jagga Reddy in a 14-year-old human trafficking case was illegal and aimed at terrorising opposition parties just before Assembly elections. He also condemned the arrest of other Congress leaders, including former deputy CM Damodar Rajanarasimha and Youth Congress leader Bala Kumar, on "frivolous charges". Jayaprakash Reddy was arrested Monday on charges of human trafficking after officials from Market police station found that he obtained passports for himself and three others using fake



documents and used these passports to take three persons from Gujarat to the US for monetary gain. Hyderabad Police North Zone's Deputy Commissioner of Police B Sumathi said that in September 2004, when Reddy was MLA, he applied for passports for himself, his wife, daughter and son. However, instead of photographs of his family members, Reddy allegedly affixed photographs of three unknown persons and secured the passports by submitting fabricated documents. "He was paid Rs 15 lakh for obtaining those

passports and visas by an agent," Sumathi said. After Jayaprakash Reddy's arrest, former deputy CM Rajanarasimha rushed to Sangareddy to protest against the police action. He, too, was arrested. Meanwhile, in Sircilla, which is TRS minister K T Rama Rao's constituency, Bala Kumar was arrested for allegedly harassing girls of ST Hostel in an inebriated condition. And Congress leader from Warangal Gandra Venkata Ramana Reddy was booked for allegedly threatening a businessman with a firearm. Congress leaders alleged the

police were directed by the CM to book A Revanth Reddy, a TDP MLA who recently joined the Congress and will contest from Kodangal constituency. As TDP MLA, Revanth Reddy was caught by the Telangana ACB while allegedly trying to bribe a nominated MLA to vote in favour of a TDP candidate in the Legislative Council election. On Wednesday, officials of Jubilee Hills police station issued a notice to Revanth Reddy to appear before them for questioning. He was also booked for allegedly purchasing a plot by submitting forged documents. Condemning the arrest of Jayaprakash Reddy, the TPCC chief said the main accused in the case, Mohammed Rasheed Ali, in his confessional statement named KCR, minister T Harish Rao and other TRS leaders. "KCR, T Harish Rao, Kasipeta Lingaiah, Bodhan ex-MLA Shakeel Ahmed, ex-MP Madhusudan Reddy were allegedly involved in the trafficking racket. However, only Jagga Reddy was targeted and arrested. This was done to intimidate Congress leaders," he said.

Advani renominated as chairman of Lok Sabha ethics panel

Senior BJP leader L.K. Advani has been renominated as the chairman of the Ethics Committee of the Lok Sabha by Speaker Sumitra Mahajan. The Committee examines complaints related to any unethical conduct by members of the Lower House. The committee can also

initiate suo motu investigation into matters related to unethical conduct of a member and make recommendations. Former Uttarakhand CM Ramesh Pokhriyal "Nishank" of the BJP was renamed the chairman of the Lok Sabha Committee on Government Assurances. Chandrakant Khaire of the Shiv Sena was reappointed as the chairman

of the Committee on Papers Laid on the Table. BJP's Dilipkumar Mansukhlal Gandhi has been given another term as the chairman of the Committee on Subordinate Legislation. P Karunakaran of the CPI(M) will continue serving as the chairman of the Committee on Absence of Members from theittings of the House.

Three held, several injured as students damage property, pelt stones

Students of two Banaras Hindu University (BHU) hostels clashed over mess food Wednesday. They vandalised over a dozen motorcycles, damaged mess property and pelted stones at each other and policemen, leaving several injured. Twenty students were booked later in the day, of which three were arrested. "The clash took place between students of Aiyar and Birla hostels at around 8.30 am. Some students from these hostels went to have breakfast in each other's mess. Following an argument, some students of Aiyar hostel reportedly slapped one Neeraj Kumar from Birla hostel. When hostellers from Birla came to know about this, they went to

the Aiyar hostel and both groups got into an argument," said Station House Officer (SHO) at Lanka police station, Bharat Bhushan Tiwari. "A verbal spat soon turned into a violent one. Stones were pelted. More than a dozen motorcycles parked near the hostels were vandalised and some of the mess property was destroyed. A police team reached and managed to pacify the groups by around 9.15 am. However, in the afternoon, after some of them were arrested, the students were agitated again and attacked police vehicles. Heavy police force has been deployed on the university campus," Tiwari added. An FIR was registered against 20 students on the basis of a complaint filed by Chief Proctor Raina Singh under IPC sections 147 (rioting), 323



(voluntarily causing hurt) and 427 (mischief causing damage to the amount of fifty rupees). The three students who were arrested were identified as Saurabh Kumar, Ankur and Vibhesh Kumar. Police are examining CCTV footage to

identify and arrest other students involved. Both hostels have been sealed for now and police teams are keeping vigil. The incident took place at a time when Chief Minister Yogi Adityanath is in the district.

Naveen Patnaik expels Damodar Rout from BJD, he fires back

BJD leader and Paradeep MLA Damodar Rout was on Wednesday suspended from the party after orders from Chief Minister Naveen Patnaik, as per a press release. On Tuesday, hundreds of BJD workers from Jagatsinghpur district met Patnaik at his residence and handed him written complaints against Rout's anti-party activities. The CM, who is presently in Delhi for a road show promoting the Make in Odisha conclave scheduled for November, had said he will consider the complaints. Reacting to the reports on his expulsion, Rout said, "BJD has no constitution. I have not received any letter informing me of the expulsion or reasons behind it". "Who will expel me? Is Naveen Patnaik in Biju Janata Dal anymore? Who is left from the original Biju Janata Dal or has been a follower of Biju Patnaik?" he fired at the CM. "Now BJD is filled with people

on whom CBI's sword hangs", Rout said. Earlier on Wednesday, Rout told the press that the "CM is a good man", which other party leaders say was in fear of suspension. In BJD's 18 year rule, Rout, who has handled important portfolios such as agriculture, health and cooperation, also warned that he will now be more candid about the BJD's wrongdoings over the years. Rout's expulsion came a day after he alleged that "the BJD was being run by one bureaucrat and three MLAs". He referred to the CM's private secretary IAS V Karthikeyan Pandian and MLAs Debashish Samantray of Cuttack, Arun Sahoo of Nayagarh and Pranab Prakash Das of Jajpur. Rout, who targeted the state government for overseeing a scam worth Rs 800 crores in farm loans disbursed by the cooperation department, also alleged that Odisha was being run by a satellite-centre of Tamil Nadu, which was seen as a shot at Pandian.

IRT Rescues 41 Child labourers in Dimapur

An Immediate Response Team (IRT) under Dimapur District Task Force (DDTF) on child labour under the chairmanship of Dimapur deputy commissioner (DC) Sushil Kumar Patel rescued 41 child labourers from garages, workshops, hotels and shops from various locations in Dimapur on Wednesday. In a press release, Childline 1098 Dimapur nodal coordinator Neiketulie Namda said the children aged between 10 and 14 years were rescued from Duncan, Notun Basti, Churches Colony, Khermahal, Golaghat Road and Eros Lane areas.

The rescued children were produced before child welfare committee (CWC) along with their parents and guardians. The employers were summoned before the CWC and penalties were imposed on them as per provisions of the relevant Acts and they were made to sign bonds declaring that they would not employ any child below 14 years in future. The employers were also sensitised on the Juvenile Justice (Care & Protection of Children) Act, Child and Adolescent Labour and Prohibition Act and Right to Education Act. The DDTF chairman apprised the children about the evils of child labour and the

importance of education and encouraged them to pursue education. Meanwhile, DC Dimapur announced that more such rescue operations would be carried out at regular intervals in different locations. He warned that any person found employing children below 14 years of age would be dealt with strictly as per the law. The IRT consisted of Dimapur SDO civil N Zubenthung Ngullie, district child protection officer Pikato Tuucu, assistant commissioner of police Tiamenla, Childline 1098 nodal director Subonbenba Longkumer, labour inspector Yoise Sangtam and Childline Dimapur.

Srinagar businessman gets bail in Kashmir terror funding case

The Delhi High Court Thursday granted bail to Srinagar businessman Zahoor Ahmad Shah Watali, who was arrested in connection with the NIA's probe into an alleged terror funding case. A bench of Justice S Muralidhar and Justice Vinod Goel granted Watali bail and asked him to furnish a personal bail bond of Rs two lakh, with two sureties of a similar amount. Watali had challenged the trial court's June 8 order rejecting his bail plea. Watali, arrested on August 17 last year, was chargesheeted by the NIA on January 18 along with Pakistan-based terrorist leaders Hafiz Saeed, Syed Salahuddin, seven Kashmiri separatist leaders and others for allegedly trying to create unrest in the

Kashmir Valley. They were chargesheeted under stringent anti-terror laws for allegedly hatching a conspiracy with Saeed and Salahuddin to wage a war against India to secede Kashmir. The separatists, who were arrested on July 24, 2017, are Aftab Hilali Shah alias Shahid-ul-Islam, Ayaz Akbar Khandey, Farooq Ahmad Dar alias Bitta Karate, Nayeem Khan, Altaf Ahmad Shah, Raja Mehrajuddin Kalwal and Bashir Ahmad Bhat alias Peer Saifullah. Altaf Ahmad Shah is the son-in-law of hardline Hurriyat leader Syed Ali Shah Geelani, who advocates Jammu and Kashmir's merger with Pakistan. Islam is an aide of moderate Hurriyat leader Mirwais Umar Farooq, and Khandey is the spokesperson for the Geelani-led Hurriyat.
