## After AP Pandey's suspension, M. Shyamkesho appears as another trouble maker in resolving the crisis at MU

IT News Imphal, Sept. 19,

The suspension order of Manipur Üniversity VC Prof. AP Pandey by an order of the MHRD on the approval of the president of India in the capacity of Visitor of Manipur University leaving no option for him to occupy his position using all means has not ended the tendency to deteriorate the normal functioning of the Manipur University, as another associate of AP Pandey, who still claimed as in charge VC had issued an order late yesterday evening stating that pro VC Prof. Yugindro Singh, who was appointed by the VC AP Pandey shall performed the duties of Vice Chancellor.

The legitimacy to the appointment of Pro Vice Chancellor is still in questioned as VC AP Pandey had been given leave from

University soon after he announced his joining the office on September 1. However, source said that the complicacy can only be sorted out after the court directives as a case regarding the force type leave and the MoA signed between the MHRD, Govt. Manipur and Manipur University community has been challenged by Pandey. The hearing which was supposed to be held yesterday has been differed after a similar SLP has been filed by the Prof. AP Pandey at Supreme Court.

However, as per the MoA signed on August 16 and after the MHRD gave approval of every content in the every content in the agreement, The two member independent enquiry Committee has been conducting the enquiry in full

swing.

to the Secretary MHRD urging for clarification to the legitimacy of the order by Prof. Shyamkesho at the capacity of the in charge Registrar , when prof. Dlendro has already been acting as the in-charge registrar and is presently serving as nodal officer of the

enquiry committee. Source close to Imphal Times said that, VC in Charge Prof. Vishwanath in the letter to the secretary MHRD stated that Shaymkesho had applied for casual leaved since he took charge as VC in Charge when the University re-opened on

August 23.
To coup up with pending works of the University Prof. Sh. Dorendrojit Singh has been given in-charge Registrar

for a period of 30 days. The letter also stated that Prof. AP Pandey's leave was extended from Septemebr 9 untill the completion of the enquiry with the approval of the Chancellor of the Manipur

University. Activities of AP Pandey during his leave period by issuing orders of many kinds has created confused to the University community and the MHRD had already acknowledge the act of Pandey as a deteriorating factors in the activities of the Manipur university.

The source further added that prof. W. Vishwanath Singh, in his letter to the Secretary soght clarification regarding the his position as well as that of Prof. Dorendrajit's position . he also sought clarification from the HRD to the status of the so called transit office opened by Prof. AP Pandey at Sanjenthong.

# UNHRC urged to intervene for bringing lasting solution to Naga issue

Agency Imphal, Sept 19,

The Liberation, an NGO, through a written statement made number recommendations to the Human Rights Council of the United Nations (UNHRC) in order to bring an honourable lasting political solution to the protracted Naga political

issue.
The NGO stated that they are deeply concerned about the growing opposition and continuing protests against the Indo-Naga peace process between the Government of India (GOI) and National Socialist Council of Nagaland- Isaac Muivah (NSCN-IM), by the

(NSCN-IM), by the neighbouring States. The neighbouring States, it stated, threaten to derail the peace process and result in continued violations of the rights of indigenous Naga

people.
"With the signing of the historic Indo-Naga ceasefire between GOI and NSCN-IM in 1997, Nagas hope for peace was founded. The Nagas appreciate the GOI for

recognising the unique history of the Nagas and it is our hope that the political solution will be based on historical facts and legitimacy," it stated. However, since the signing of the most recent Indo-Naga

Framework Agreement 2015

the governments of neighbouring Indian States as well as some sections of the civil society organisations, particularly in the State of Manipur, are spreading wrongly alleging that this agreement "compromises territorial integrity of the state", it stated.

'This propaganda is being deliberately carried out to sabotage the Naga peace process and continues till this day with increased hostile protests that threaten to negatively impact social harmony," the NGO stated. In such a situation, the NGO requested the President and Members of the Human Rights Council of the UN to urge the Government of India to welcome third neutral parties, including UN bodies, to aid in expediting the Indo-Naga peace process.

NGO has recommended that the Indian Government and the negotiating parties be urged to respect democratic processes and the rights of indigenous people with particular reference to article of the United Nations Declaration on the Rights of Indigenous.

It also recommended that a team of experts be sent to assess the developments surrounding the Indo-Naga peace negotiations and advise the GOI in devising mechanisms around the obstructive forces against the Indo-Naga peace process for ensuring early settlement of the issues involved. Besides, the UNHRC was also

requested to send human rights delegation, including the SR on the rights of indigenous people to assess the human rights situation in Northeast India to ascertain facts on the ground and to encourage and/or initiate dialogue among the communities in the region based on universally based on universally accepted standards and
