

MU Community resolves to stop cooperating with the 2 member enquiry committee

After the 2 members enquiry committee constituted by the MHRD to look into the crisis at Manipur University fails to take any action to the breaking of the sealed rooms at the Administrative block by alleged Pro VC Yugindro and also noticing the silence of the committee to the arrest of Nodal Officer of the enquiry Prof. Dorendrajit (i/s) Registrar, the University Community today resolved to stop extending cooperation to the ongoing enquiry. The resolution was adopted in an emergency meeting of the Joint Action Committee of the MU Community held today morning with Prof. I Tomba Singh on the chair. The meeting of the MU Community also demanded to reconstitute

the enquiry committee under the Commission of Enquiry Act 1952.

The meeting deliberated extensively on the Character, meaning and implication of the Rape of Institutional character of Manipur University since the Midnight of September 20, 2018 and still being continued. The members of the MU community have lost confidence to either the state government or also the central government as the sequence of event taking place over the issue showed signed of insincerity.

"Neither the Government of India nor the Government of Manipur has been sincere in the dealing of Manipur University Community as they are in a covert support of Prof. AP Pandey", the MU Community said. The community now felt

frustrated to have faith on the verbal assurance given through VC in Charge Prof. Vishwanath regarding the disagreement to the MHRD Order issued after the signing of the Memorandum of Agreement with the MHRD representative, Manipur Government and the MU Community. The interference of the MHRD to the internal arrangement of Manipur University when it comes to protecting Prof. AP Pandey and the recognition of a Pro VC appointed by prof. AP Pandey when he was on leave by skipping the clauses of the Manipur University Act has been seriously viewed by the members of the Manipur University Community. The Manipur University also hinted partiality attitude of the Prof. Choudhury who is also the Jury No. 2 of the enquiry

committee.

"Prof. Choudhury, keeps on referring to the telephonic instructions and suggestions he receives from the MHRD and prof. Shyamkesho Singh urged the Committee to complete the enquiry in a hasty way while appearing to the committee yesterday". The MU community said and added that the Committee remain silence when AP Pandey showed disrespect to the enquiry committee. "As the Transparency, Fairness, Impartiality and Commitment to truth and the capability of the Committee to be Independent have been compromised, the University Community would immediately withdraw their acceptance of the Committee and stop cooperating with it forthwith", the meeting of the MU community resolved.

Issues can be resolved through dialogue: CM

Chief Minister N. Biren Singh said that any discontents and issue can be resolved through dialogue. He called out to the stakeholders and student organisations to come forward for dialogue to find amicable solution to the MU row. This was stated by him at the inauguration of Main Building Complex of Pandit Deen Dayal Upadhyay Institute of Agricultural Sciences, Utluo Bishnupur district today. Speaking as Chief Guest of the function, Chief Minister said that bandhs and general strikes severely affect the lives of the common people of the State. He mentioned that such situation also portrays Manipur in bad light to the outside world. He reiterated that we need to stop supporting bandh culture being called out for some vested interest in the State. He stated that now, it's time to analyse and digest the negative impacts of bandhs

and general strikes to the State and people. He said that we should conduct a mass campaign against the misuse of students in bandhs, general strikes and other issues.

Mentioning that the people have experienced the good governance in the State, he stated that the government is for the people of the State. The government has been able to improve the police-public relationship in the State, he added. He appealed the people to extend their co-operation and help in bringing positive change in the State. The present government has brought visible changes in the State, he added. According to the NABARD, in the last 18 months, there is economic boom in the State with a steep increase from 10 percent to 200 percent in economic activities in the State. Chief Minister reiterated that with the introduction of 'Go to Village' (GTV) mission, various government services are being made available at the people's doorsteps.

Such initiative has brought positive changes in the governance of the State, he added. Out of 2660 census villages, around of 1600 villages have been covered in the GTV camps. Force breaking of the sealed room showed their attempt to temper the documents, the faculty member added.

Bomb found near the office of Indo-Myanmar Labour Union at Moreh

Today at around 5:00 am morning a combined team of security force recovered a Bomb (Romote Control and Mobile)-RDX found near the Office of Indo-Myanmar Labour Union (under Bharatiya Majdoor Sangh). The bomb was first noticed by a team of 11 Assam Rifle who were patrolling the area at around 4:00 am near the office

of Indo-Myanmar Labour Union which is about 150 metre far from Indo-Myanmar Border. Metal detectors and trained dog confirmed the bomb.

Moreh Police, Commando rushed at the spot and cordon the area.

Superintendent of Tenguonpal District Police Dr. S. Ibomcha, Additional Superintendent of Police K. Robinsun, Deputy Superintendent of Police (Ops)

Thomas Thokchom and Officer Incharge of Moreh Police Letkhohao Vaiphei and Officer Incharge of Moreh Commando Mr. Saktishen made a strict vigil at the area. Bomb Disposal team of Manipur Police Department and three Army diffused the bomb at around 12:37pm near Houlemphei Village. The Bomb was a combined of Remote Control and Mobile RDX, it weight about 3.5kg, police source said.
