SC Allows Live Streaming of Court Proceedings

The Supreme Court signaled the dawn of a new era on Wednesday, September 26, by opening the doors for live streaming of court proceedings. The apex court observed that it will bring transparency and serve public interest. A bench of Chief Justice

Dipak Misra and Justices A M Khanwilkar and D Y Chandrachud had reserved its verdict on 24 August saying it wanted to implement the concept of open court" to decongest the courtrooms.

Attorney General K K Venugopal, appearing for the Centre, had said that live streaming could be introduced as a pilot project in the Chief Justice of India's court on matters of constitutional importance and had submitted suggestions on the guidelines for live streaming

of court proceedings.
"We don't perceive any
difficulty in live streaming.
Let us first start with it and
see how it goes. We are just on a pilot project. We are not ruling out anything and will improve with time. We cannot have everything together, the bench had observed.

Assam NRC Process to file NRC claims & objection begins amid anxiety & chaos

As the National Register of Citizens (NRC) process of filing claims and objections begins on Tuesday, one Azida Begum was in for a shock. The 44-year-old, whose name was missing from the draft NRC published on July 30, had gone to the Nagrik Seva Kendra (NSK) in Azara, a neighbourhood on Guwahati's outskirts, to file her claim for inclusion in the list.

"They have told me to either wait for a month or get more documents," said Begum, one of less than 50 people who visited the Azara NSK, according to officials."This is my father's legacy document. His name is there in the 1970 voters' list," she said pulling out a sheaf of papers from a plastic carry bag. Instead of submitting the legacy document of Abdul Hamid, her father, she had attached the document of Mohabbat Ali, her father-in-law, leading to a family tree mismatch and her exclusion from the NRC draft.

But the official at the NSK told Begum the 1970 voters' list with her father's name in it could not be accepted as a valid document at this point as per a Supreme Court

order, leaving her worned.

Recently, the SC had said only 10 of the 15 documents that were initially accepted as proof of citizenship could be submitted afresh with the claims form. A decision on the remaining five-an extract of the 1951 NRC voters' list and ration cards until March 24, 1971, refugee and migration certificates – will be taken on October 23 amid demands that they

Aadhaar verdict:

Congress to move SC for upholding passage of Aadhaar Act as money bill

The Congress has decided to challenge the Supreme Court verdict to uphold the passage of the Aadhaar Act, 2016, as a money bill in Lok Sabha. The Aadhaar Bill was passed during the Budget session in March 2016, overruling amendments moved in the Rajya Sabha.

The top court, while delivering its verdict on Wednesday, had upheld the constitutional validity of the Centre's flagship Aadhaar scheme by 4:1, saying it serves a larger public interest and empowers the marginalised sections. While addressing the media

in the national capital, senior Congress leader Kapil Sibal said, "The passage of the law violates both the fundamental right to privacy and is a gross abuse of the Money Bill route."

Nagaland CAG report finds anomalies in state PHE Department

The Nagaland Department of Public Health Engineering (PHE) has failed to abide by certain prescribed safety requirements for safe drinking water with regard to the National Rural Drinking Water Programme (NRDWP).

was stated in the report of the Comptroller and Auditor General (CAG) for the year ending March 31, 2017.

Among the several irregularities detected in the implementation of the programme, the CAG found that state and district level laboratories did not carry out water quality tests as mandated.

The CAG ascertained that the laboratories had "significantly failed" in carrying out the prescribed number of bacteriological and chemical contamination tests in the three districts to ensure the supply of safe drinking water to the populace in their districts. NRDWP guidelines require

that all drinking water sources should be tested at least twice a year (pre and post monsoon) bacteriological contamination and once a year for chemical contamination.
